

1 **AN ACT INCREASING THE BED CAPACITY OF THE ADELA SERRA TY**
2 **MEMORIAL MEDICAL CENTER IN TANDAG CITY, PROVINCE OF SURIGAO DEL**
3 **SUR, FROM TWO HUNDRED (200) TO ONE THOUSAND (1,000) BEDS,**
4 **UPGRADING ITS SERVICES AND FACILITIES, AUTHORIZING THE INCREASE OF**
5 **ITS MEDICAL PERSONNEL AND APPROPRIATING FUNDS THEREFOR**

7 *Be it enacted by the Senate and the House of Representatives of the Philippines in*
8 *Congress assembled:*

10 **SECTION 1.** The authorized bed capacity of the Adela Serra Ty Memorial
11 Medical Center (ASTMMC) in Tandag City, Province of Surigao del Sur is hereby
12 upgraded from two hundred (200) to one thousand (1,000) beds.
13

14 **SEC. 2.** The existing service facilities and other services of the ASTMMC are
15 hereby upgraded to conform with the bed capacity increase as provided for in Section 1
16 hereof.

18 **SEC. 3.** The existing medical personnel of the ASTMMC shall also be
19 correspondingly increased. The Department of Health, in coordination with the
20 Department of Budget and Management and the Civil Service Commission shall
21 determine the additional plantilla positions to be created and filled up upon prior
22 consultation with and recommendation by the ASTMMC.

24 **SEC. 4.** The increase in bed capacity of the ASTMMC from two hundred (200)
25 to one thousand (1,000) beds shall be implemented for a period of not more than five
26 (5) years from the approval of this Act.

SEC. 5. The Secretary of Health shall immediately include in the Department's program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.

SEC. 6. All laws, decrees, orders, issuance, rules and regulations or parts thereof inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

SEC. 7. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
