Mr. Speaker:

The Committee on Health and the Committee on Appropriations to which was referred House Bill No. 639 introduced by Rep. Renato J. Unico, Jr., entitled:

AN ACT PROVIDING FOR THE ESTABLISHMENT OF A DISTRICT HOSPITAL IN THE MUNICIPALITY OF SANTA ELENA, PROVINCE OF CAMARINES NORTE, TO BE KNOWN AS THE SANTA ELENA DISTRICT HOSPITAL AND APPROPRIATING FUNDS THEREFOR

have considered the same and recommend its approval with the following amendment:

1. On Section 3, delete the entire provision and in lieu thereof substitute the following:

SEC. 3. THE PROVINCIAL GOVERNMENT OF CAMARINES NORTE SHALL PROVIDE FUNDING FOR THE ESTABLISHMENT, OPERATION AND MAINTENANCE OF SANTA ELENA DISTRICT HOSPITAL. THE SECRETARY OF HEALTH SHALL INCLUDE IN THE DEPARTMENT'S SUBSIDY PROGRAM, SUPPORT FOR THE CAPITAL OUTLAY OF THE SAID DISTRICT HOSPITAL.


2. Change the title of the bill to read as follows: **“AN ACT ESTABLISHING A DISTRICT HOSPITAL IN THE MUNICIPALITY OF SANTA ELENA, PROVINCE OF CAMARINES NORTE, TO BE KNOWN AS THE SANTA ELENA DISTRICT HOSPITAL AND APPROPRIATING FUNDS THEREFOR”**
