Mr. Speaker:

The Committee on Health and the Committee on Appropriations to which was referred House Bill No. 1574 introduced by Rep. Alfredo D. Vargas III , entitled:

AN ACT PROVIDING FOR THE CONSTRUCTION OF A SUPER HEALTH CENTER AND LYING-IN CLINIC IN BARANGAY SAN AGUSTIN, QUEZON CITY, AND APPROPRIATING FUNDS THEREFOR

have considered the same and recommend its approval with the following amendments:

1. On Section 2, delete the entire provision and in lieu thereof substitute the following:

SEC. 2. THE LOCAL GOVERNMENT OF QUEZON CITY SHALL PROVIDE FUNDING FOR THE ESTABLISHMENT, OPERATION AND MAINTENANCE OF THE SUPER HEALTH CENTER AND LYING-IN CLINIC IN BARANGAY SAN AGUSTIN. THE SECRETARY OF HEALTH SHALL INCLUDE IN THE DEPARTMENT'S SUBSIDY PROGRAM, SUPPORT FOR THE CAPITAL OUTLAY OF THE SAID HEALTH CENTER AND LYING-IN CLINIC.

2. On Section 3, line 14, insert the phrase "THE NECESSARY" between the words, "issue" and "rules".

3. On Section 3, line 15 delete the phrase, " as may be necessary to carry out the purpose" and in lieu thereof, insert the phrase, "FOR THE EFFECTIVE IMPLEMENTATION".
4. On Section 4, line 19, delete the phrase "at least two (2) newspapers", and in lieu thereof, insert the phrase, "A NEWSPAPER".
5. Change the title of the bill to read as follows: "AN ACT ESTABLISHING A SUPER HEALTH CENTER AND LYING-IN CLINIC IN BARANGAY SAN AGUSTIN, QUEZON CITY AND APPROPRIATING FUNDS THEREFOR"

With Reps. Alfredo D. Vargas III and Karlo Alexei B. Nograles as authors thereof.
