The Committee on Public Works and Highways to which was referred House Bill No. 4764, introduced by Rep. Frederick F. Abueg, entitled:

AN ACT
RENAMING THE PUERTO PRINCESA CITY SOUTH ROAD, STRETCHING
FROM THE NATIONAL ROAD AT JUNCTION 1, PUERTO PRINCESA CITY
PASSING THROUGH THE MUNICIPALITIES OF ABORLAN, NARRA, SOFRONIO
ESPAÑOLA, BARANGAY RIO TUBA IN THE MUNICIPALITY OF BATARAZA AT
THE EAST COAST, AND TURNING BACK TO PUERTO PRINCESA CITY FROM
THE WEST COAST, AGAIN PASSING THOSE MUNICIPALITIES UP TO
BARANGAY BACUNGAN, PUERTO PRINCESA CITY, PROVINCE OF PALAWAN,
AS GOVERNOR ALFREDO M. ABUEG NATIONAL CIRCUMFERENTIAL ROAD

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Puerto Princesa City South Road, starting from the national road at
2 Junction 1, Puerto Princesa City passing through the Municipalities of Aborlan, Narra, Sofronio,
3 Española, Barangay Rio Tuba in the Municipality of Bataraza at the east coast, and turning back
4 to Puerto Princesa City in the Province of Palawan, shall be renamed as Governor Alfredo M.
5 Abueg National Circumferential Road.

6 **SEC. 2.** The Department of Public Works and Highways shall issue the necessary
7 rules, orders and circulars to implement this Act.

8 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the Official
9 Gazette or in a newspaper of general circulation.
