The Committee on Basic Education and Culture to which were referred House Bill No. 6306, introduced by Rep. Virgilio S. Lacson, titled:

**AN ACT**  
**RECOGNIZING THE BRITISH SCHOOL MANILA AS AN**  
**EDUCATIONAL INSTITUTION OF INTERNATIONAL**  
**CHARACTER, GRANTING CERTAIN PREROGATIVES**  
**CONDUCTIVE TO ITS DEVELOPMENT AS SUCH, AND FOR OTHER**  
**PURPOSES**

House Bill No. 6032, introduced by Rep. Ron P. Salo, titled:

**AN ACT**  
**RECOGNIZING THE BRITISH SCHOOL MANILA AS AN**  
**EDUCATIONAL INSTITUTION OF INTERNATIONAL**  
**CHARACTER, GRANTING CERTAIN PREROGATIVES**  
**CONDUCTIVE TO ITS GROWTH AS SUCH, AND FOR OTHER**  
**PURPOSES**

and House Bill No. 6063, introduced by Rep. Evelina G. Escudero, titled:

**AN ACT**  
**IN RECOGNITION OF THE BRITISH SCHOOL MANILA AS AN**  
**EDUCATIONAL INSTITUTION OF INTERNATIONAL CHARACTER,**  
**GRANTING CERTAIN PREROGATIVES CONDUCTIVE TO ITS**  
**GROWTH AND EXPANSION AS SUCH, AND FOR OTHER**  
**PURPOSES**

has considered the same and recommends the approval of House Bill No. 6306, in consolidation with House Bills Numbered 6032 and 6063, with the following amendments:

1. On page 3, after the last sentence of Section 3, insert the following new Section: “SEC. 4. *SUPERVISION AND REGULATION OF THE DEPARTMENT OF EDUCATION.* – NOTWITHSTANDING THE RECOGNITION AND PREROGATIVES UNDER THIS ACT, THE BRITISH SCHOOL MANILA SHALL BE UNDER THE SUPERVISION AND REGULATION OF THE DEPARTMENT OF EDUCATION AND SHALL ADHERE TO BASIC LAWS, AND RULES AND REGULATIONS OF THE DEPARTMENT OF EDUCATION GOVERNING INTERNATIONAL OR FOREIGN SCHOOLS.” and renumber the succeeding Sections accordingly;
2. On page 3, delete Section 6 and in lieu thereof insert the following Section: “SEC. 7. *EFFECTIVITY.* – THIS ACT SHALL TAKE EFFECT FIFTEEN (15) DAYS AFTER ITS PUBLICATION IN THE OFFICIAL GAZETTE OR IN A NEWSPAPER OF GENERAL CIRCULATION.”;
3. The title of the bill is hereby amended as: “AN ACT RECOGNIZING THE BRITISH SCHOOL MANILA AS AN EDUCATIONAL INSTITUTION OF INTERNATIONAL CHARACTER AND GRANTING THE SCHOOL CERTAIN PREROGATIVES CONDUCIVE TO ITS DEVELOPMENT”

and with Reps. Lacson, Salo, Escudero, Durano, Olivarez, Ortega (P.), Violago, Uybareta, Lobregat, Cuaresma, Go (M.), Antonio, Bordado, Collantes, Gatchalian, Bolilia, Revilla, Cua and Quimbo as authors thereof.
