

AN ACT
**TRANSFERRING THE CAPITAL AND SEAT OF GOVERNMENT OF THE
PROVINCE OF RIZAL FROM THE CITY OF PASIG, METRO MANILA TO
THE CITY OF ANTIPOLO, PROVINCE OF RIZAL"**

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION. 1.** The capital and seat of government of the Province of Rizal is
2 hereby transferred from the City of Pasig, Metro Manila to the City of Antipolo, Province
3 of Rizal

4 **SEC. 2.** Upon the effectivity of this Act, the present Provincial Capitol located in
5 the City of Antipolo, Province of Rizal shall be deemed as the official Provincial
6 Government Center where all the provincial offices shall be established.

7 **SEC. 3.** All laws, decrees, executive orders, laws and regulations which are
8 inconsistent with this Act are hereby amended, repealed or modified accordingly.

9 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the
10 Official Gazette or in a newspaper of general circulation.
