AN ACT
DECLARING THE LANTAWAN ECOPARK LOCATED IN BARANGAY
SAN ROQUE AND BARANGAY CROSSING, MUNICIPALITY OF
KITCHARAO, PROVINCE OF AGUSAN DEL NORTE A PRIORITY
TOURISM SITE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in session assembled:

1 **SECTION 1.** The Lantawan Ecopark, located in Barangay San Roque and
2 Barangay Crossing, Municipality of Kitcharao, Province of Agusan del Norte is
3 hereby declared a priority tourism development area. As such, the Department of
4 Tourism (DOT) shall incorporate this in the National Tourism Development Plan.

5 **Sec. 2.** Within one (1) year after the approval of this Act, the DOT, in
6 coordination with the Tourism Infrastructure and Enterprise Zone Authority (TIEZA),
7 shall prepare a tourism development plan for the area that is cognizant of its
8 environmental and historical significance, and shall undertake the implementation of
9 said plan.

10 **Sec. 3.** The Secretary of the DOT shall include in the Department’s program
11 the implementation of this Act, the funding of which shall be included in the annual
12 General Appropriations Act and from internally-generated funds of the DOT.

1 **Sec. 4.** Within sixty (60) days from the effectivity of this Act, the DOT shall
2 issue the necessary rules and regulations for the proper implementation of this Act.

3 **Sec. 5.** This Act shall take effect fifteen (15) days after its publication in the
4 Official Gazette or in any newspaper of general circulation.
