16 Master’s Degree in Law and Finance conferred during the graduation rites of the Queen Mary

19 **WHEREAS**, such international recognition obtained by Atty. Nuylan is another
20 enviable achievement which raised the Filipino pride and clearly brought international prestige
21 to the country;

23 **NOW THEREFORE, BE IT RESOLVED**, That the House of Representatives

25 Student Honors” for the Master of Science in Law and Finance during the commencement rites
