**AN ACT**

**ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY PAN-AY DAKO, MUNICIPALITY OF CLARIN, PROVINCE OF MISAMIS OCCIDENTAL TO BE KNOWN AS FELINA SEVILLA OAMINAL NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. There is hereby established, under the supervision of the Department of  
2 Education, a national high school in Barangay Pan-ay Dako, Municipality of Clarin, Province  
3 of Misamis Occidental to be known as Felina Sevilla Oaminal National High School.

4  
5           SEC. 2. The Secretary of Education shall immediately include in the Department's  
6 program the operationalization of the Felina Sevilla Oaminal National High School, the funding  
7 of which shall be included in the annual General Appropriations Act.

8  
9           SEC. 3. The Secretary of Education shall formulate the rules and regulations  
10 implementing the provisions of this Act within one hundred twenty (120) days after its  
11 effectivity.

12  
13           SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official  
14 Gazette or in a newspaper of general circulation.
