The Committee on Justice, to which was referred House Bill No. 3266, introduced by Representative Linabelle Ruth R. Villarica entitled:


"AN ACT GRANTING PHILIPPINE CITIZENSHIP TO MOHAMAD WASSIM NANAA"

AN ACT
GRANTING PHILIPPINE CITIZENSHIP TO MOHAMAD WASSIM NANAA

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 **SECTION 1.** Mr. Mohamad Wassim Nanaa is hereby granted Philippine
2 citizenship with all the rights, privileges and prerogatives, as well as the duties
3 and obligations appurtenant thereto.

5 **SEC. 2.** Mr. Mohamad Wassim Nanaa shall take the Oath of Allegiance to the
6 Republic of the Philippines before an officer duly authorized to administer the
7 same. The Oath of Allegiance shall be registered with the Bureau of Immigration.

9 **SEC. 3.** Upon registration of the Oath of Allegiance, the Bureau of
10 Immigration shall issue a Certificate of Naturalization to Mr. Mohamad Wassim
11 Nanaa who shall thereupon enter into the full enjoyment of Philippine
12 citizenship.

14 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the
15 Official Gazette or in any newspaper of general circulation.
