AN ACT

RENAMING THE STRETCH OF ROAD CURRENTLY KNOWN AS THE NORTH LUZON EXPRESSWAY (NLEX), THAT TRAVERSES BARANGAY BALINTAWAK IN QUEZON CITY, THE CITIES OF CALOOCAN AND VALENZUELA IN METRO MANILA, THROUGH THE CITY OF MEYCAUAYAN, THE MUNICIPALITIES OF MARILAO, BOCAUE, BALAGTAS, GUIGUINTO, THE CITY OF MALOLOS, THE MUNICIPALITIES OF PLARIDEL AND PULILAN, ALL IN THE PROVINCE OF BULACAN, THROUGH THE MUNICIPALITY OF SAN SIMON, THE CITY OF SAN FERNANDO, THE MUNICIPALITY OF MEXICO, THE CITY OF ANGELES, UP TO BARANGAY STA. INES IN THE CITY OF MABALACAT, ALL IN THE PROVINCE OF PAMPANGA, AND WHICH MERGES WITH MAC ARTHUR HIGHWAY AND CONTINUES NORTHWARD INTO THE REST OF CENTRAL AND NORTHERN LUZON, TO THE MARCELO H. DEL PILAR EXPRESSWAY (MHDPEX)

Be it enacted by the Senate and the House of Representatives in Congress assembled:

1 **SECTION 1.** The stretch of road currently known as the North Luzon
2 Expressway (NLEX), that traverses Barangay Balintawak in Quezon City, through the
3 Cities of Caloocan and Valenzuela in Metro Manila, through the City of Meycauayan, the
4 Municipalities of Marilao, Bocaue, Balagtas, Guiguinto, the City of Malolos, the
5 Municipalities of Plaridel and Pulilan, all in the Province of Bulacan, through the
6 Municipality of San Simon, the City of San Fernando, the Municipality of Mexico, the City
7 of Angeles, up to Barangay Sta. Ines in the City of Mabalacat, all in the Province of
8 Pampanga, and which merges with MacArthur Highway and continues northward into the
9 rest of Central and Northern Luzon, is hereby renamed to the Marcelo H. Del Pilar
10 Expressway (MHDPEX).

12 **SEC. 2.** The Department of Public Works and Highways shall issue the
13 necessary rules, orders, and circulars to implement the provisions of this Act within sixty
14 (60) days from its effectivity.

15
16 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in
17 the *Official Gazette* or in a newspaper of general circulation.
