AN ACT
SEPARATING THE LUBON NATIONAL HIGH SCHOOL – MABALITE EXTENSION IN BARANGAY MABALITE, MUNICIPALITY OF TADIAN, MOUNTAIN PROVINCE FROM THE LUBON NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS MABALITE NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Lubon National High School – Mabalite Extension in Barangay
2 Mabalite, Municipality of Tadian, Mountain Province is hereby separated from the Lubon
3 National High School and converted into an independent national high school to be known as
4 Mabalite National High School.

6 SEC. 2. All personnel, assets, liabilities and records of the Lubon National High
7 School - Mabalite Extension are hereby transferred to and absorbed by the Mabalite National
8 High School.

10 SEC. 3. The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the Mabalite National High School, the initial funding of
12 which shall be charged against the current year's appropriation of the Lubon National High
13 School – Mabalite Extension. Thereafter, the amount necessary for the continued operation
14 of the school shall be included in the annual General Appropriations Act.

16 SEC. 4. Within one hundred twenty (120) days after the approval of this Act, the
17 Secretary of Education shall formulate the rules and regulations implementing the provisions
18 of this Act.

20 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
21 *Gazette* or in a newspaper of general circulation.

23 *Approved,*
