The Committee on Transportation and the Committee on Appropriations to which was referred House Bill No. 5120, introduced by Rep. Fidel Nograles, entitled:




have considered the same and recommend the approval of the attached House Bill No. 5882, entitled:

**AN ACT**  
**CONVERTING THE SATELLITE OFFICE OF THE LAND TRANSPORTATION**  
**OFFICE (LTO) LOCATED IN THE MUNICIPALITY OF TANAY, PROVINCE OF**  
**RIZAL INTO A REGULAR LTO DISTRICT OFFICE AND APPROPRIATING**  
**FUNDS THEREFOR**

*Be it enacted by the Senate and the House of Representatives of the  
Philippines in Congress assembled:*

1           **Section 1.** The Satellite Office of the Land Transportation Office (LTO) in the  
2 Municipality of Tanay, Province of Rizal is hereby converted into a Regular LTO  
3 District Office to be known as the LTO District Office of Tanay, Rizal.

4           **Sec. 2.** The Secretary of Transportation shall immediately include in the  
5 Department's programs the operationalization of a Regular LTO District Office in the  
6 Municipality of Tanay, Rizal, the initial funding of which shall be charged against the  
7 current year's appropriation of the Tanay LTO Satellite Office located in the  
8 Municipality of Tanay, Province of Rizal. Thereafter, such sums as may be  
9 necessary for the continued operation of the Regular LTO District Office shall be  
10 included in the annual General Appropriations Act.

11           **Sec. 3** Within ninety (90) days from the effectivity of this Act, the Secretary of  
12 the Department of Transportation shall promulgate the rules and regulations for the  
13 effective implementation of this Act.

14           **Sec. 4** This Act shall take effect fifteen (15) days after its publication in the  
15 Official Gazette or in a newspaper of general circulation.
