House Bill No. **3738**

AN ACT

CHANGING THE NAME OF THE UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES INTO THE UNIVERSITY OF SCIENCE AND TECHNOLOGY OF THE PHILIPPINES, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10919

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

SECTION 1. Section 1 of Republic Act No. 10919 is hereby amended to read as follows:

*"SECTION 1. Short Title. - This Act shall be known as the "University of Science and Technology of [Southern] THE Philippines [(USTSP)] (USTP) Act".*

SEC. 2. RA No. 10919 and all laws, presidential decrees, executive orders, and rules and regulations contrary to or inconsistent with the provisions of this Act are repealed or modified accordingly.

SEC. 3. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
