**AN ACT**  
**DECLARING JANUARY 2 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY**  
**IN THE MUNICIPALITY OF BONIFACIO, PROVINCE OF MISAMIS OCCIDENTAL**  
**TO BE KNOWN AS “BONIFACIO DAY”, IN COMMEMORATION OF ITS**  
**FOUNDATION ANNIVERSARY**

*Be it enacted by the Senate and the House of Representatives  
of the Philippines in Congress assembled:*

1           **SECTION 1.** January 2 of every year is hereby declared a special non-working holiday  
2 in the Municipality of Bonifacio, Province of Misamis Occidental, to be known as “*Bonifacio*  
3 *Day*”, in commemoration of its foundation anniversary.

5           **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
6 *Gazette* or in a newspaper of general circulation.
