At this point, Rep. Gerald Anthony V. Gullas Jr. acknowledged the presence in the Session Hall of guests of Rep. Ron P. Salo, Deputy Speaker Abu, Reps. Evelina G. Escudero, Federico "Ricky" S. Sandoval II, and Frederick W. Siao.

THE PRIVILEGE HOUR

With the permission of the Speaker and the unanimous consent of the House, on motion of Rep. Gullas, there being no objection, the Chair declared a Privilege Hour.

On motion of Rep. Gullas, the Chair then recognized Rep. Rosanna "Ria" Vergara from the Third District of Nueva Ecija for her privilege speech.

PRIVILEGE SPEECH OF REP. VERGARA

Rep. Vergara initially said that corruption, which she defined as abuse of power for private gain, was pervasive, systemic, and prevalent in the country.

She then said that because of countless instances of shooting and murder of barangay officials in her

district and the inaction thereon by Nueva Ecija Governor Aurelio Umali and his wife, Representative Cherry Umali, she ran under the platform of change and progress against the influential and well-connected couple who used to be a political ally and ruled over the province for the last 15 years. She stressed that she wanted to protect the weakest members of the political chain and will file and support measures that will entitle barangay officials to insurance coverage and pension under the Government Service Insurance System (GSIS).

She subsequently alleged that several officials of the Bureau of Immigration, whom she named, had conspired and tampered with official government documents to support several disqualification cases filed against her in order to benefit the Umalis and help them remain in power. She stressed that Congress must pass a law providing more severe punishment for corrupt public servants. She maintained that the country must be ruled by laws and not connections and must treat all Filipinos with equal respect and courtesy regardless of social, economic, and educational stature.

REFERRAL OF REP. VERGARA'S PRIVILEGE SPEECH

On motion of Rep. Gullas, there being no objection, the Body referred Rep. Vergara's privilege speech to the Committee on Rules.

SUSPENSION OF THE PRIVILEGE HOUR

On further motion of Rep. Gullas, there being no objection, the Body suspended the Privilege Hour.

ACKNOWLEDGMENT OF GUESTS

At this point, Rep. Gullas acknowledged the presence in the Session Hall of guests of Rep. Vergara.

Likewise, the Chair recognized the presence in the Session Hall of former Deputy Speaker Roberto V. Puno.

RESUMPTION OF THE PRIVILEGE HOUR

Thereupon, on motion of Rep. Gullas, there being no objection, the Body resumed the Privilege Hour.

Thereafter, on further motion of Rep. Gullas, the Chair recognized Rep. Harlin Neil J. Abayon III from Aangat Tayo Party-List for his privilege speech.

PRIVILEGE SPEECH OF REP. ABAYON

Rep. Abayon spoke on the issue of the improper implementation of the emission testing provision of the Philippine Clean Air Act of 1999. He relayed the concern of one of his constituents regarding emission testing and inquired into the status of emission testing centers as he lamented that there are certain unscrupulous individuals who are taking advantage of the situation for their personal gain. As such, he urged the Departments of Trade and Industry (DTI), and Transportation (DOTr) to review the accreditation of the authorized emission testing centers.

On motion of Rep. Gullas, the Chair recognized Rep. Federico "Ricky" S. Sandoval II for his interpellation.

INTERPELLATION OF REP. SANDOVAL

Rep. Sandoval agreed with the concerns raised by Rep. Abayon and likewise disclosed that fake apprehending officers who are not connected with the Land Transportation Office (LTO) are rampant along Epifanio delos Santos Avenue (EDSA) and prey on unsuspecting motorists. They also dwelled on the issue of unscrupulous emission testing operators who allow emission testing of vehicles *in absentia* but are still given permits to operate by the LTO; the endless approval of permits to operate private emission testing centers; and the need for the LTO and the DOTr to review the system of emission testing.

REFERRAL OF REP. ABAYON'S SPEECH

On motion of Rep. Gullas, there being no objection, the Body referred Rep. Abayon's privilege speech and the interpellation thereon to the Committee on Rules.

PRIVILEGE SPEECH OF REP. PINEDA

Recognized by the Chair on motion of Rep. Gullas, Rep. Enrico A. Pineda from 1-PACMAN Party-List first emphasized the important role as well as the social and economic impact of telecommunications throughout the world, this as he noted that reliable networks could be found in top industrialized nations while developing countries are still working diligently to attain this level.

As he observed that the Philippines has been lagging behind in terms of internet connectivity and cellular services that it has already been outranked by its neighboring countries, he lamented that the Filipinos also suffer from costly broadband and internet charges. He thereafter emphasized the National Telecommunications Commission's (NTC) task of reviewing and safeguarding the operations of the telecom industry, particularly in the light of President Rodrigo R. Duterte's warning to telecommunications companies (Telcos) "to shape up or face the consequences." He concluded that the Filipinos deserve better services which, he hoped, would be provided by the telcos.

ACKNOWLEDGMENT OF GUESTS

At this point, Rep. Gullas acknowledged the presence in the Session Hall of the guests of Reps. Karlo Alexei B. Nograles, Cesar V. Sarmiento, Mark Aeron H. Sambar and Jericho Jonas B. Nograles.

Thereafter, on motion of Rep. Gullas, the Chair recognized Rep. Salvador B. Belaro Jr. for his interpellation.

INTERPELLATION OF REP. BELARO

At the outset, Rep. Belaro praised Rep. Pineda for bringing to the fore the unfair practices of some internet service providers (ISPs) in the country. On the queries of Rep. Belaro, Rep. Pineda affirmed that the Philippines has one of the highest internet rates being assessed for internet services and that there are only two companies which provide internet services in the country.

They also discussed possible solutions that the Members could do to improve their services; the need to open up competition for internet services in the country; the abuses committed to the consumers by the

two Telcos; and the need to address the problem of having only two ISPs in the country.

Before providing the necessary internet facilities to far-flung areas in the country, Rep. Belaro expressed belief that they should first address the problem of having only two ISPs in the country by allowing other players to join the competition.

INTERPELLATION OF REP. SY-ALVARADO

On motion of Rep. Arthur R. Defensor Jr., the Chair recognized Rep. Jose Antonio "Kuya Jonathan" R. Sy-Alvarado who asked Rep. Pineda to reiterate the reasons why the Philippines has a so-called slow internet speed and the solution thereto. They also discussed the lack of cell site facilities as a contributory factor to the problem of slow internet speed in the country, and agreed that cutting of red tape in the issuance of permits may somehow resolve the country's problem on the need to establish more cell sites.

Rep. Sy-Alvarado then appealed to his colleagues to help find solutions to improve the internet speed in the country. He said that along with a changing society and nation, the internet service should also be given priority for this would make the Filipinos more productive.

Thereafter, on motion of Rep. Gullas, the Chair recognized Rep. Arnolfo A. Teves Jr. for his interpellation.

INTERPELLATION OF REP. TEVES

On Rep. Teves' query, Rep. Pineda agreed that oversubscription and substandard internet services should be criminalized.

REFERRAL OF REP. PINEDA'S PRIVILEGE SPEECH

On motion of Rep. Gullas, there being no objection, the Body referred the privilege speech of Rep. Teves together with the interpellations to the Committee on Rules.

Likewise, on motion of Rep. Gullas, the Chair recognized Rep. Rodel M. Batocabe from Ako Bicol Party-List for his privilege speech.

PRIVILEGE SPEECH OF REP. BATOCABE

Rep. Batocabe delved on the recent development on the war against drugs and what to do with the mass surrenderees. He averred that the drug rehabilitation issue would be better addressed by a comprehensive and sustainable plan that aims to establish additional drug rehabilitation centers strategically located in each legislative district of the country.

As he cited more statistics, Rep. Batocabe said that what the government needs is to appropriate around P33 billion for the drug rehabilitation program as he remarked that it had allocated more than that amount for the Conditional Cash Transfer Program. He then proposed to increase admissions in existing rehabilitation centers; build additional centers or at least one center in each district; and consider the temporary use of military camps and government hospitals to treat drug dependents. He thereafter urged for a comprehensive and long-term plan on how to address the rehabilitation of the drug dependents and that the war against drugs should include saving lives and protecting the welfare and rights of the people.

On motion of Rep. Gullas, the Chair recognized Rep. Rozzano Rufino B. Biazon for his interpellation.

INTERPELLATION OF REP. BIAZON

Agreeing with the views of his colleague, Rep. Biazon nevertheless asked whether the government should also look at reducing the drug demand, drug supply, and drug distribution network. Rep. Batocabe agreed that the aforecited measures were part and parcel of the drug war after saying that the identification and monitoring of drug suspects under "Operation Tokhang" was merely a stop-gap measure; the body count was not an indicator of winning the drug war but only a reminder of the need to address the problem; and drug dependents will return to their old ways if they are not rehabilitated.

Finally, Reps. Batocabe and Biazon agreed that with the forthcoming deliberations on the 2017 national budget, it is timely for Congress to seek additional funds for the rehabilitation of drug victims. They also agreed that in the exercise of its power to appropriate, Congress should inquire from the Executive Department the programs, strategies and tactics needed to win the war against illegal drugs.

On motion of Rep. Gullas, the Chair recognized Rep. Sherwin N. Tugna for his interpellation.

INTERPELLATION OF REP. TUGNA

To the concerns of Rep. Tugna, Rep. Batocabe agreed that Congress should legislate measures allowing the forfeiture of assets of convicted persons involved in illegal drugs, the proceeds of which could

be used to fund the rehabilitation programs for drug victims.

Rep. Batocabe also suggested the filing of a bill that will allow enforcement officials to sequester properties of suspected drug lords.

As a rejoinder, Rep. Tugna agreed on the need to monitor the performance of drug rehabilitation centers.

REFERRAL OF REP. BATOCABE'S PRIVILEGE SPEECH

Thereupon, on motion of Rep. Gullas, there being no objection, the Body referred the privilege speech of Rep. Batocabe, together with the interpellations thereon, to the Committee on Rules.

TERMINATION OF THE PRIVILEGE HOUR

On motion of Rep. Gullas, there being no objection, the Body terminated the Privilege Hour.

APPROVAL OF THE JOURNAL

Thereafter, on motion of Rep. Gullas, there being no objection, the Body approved Journal No. 10, dated August 15, 2016.
