On motion of Representative de Venecia, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6770 contained in Committee Report No. 508 as reported out by the Committee on Labor and Employment.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INCREASING THE SERVICE INCENTIVE LEAVE OF EMPLOYEES, AMENDING FOR THE PURPOSE ARTICLE 95 OF PRESIDENTIAL DECREE NO. 442, AS AMENDED, OTHERWISE KNOWN AS THE LABOR CODE OF THE PHILIPPINES.”

Representative de Venecia thereafter stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and on his motion, the Chair recognized Rep. Randolph S. Ting, Chairperson of the Committee on Labor and Employment, to sponsor the measure.

## SPONSORSHIP REMARKS OF REPRESENTATIVE TING

Presenting the instant Bill for approval, Representative Ting stated that some employees in the private sector are exempted from enjoying the service incentive leave. He then stressed that the Bill proposes to increase the same from five to 10 days. Citing the current complex and stressful lifestyle that leaves workers more susceptible to sickness and emergencies, he explained that the Bill aims to give employees more time to rest, seek medical care, balance their work life, and be with their loved ones.

## TERMINATION OF PERIOD OF SPONSORSHIP AND DEBATE

There being no Member who wished to interpellate the Sponsor, on motion of Representative de Venecia, there being no objection, the Body terminated the period of sponsorship and debate; and thereafter proceeded to the period of amendments.

## PERIOD OF AMENDMENTS

There being no Committee amendments, on motion of Representative de Venecia, there being no objection, the Body proceeded to consider individual amendments.

## SUSPENSION OF SESSION

On motion of Representative de Venecia, the Chair suspended the session at 3:45 p.m.

At 3:46 p.m., the session resumed.

## SUSPENSION OF CONSIDERATION OF HOUSE BILL NO. 6770

Upon Representative Defensor's motion, there being no objection, the Body suspended the consideration of House Bill No. 6770.

The Chair *motu proprio* suspended the session at 3:48 p.m.

## RESUMPTION OF SESSION

At 3:50 p.m., the session resumed.

## BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 507 ON HOUSE BILL NO. 6769

Upon Representative Defensor's motion, there being no objection, the Body then considered on Second Reading House Bill No. 6769 contained in Committee Report No. 507 as submitted by the Committee on Labor and Employment.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT EXPANDING THE PROHIBITION OF DISCRIMINATORY ACTS AGAINST WOMEN ON ACCOUNT OF SEX, AMENDING FOR THE PURPOSE PRESIDENTIAL DECREE NO. 442, AS AMENDED, OTHERWISE KNOWN AS THE 'LABOR CODE OF THE PHILIPPINES'.”

As copies of the Bill had been distributed to the Members, on motion of Representative Defensor, there being no objection, the Body dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House.

On motion of Representative Defensor, the Chair recognized Representative Ting, Chairperson of the sponsoring Committee, to deliver his sponsorship remarks on the measure.

## SPONSORSHIP REMARKS OF REPRESENTATIVE TING

Representative Ting, after thanking Reps. Emeline Aglipay-Villar and Strike B. Revilla for filing House Bill No. 6769, explained that the measure seeks to penalize employers who give preference to male employees over female employees in recruitment, hiring, and employment and prohibits the denial to women of the benefits of employment or other legal statutory benefits because of her sex.

He cited Section 14, Article II of the Constitution which mandates the protection and strengthening of women and their role in society. Seeking the Body's support and approval of the Bill, he said that the goal of the measure is to remove the protective veil of sexual discrimination by explicitly stating the acts that constitute discrimination as well as to ensure that the gravity of punishment suits the gravity of the offense.

## TERMINATION OF PERIOD OF SPONSORSHIP AND DEBATE

There being no interpellations, on motion of Representative Defensor, there being no objection, the Body terminated the period of sponsorship and debate, and thereafter proceeded to the period of amendments.

## COMMITTEE AMENDMENTS

As proposed by Representative Ting, there being no objection, the Body approved the Committee amendments on pages 1, 2, and 3 of House Bill No. 6769.

## TERMINATION OF PERIOD OF AMENDMENTS

There being no more Committee or individual amendments, on motion of Representative Defensor, there being no objection, the Body terminated the period of amendments.

## APPROVAL ON SECOND READING OF HOUSE BILL NO. 6769, AS AMENDED

Upon Representative Defensor's motion, there being no objection the Body approved on Second Reading House Bill No. 6769, as amended, through *viva voce* voting.

The Chair subsequently declared a recess at 3:59 p.m. upon Representative Defensor's motion.

The session resumed at 4:07 p.m.

**BUSINESS FOR THE DAY:  
COMMITTEE REPORT NO. 787  
ON HOUSE BILL NO. 7857**

On motion of Representative de Venecia, there being no objection, the Body considered on Second Reading House Bill No. 7857 contained in Committee Report No. 787 as reported out by the Committees on Trade and Industry, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT PROVIDING FOR THE ESTABLISHMENT OF A *TIMBANGAN NG BAYAN* CENTER IN ALL MARKETS NATIONWIDE, AMENDING FOR THE PURPOSE CHAPTER II OF REPUBLIC ACT NO. 7394, OTHERWISE KNOWN AS THE 'CONSUMER ACT OF THE PHILIPPINES'.”

As copies of the Bill had been distributed to the Members, on motion of Representative de Venecia, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative de Venecia, the Chair recognized Rep. Ferjanel G. Biron, MD, Chairperson of the Committee on Trade and Industry, for his sponsorship remarks.

**SPONSORSHIP REMARKS  
OF REPRESENTATIVE BIRON**

On motion of Representative Biron, duly seconded by Representative de Venecia, there being no objection, the Body adopted the Explanatory Note of the original House Bill No. 2957 as the sponsorship remarks on the instant measure. He then sought his colleagues' approval of House Bill No. 7857.

On motion of Representative Defensor, the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

**INTERPELLATION OF  
REPRESENTATIVE ATIENZA**

Representatives Atienza and Biron discussed the definition of the word “market” as used in the Bill. Representative Atienza stressed that the law should be clear as to who would provide for a *Timbangan ng Bayan* with regard to a situation where a market can be considered as both public and private. Representative Biron replied that every market, regardless of its nature, should have a *Timbangan ng Bayan* and that the local government units through their provincial, city or municipal treasurers are mandated to provide a *Timbangan ng Bayan* and to monitor the same as well.

Representative Atienza then congratulated Representative Biron for the stiff penalties to be meted out to vendors who will be found cheating in any market. He thereafter stated that he would be proposing an amendment at the proper time to include the cancellation of work permits of those who will be caught cheating for at least three times. Representative Biron said that Representative Atienza's proposal is a welcome suggestion which could be incorporated in the proposed measure.

**TERMINATION OF PERIOD  
OF SPONSORSHIP AND DEBATE**

There being no further interpellations, on motion of Representative de Venecia, there being no objection, the Body terminated the period of sponsorship and debate and thereafter proceeded to the period of amendments.

On subsequent motion of Representative Defensor, there being no objection, the Body approved on Second Reading House Bill No. 7857, as amended, through *viva voce* voting.

## UNFINISHED BUSINESS: COMMITTEE REPORT NO. 13 ON HOUSE BILL NO. 4113

On motion of Representative de Venecia, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 4113 contained in Committee Report No. 13 as reported out by the Committee on Women and Gender Equality.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INCREASING THE MATERNITY LEAVE PERIOD TO ONE HUNDRED (100) DAYS FOR FEMALE WORKERS IN THE GOVERNMENT SERVICE AND IN THE PRIVATE SECTOR, AND GRANTING AN OPTION TO EXTEND FOR AN ADDITIONAL THIRTY (30) DAYS WITHOUT PAY.”

Representative de Venecia stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and on his motion, the Chair recognized Rep. Bernadette “BH” Herrera-Dy, Chairperson of the Committee on Women and Gender Equality, to sponsor the measure and Representative Atienza for his interpellation.

## INTERPELLATION OF REPRESENTATIVE ATIENZA

Initially, Representative Atienza stressed that as a pro-lifer, he likes the Bill but the Body should be very clear as to how it will be implemented. He then sought the assurance of the Sponsor as to the administrative and financial viability of the measure. This, as he cautioned the Members against giving false hopes to pregnant women employees.

The Sponsor stated that institutions such as the Social Security System (SSS), Government Service Insurance System (GSIS), Employees Confederation of the Philippines (ECOP), League of Cities of the Philippines (LCP), and the Union of Local Authorities of the Philippines (ULAP) had welcomed the proposed measure.

While Representative Atienza congratulated the Sponsor for her patience and perseverance in sponsoring the proposed measure, he inquired if the sponsoring Committee had conducted proper consultations with stakeholders at the local level to guarantee their support for the Bill and prepare them with its possible additional budgetary requirements. He then requested for copies of the position papers submitted to the Committee as he expressed support for the immediate passage of the instant Bill and his willingness to be one of its coauthors.

On motion of Representative de Venecia, the Chair next recognized Rep. Arnel U. Ty for his interpellation.

### **INTERPELLATION OF REPRESENTATIVE TY**

Representative Ty exchanged views with Representative Herrera-Dy regarding the viability of the SSS fund for members who would be eligible to avail of the maternity leave benefit under the Bill; how said benefit could help augment the income of minimum wage earners; and the difference in the provisions of the proposed Maternity Leave Law from the existing Republic Act No. 8282 or the Social Security Act.

To Representative Ty's other concerns, the Sponsor said that the ECOP eventually interposed no objection to the Bill inasmuch as many companies were already implementing 98 days of maternity leave; the number of employees that will benefit from the instant Bill constitutes only 1.73 percent of the labor sector and they are mostly minimum wage earners; the SSS finds the maternity leave scheme viable and doable; the cost involved in increasing the maternity leave is so small compared to what women in the country deserve and given that maternal function is a social responsibility; and the Committee will consider an amendment that will exclude other employers or businesses from the coverage of the Bill.

Representative Ty next discussed the labor productivity level in the Philippines as compared to other Asian countries. He said that additional days of maternity leave would cost a lot to small businesses which he was trying to protect. Representative Herrera-Dy appealed to Representative Ty that should there be a provision which he would like to include in the Bill, he should do so during the period of amendments.

Stating that he will end his interpellation if the Sponsor would commit to accept his proposed amendments, Representative Ty asked whether the Sponsor would agree that the maternity benefit provided under the Bill shall be paid only for the first four deliveries. Representative Herrera-Dy said that she is amenable to the proposal although the Bill provides that maternity leave shall be granted to female workers in every instance of pregnancy, miscarriage, or abortion regardless of its frequency.

Representative Ty then asked whether Representative Herrera-Dy would be willing to remove the provision under Section 5 (c) of the Bill.
