THE PRIVILEGE HOUR

The day being a Monday, on motion of Rep. Bondoc, there being no objection, the Chair declared a Privilege Hour and recognized Rep. Emmi A. De Jesus from Gabriela Party-List to deliver her privilege speech.

PRIVILEGE SPEECH OF REP. DE JESUS

As Rep. De Jesus assailed in Filipino the poor cellphone services as well as the penalties and hidden fees charged by telecommunications companies (telcos) to the consumers, she related her personal experience of customer service troubles as a postpaid subscriber who had used the same cellphone number in the last 13 years and had recently applied for an upgrade of her postpaid plan.

She recalled the difficulties she encountered because 1) she had to wait long as her transaction had to pass through customer service representatives in a call center; 2) she was charged for a decade-long bill that was never reflected in her statement of account so she was forced to stop the subscription for the particular cellphone number; 3) her application for a new post-paid plan was cut because she was told that she had to settle first her old account; 4) she suffered from a daylong disconnection that she had to personally talk to the OIC manager and put in writing her complaint.

Rep. De Jesus said that as she tackled her problem with her postpaid plan, she learned of the many stories about similar situations encountered by consumers with major telcos, as well as the numerous negative comments against them in social media since 2013, such as overcharging, lack of refund in instances when internet services were not provided, and slow and inefficient customer service.

It is about time, she said for these communications service providers to be made accountable for their inefficient services. She then expressed hope that her speech would be referred to the proper committee that will help solve the problems of the telco consumers.

REFERRAL OF REP. DE JESUS' PRIVILEGE SPEECH

On motion of Rep. Bondoc, there being no objection, the Body referred the privilege speech of Rep. De Jesus to the Committee on Rules.

MANIFESTATION OF REP. DAZA

Recognized by the Chair, Rep. Raul A. Daza said that he was not objecting to Rep. Bondoc's motion but he would like to consent to the latter that the specific committee be now named to look into Rep. De Jesus' privilege speech. He then moved to amend said motion to refer the speech to the Committee on Legislative Franchises which has the jurisdiction to revoke the franchises of telecommunications companies.

The Chair asked whether Rep. Bondoc would accept Rep. Daza's amendment to which Rep. Bondoc posed no objection and explained that tradition holds that the Body refer the said speech to the Committee on Rules aside from the Committee on Legislative Franchises. He added that other committees, such as the Committee on Transportation, might also wish to join in the discussion. He expressed hope that Rep. Daza was satisfied with the referral of said speech.

REP. DAZA'S AMENDMENT TO THE MOTION

Rep. Daza said that he would be satisfied with Rep. Bondoc's explanation, provided that it be placed on record that the subject matter of the speech referred to the Committee on Rules would be referred to the Committee on Legislative Franchises considering that under Section 28 of the amended Provisional Rules of the House, the Committee on Legislative Franchises has the potential to correct the way the telephone companies should have been functioning and has the power to revoke or threaten to revoke franchises of telephone companies.

Upon agreement with the original movant, there being no objection, the Chair approved Rep. Daza's amendment to Rep. Bondoc's motion by referring the speech of Rep. De Jesus to the Committee on Legislative Franchises.

REMARKS OF THE CHAIR

The Chair likewise reminded the Members that they are not prevented from seeking referral to other Committees once their speeches had been referred to the Committee on Rules.

PRIVILEGE SPEECH OF REP. LOPEZ (M.)

On motion of Rep. Bondoc, the Chair recognized Rep. Manuel Luis T. Lopez from the First District of Manila who spoke on two important events in Philippine history that happened in August 21: 1) the Plaza Miranda bombing during the *miting de avance* of the opposition Liberal Party; and 2) when Ninoy Aquino upon his return home after a three-year exile in the United States was gunned down at the tarmac of the old Manila International Airport.

He cited the important lessons that the people should learn from these two important events and expressed hope that the young would look back and reflect on the lessons learned on this very significant day and recall the sacrifice and heroism of these brave and courageous men as the country commemorate the events of August 21.

He then called upon the Members to rededicate themselves to the fundamental right of freedom of speech and independence; and to unite and take action whenever these primordial values are threatened.

REFERRAL OF REP. LOPEZ'S (M.) PRIVILEGE SPEECH

On motion of Rep. Bondoc, there being no objection, the Body referred the privilege speech of Rep. Lopez (M.) to the Committee on Rules.

ACKNOWLEDGMENT OF GUESTS

At this point, Rep. Bondoc acknowledged the presence in the Session Hall of guests of Reps. Florida "Rida" P. Robes and Jose L. Atienza Jr.

PRIVILEGE SPEECH OF REP. ATIENZA

Recognized by the Chair, Rep. Atienza from Buhay Party-List also stood up to speak on the same event on August 21, 1971 wherein he, together with the father of Rep. Lopez, the late Mayor Mel Lopez, gladly stood up in front of the people in Plaza Miranda to be proclaimed as candidates of the Liberal Party when the bombing took place.

He averred that the years in between have shown that the late former President Ferdinand E. Marcos had nothing to do with said bombing, and that according to research, a Senate hearing and former General Victor Corpuz, it was Jose Maria Sison who masterminded the whole thing. He asked whether the culprits have already been apprehended or charged since then, because if nothing has been done or if the truth is not uncovered, he said that the next generation will suffer for not being able to learn lessons from past history.

Thereafter, he spoke about the assassination of former Senator Benigno "Ninoy" Aquino Jr. also on August 21 and wondered why despite having had two Aquino Administrations, no one seemed interested in speaking about the issues during said administrations, more importantly in identifying the brains behind the Plaza Miranda bombing and Ninoy's assassination. He expressed fear that the country would be going nowhere should there be no answer to these questions. He further underscored that the certainty of punishment is the best deterrent to the commission of any crime.

Whereupon, Rep. Atienza called on President Rodrigo Roa Duterte to do something and find out the masterminds behind the two dreadful events in order to ferret out the truth. He also expressed his support

for the burial of former President Marcos in the Libingan ng mga Bayani. Thereafter, Rep. Atienza asked everyone to look back and give a kinder eye on Mr. Marcos who was vilified and accused of doing evil when he only wanted to free the country then from a communist takeover.

REFERRAL OF REP. ATIENZA'S PRIVILEGE SPEECH

On motion of Rep. Victoria Isabel G. Noel, there being no objection, the Body referred the privilege speech of Rep. Atienza to the Committee on Rules.

SUSPENSION OF THE PRIVILEGE HOUR

Likewise, on motion of Rep. Noel, there being no objection, the Body suspended the Privilege Hour.

ACKNOWLEDGMENT OF GUESTS

At this point, Rep. Noel acknowledged the presence in the Session Hall of the youth members of the European Parliamentary Forum Delegation who were guests of Deputy Speakers Pia S. Cayetano and Sharon S. Garin, and Reps. Rodel M. Batocabe and Alfredo A. Garbin Jr.

RESUMPTION OF THE PRIVILEGE HOUR

Thereafter, on motion of Rep. Noel, there being no objection, the Body resumed the Privilege Hour and the Chair recognized Rep. Florida "Rida" P. Robes from the Lone District of San Jose Del Monte City for her privilege speech.

PRIVILEGE SPEECH OF REP. ROBES

Rep. Robes delved into the current water crisis affecting her Lone District in Bulacan which has been waterless for the past six days. She then commented on the ineptitude of the city's local water district in addressing the problem.

She said that the San Jose Del Monte City Water District's (SJDMCWD) plan to resort to borrowings will only result in the increase of the very high water charges that her constituents were already suffering from despite inefficient water services. As she complained about the SJDMCWD's lack of social responsibility, she discussed the contributory factors to the water crisis such as the poverty of her constituents, her district's lack of surface water and inability to benefit

from water passing through it that was transmitted to Metro Manila, and the increase in their urban poor migration.

Thereupon, Rep. Robes asked the national government to allow more private concessionaires to enter San Jose Del Monte City and to enact legislations to check the operations of local water districts and ensure the accountability of their directors; institutionalize early warning systems for water interruption; and grant local chief executives with greater supervision over local districts.

INTERPELLATION OF REP. BATOCABE

On motion of Rep. Gullas, the Chair recognized Rep. Rodel M. Batocabe who sought more information about the water problem in San Jose Del Monte City. Rep. Robes said that she was not aware of what the Local Water Utilities Administration (LWUA) was doing about it, not all of the barangays in her district had water connections, the Bulk Water Project of her district was not yet implemented, and the SJDMCWD was reportedly building treatment facilities in some barangays. She also affirmed that she was proposing the liberalization of the water industry, her poor constituents could not afford the prohibitive water rates, and the SJDMCWD did not consult the stakeholders about the new rates.

REFERRAL OF REP. ROBES' PRIVILEGE SPEECH

On motion of Rep. Gerald Anthony V. Gullas Jr., there being no objection, the Body referred Rep. Robes' privilege speech and interpellation thereon to the Committee on Rules.

On further motion of Rep. Gullas, the Chair recognized Rep. Arnolfo A. Teves Jr. from the Third District of Negros Oriental for his privilege speech.

PRIVILEGE SPEECH OF REP. TEVES

Alleging that the governor of Negros Oriental had been using the provincial police director to harass his political opponents, Rep. Teves said that the former relieved several police chiefs for no reason at all and without offering the mayors concerned with several replacements for the same and planned to implicate him with possession of illegal drugs and firearms in his residence. He also alleged that the governor was using said police director to operate his money-making schemes.

Thereupon, Rep. Teves called for an investigation into the illegal activities in his province and requested Philippine National Police (PNP) Regional Director Conrad Capa to immediately relieve police Provincial Director Nestor Tiempo from his post as the mandate of the police is to protect the people and not to be a partisan to a provincial governor.

REFERRAL OF REP. TEVES' PRIVILEGE SPEECH

Thereafter, on motion of Rep. Gullas, there being no objection, the Body referred the privilege speech of Rep. Teves to the Committee on Rules.

REMARKS OF REP. TEVES

Rep. Teves stated that he would like to submit to the Body a copy of his letter to PNP Regional Director Capa.

The Chair informed Rep. Teves that the contents of his letter had already been made part of his speech.

EXTENSION OF THE PRIVILEGE HOUR

On motion of Rep. Gullas, there being no objection, the Body extended the Privilege Hour for 30 minutes.

Thereafter, on motion of Rep. Gullas., the Chair recognized Rep. Henry S. Oaminal from the Second District of Misamis Oriental for his privilege speech.

PRIVILEGE SPEECH OF REP. OAMINAL

Rep. Oaminal spoke on the threat of illegal drugs which is among the greatest evils that the country faces and threatens to eat away at the very foundation it is built upon. As he worked hard hand-in-hand with his constituents to address the issue of illegal drugs, he informed the Body of some of the community-based programs and seminars he had initiated in the campaign against illegal drugs, such as the creation of the District 2 Anti-Drug Abuse Council and the Barangay Anti-Drug Clearing Program, establishment of community-based rehabilitation centers, and rewarding law enforcers for their accomplishments in the illegal drugs war, among others.

The Member also stated that the turn of events the previous months in his district has increased the Misamisnons' trust in government because they now believe that there are no sacred cows in the present Administration, and that they are happy because they feel that the President cares.

In the aftermath of President Duterte's announcement, he continued, some of the leaders and people in the province reported to him the insinuations made by the camp of Mayor Reynaldo "Aldong" Parojinog Sr. of Ozamiz City that Rep. Oaminal was responsible for making a report to the President that led to the inclusion of their names in the list and that the said mayor and company have retaliated by using their connections and resources to come up with dossiers that would connect Rep. Oaminal to illegal drugs. He thereafter denied said insinuations and expressed confidence that should the authorities receive such dossiers, they will properly validate and investigate any outrageous claims.

He then appealed to President Duterte, the House leadership, Department of the Interior and Local Government Secretary Ismael Sueño and PNP Chief Ronald "Bato" Dela Rosa to protect the lives of the people, including his family, friends and himself in their strong adherence to good governance and crusade against illegal drugs. He expressed support to Rep. Rodel M. Batocabe's call in his privilege speech the previous week for the inclusion in the 2017 national budget of a program to rehabilitate drug addicts, and called on his colleagues to support the President's fight against illegal drugs.

DIAZ FOR WINNING THE SILVER MEDAL IN THE WOMEN'S WEIGHTLIFTING 53-KG CATEGORY IN THE 2016 RIO DE JANEIRO SUMMER OLYMPIC GAMES"; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; and unanimously adopted the same.
