On an omnibus motion of Rep. Ortega (V.N.), there being no objection, the Body considered on Second Reading the following House Bills calendared under the Business for Thursday and Friday contained in Committee Reports submitted by the Committees concerned; dispensed with the reading of the texts of the measures without prejudice to their insertion into the Record of the House; adopted the Explanatory Notes as the sponsorship remarks on the measures; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting:

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 842 ON HOUSE BILL NO. 8165

On motion of Representative Ortega (V.N.), there being no objection, the Body considered on Second Reading House Bill No. 8165 contained in Committee Report No. 842 as reported out by the Committees on Government Reorganization, National Defense and Security, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT CREATING THE DEPARTMENT
OF DISASTER RESILIENCE, DEFINING
ITS POWERS AND FUNCTIONS,
AND APPROPRIATING FUNDS
THEREFOR.”

As copies of the Bill had been distributed to the Members, on motion of Representative Ortega, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Ortega, the Chair recognized Rep. Xavier Jesus D. Romualdo, Chairperson of the Committee on Government Reorganization, to deliver his speech on the measure which was coauthored by Reps. Rodel M. Batocabe and Joey Sarte Salceda.

SPONSORSHIP SPEECH OF REPRESENTATIVE ROMUALDO

At the outset, Representative Romualdo stated that House Bill No. 8165 was a consolidation of numerous measures, seeking to create the Department

of Disaster Resilience (DDR). He then cited statistics which showed the damages brought about by natural disasters and calamities and the government's *ad hoc*, coordinative and reactive approach to disaster risk management. In this regard, he spoke on the need to anchor climate and disaster resilience to the very foundations of sustainable development by creating a Cabinet-level agency that builds a culture of resilience, organizes and strengthens the nation to prepare for or face catastrophic events, and reduces the complexity of responding to the threats of current and future climate and disaster risks.

Representative Romualdo then enumerated the Bill's objectives towards an improved centralized disaster resiliency system with an integrated approach to risk reduction; discussed how the new disaster agency would function and work with other government agencies; and emphasized the need to invest in disaster resilience programs and projects as well as to adopt a multi-stakeholder approach and strong partnership.

As the Bill was in compliance with President Rodrigo Roa Duterte's declaration during his 2018 State of the Nation Address (SONA) that the country needs a truly empowered disaster resilience department, the Sponsor subsequently urged his colleagues to support the approval of the instant Bill.

MANIFESTATION OF REPRESENTATIVE BATOCABE

Upon recognition of the Chair, Representative Batocabe stated for the record that he was in possession of the sponsorship speech of Rep. Yedda Marie K. Romualdez and asked that it be made as an integral part of the proceedings on House Bill No. 8165.

SPONSORSHIP SPEECH OF REPRESENTATIVE BATOCABE

Representative Batocabe recalled how Congress, the principal authors of the DDR Bill, local government units (LGUs) and other stakeholders had worked together towards responding to the need for a more resilient Philippines amidst the adverse impact of climate change. He stressed that collectively, they initiated the creation of a new department that envisions to ensure that vulnerable communities are able to adapt to the impact of climate change and disasters.

Admitting that the Bill has its flaws which may need refinements, Representative Batocabe however pointed out that the use of advisory councils

during disasters only led to many delays, confusion, and lack of accountability which has cost properties, livelihood, and even lives.

He thereafter enjoined his colleagues to join him in the quest towards making a disaster-resilient Philippines.

INSERTION INTO THE RECORDS OF REPRESENTATIVE ROMUALDEZ' SPONSORSHIP SPEECH

Whereupon, on motion of Representative Roa-Puno, the Chair directed the Secretariat to insert into the records the sponsorship speech of Representative Romualdez on House Bill No. 8165.

On another motion of Representative Roa-Puno, the Chair recognized Representative Salceda for his sponsorship speech.

SPONSORSHIP SPEECH OF REPRESENTATIVE SALCEDA

Representative Salceda cited the damages brought about by several disasters because of climate change and how people especially the poor took efforts to recover and rehabilitate on their own.

Talking on a personal note, Representative Salceda shared that he lost his mother due to Typhoon Juaning in 2011 and the Bill was a tribute to her and other victims of calamities as it seeks to address the causes of their death especially in terms of the institutional capacity of the State .

Representative Salceda appealed for his colleagues' support for the prompt approval of House Bill No. 8165 for the sake of the most vulnerable sectors of the society like children, women, senior citizens, and persons with disability. He then endorsed his complete sponsorship speech to the Secretariat.

REMARKS OF THE CHAIR

The Chair remarked that inasmuch as she wanted to hear the whole speech of Representative Salceda, she was more than happy to know about the latter's inspiration for filing the Bill.

INSERTION INTO THE RECORDS OF REPRESENTATIVE SALCEDA'S FULL SPONSORSHIP SPEECH

The Chair thereafter asked the Secretariat to insert into the records the full sponsorship speech of Representative Salceda.

At 4:16 p.m., the session resumed.

**BUSINESS FOR THE DAY:
COMMITTEE REPORT NO. 808
ON HOUSE BILL NO. 8014**

On motion of Representative Roa-Puno, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 8014 contained in Committee Report No. 808 as reported out by the Committees on Social Services, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT PROVIDING FOR THE MANDATORY PHILHEALTH COVERAGE OF ALL PERSONS WITH DISABILITY (PWD), AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7277, AS AMENDED, OTHERWISE KNOWN AS THE 'MAGNA CARTA FOR PERSONS WITH DISABILITY'.”

As copies of the Bill had been distributed to the Members, on motion of Representative Roa-Puno, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Roa-Puno, the Chair recognized Representative Batocabe, Vice Chairperson of the sponsoring Committee, to deliver his sponsorship speech.

**SPONSORSHIP SPEECH OF
REPRESENTATIVE BATOCABE**

After citing the United Nations facts and figures on persons with disabilities (PWDs) in the Philippines, Representative Batocabe stated that the pro-

vision of accessible health care to PWDs entails additional mechanisms to fully realize the government's vision to alleviate their conditions and ensure their inclusion in development.

As he urged his colleagues to immediately act on the Bill in order to help PWDs enjoy the entitlements enjoyed by senior citizens, Representative Batocabe said the Senate had already approved on Third Reading its version of the measure.

SUSPENSION OF SESSION

The Chair declared a recess at 4:21 p.m. upon Representative Roa-Puno's motion.

RESUMPTION OF SESSION

Upon resumption of session at 4:23 p.m., the Chair recognized Rep. Jose L. Atienza Jr. to interpellate Representative Batocabe.

**INTERPELLATION OF
REPRESENTATIVE ATIENZA**

Speaking in Filipino, Representative Atienza expressed support for House Bill No. 8014; informed the Sponsor that he prepared his own version thereof because PWDs needed to be given more in law; and said that Congress, if it is to help the needy and the poorest of the poor, should give special attention and provide vital medical assistance to the physically and mentally disadvantaged. He then asked for the Sponsor's assurance that the Bill will have funds available for its implementation and PWDs will not have to pay for anything else in order to enjoy the benefits under the measure.

Representative Batocabe guaranteed that the Philippine Health Insurance Corporation's (PhilHealth's) National Health Insurance Fund, which is automatically sourced from excise taxes on alcohol and tobacco, will be used to fund the Bill. He added that the House intended to provide automatic PhilHealth coverage to PWDs for free at no additional cost.

Representative Atienza urged his colleagues to correct mistakes in the past where social service programs subjected beneficiaries to certain conditions so that they could avail of the program benefits.

**ADDITIONAL COAUTHOR
OF HOUSE BILL NO. 8014**

Upon his request, the Body approved Representative Atienza's inclusion in House Bill No. 8014 as additional coauthor thereof.

QUERY FROM THE CHAIR

Upon the query of the Chair who stated that she was a Sponsor of the Excise Tax Law in the Senate, Representative Batocabe affirmed that the Bill was an additional earmarking under said law for the benefit of PWDs.

TERMINATION OF PERIOD OF SPONSORSHIP AND DEBATE

There being no more interpellations, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of sponsorship and debate; and thereafter proceeded to the period of amendments.

There being no Committee and individual amendments, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of amendments.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 8014

On motion of Representative Roa-Puno, there being no objection, the Body approved on Second Reading House Bill No. 8014.

ACKNOWLEDGMENT OF GUEST

At this point, Representative Roa-Puno acknowledged the presence in the Session Hall of the guest of Rep. Franz E. Alvarez.

On motion of Representative Roa-Puno, the Chair recognized Rep. Jose Christopher Y. Belmonte on a question of privilege.

QUESTION OF PRIVILEGE OF REPRESENTATIVE BELMONTE (J.C.)

Speaking out of fear as one of the four civilians who was granted amnesty by former President Benigno S. Aquino III, Representative Belmonte stated that Proclamation No. 572 published in the newspaper on September 4, 2018 was unconstitutional and a direct violation of the Constitution. This, as he noted how the Solicitor General in effect revoked the amnesty granted seven years ago to Senator Antonio F. Trillanes IV. He then explained the effects of the implementation of said Proclamation to Senator Trillanes, other officers, and enlisted personnel whose applications for amnesty were approved by the Department of National Defense including, among others, Rep. Gary C. Alejandro, officials who are presently working under the Duterte Administration, and those involved in the coup who refused amnesty.

He expressed fear that Proclamation No. 572 would indiscriminately be used as another tool of political persecution to silence those who oppose and criticize the present Administration. He stressed that amnesty offers a chance to return and be a better member of society and obliterates the supposed crime committed by the grantee unlike pardon which merely forgives the perpetrators.

At this juncture, Deputy Speaker Cayetano relinquished the Chair to Deputy Speaker Linabelle Ruth R. Villarica.

Thereafter, Representative Belmonte pointed out that the current trend in the country is to make issues to cover up bigger problems, but stressed that the problem on corruption never ceased. He expressed concern that people tend to forget the era of the dictatorship but he will never forget those times where too many of his countrymen had given their youth, poured blood, sweat, and life to counter its cause and allow normalcy to return. He maintained that he is afraid for himself but more afraid not only for his own children but for all Filipino children.

INTERPELLATION OF REPRESENTATIVE LAGMAN

On motion of Representative Roa-Puno, the Chair recognized Rep. Edcel C. Lagman who congratulated Representative Belmonte (J.C.) for denouncing the improvident and unlawful revocation of the amnesty granted to Senator Trillanes.

At this point, Deputy Speaker Villarica relinquished the Chair to Deputy Speaker Cayetano.

Representative Lagman then asked Representative Belmonte what prompted the President to issue Proclamation No. 572 and if there were any pending criminal cases in any regular court or military tribunal against Senator Trillanes in connection with the Oakwood Mutiny. Representative Belmonte replied that it has been known that Senator Trillanes has always been critical of the Duterte Administration and has stood up on many occasions questioning the President and his policies and actions, which could be the main reason for singling out the Senator. He also said that all cases filed against then Lt. Senior Grade Trillanes had been dismissed.

Representative Lagman then asked Representative Belmonte to coauthor House Resolution No. 2155, which he filed that day expressing the collective sentiment of Members of the House of Representatives denouncing the baseless, unlawful, and improvident revocation of the grant of amnesty to Senator Trillanes which Representative Belmonte gladly accepted.

REFERRAL OF THE SPEECH OF REPRESENTATIVE BELMONTE (J.C.)

On motion of Representative Roa-Puno, there being no objection, the Body referred Representative Belmonte's speech to the Committee on Rules for its appropriate action.
