BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 863 ON HOUSE BILL NO. 8244

On motion of Rep. Victoria Isabel G. Noel, there being no objection, the Body considered on Second Reading House Bill No. 8244 contained in Committee Report No. 863 as reported out by the Committee on Women and Gender Equality.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT EXPANDING THE DEFINITION OF SEXUAL HARASSMENT, STRENGTHENING THE MECHA-NISMS TO MONITOR COMPLIANCE WITH POLICIES AGAINST SEXUAL HARASSMENT IN THE WORKPLACE AND IN EDUCATIONAL AND TRAIN-ING INSTITUTIONS, AND PRESCRIB-ING PENALTIES FOR VIOLATIONS THEREOF, REPEALING FOR THE PUR-POSE REPUBLIC ACT NO. 7877, ALSO REFERRED TO AS THE 'ANTI-SEX-UAL HARASSMENT ACT OF 1995.""

As copies of the Bill had been distributed to the Members, on motion of Representative Noel, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Noel, the Chair recognized Rep. Bernadette "BH" Herrera-Dy, Chairperson of the Sponsoring Committee, to deliver her sponsorship remarks.

SPONSORSHIP REMARKS OF REPRESENTATIVE HERRERA-DY

Upon the request of Representative Herrera-Dy, the Explanatory Note of the Bill was considered as her sponsorship remarks on the measure.

SPONSORSHIP SPEECH OF REPRESENTATIVE DE JESUS

Recognized by the Chair on Representative Noel's motion, Rep. Emmi A. De Jesus expressed support to amend the existing Sexual Harassment Law with the instant Bill's consideration on Second Reading. She relayed how victims of sexual harassment had difficulty of getting justice while experiencing low morale and helplessness in the process, especially when the perpetrator is a person of higher authority than the victim.

Representative De Jesus then pointed out that the Bill covers incidents occurring even outside of the workplace and academic or training institution and provides for the creation of a Committee on Decorum and Investigation (CODI) that will receive and resolve complaints on sexual harassment. She expressed hope that the measure will be part of the 17th Congress' legacy of progressive laws on sexual harassment.

There being no Member who wished to interpellate, on motion of Representative Noel, there being no objection, the Body terminated the period of sponsorship and debate, and thereafter proceeded to the period of amendments.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 8282

On motion of Representative Noel, there being no objection, the Body approved House Bill No. 8282 on Second Reading through *viva voce* voting.

Thereafter, on motion of Representative Herrera-Dy, there being no objection, the Body considered on Second Reading House Bill No. 7849 contained in Committee Report No. 786 as reported out

by the Committees on Indigenous Cultural Communities and Indigenous Peoples, and Ways and Means

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE CIVIL REGIS-TRATION SYSTEM FOR INDIGENOUS PEOPLES."

As copies of the Bill had been distributed to the Members, on motion of Representative Herrera-Dy, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Noel, the Chair recognized Rep. Arlene D. Brosas, one of the principal authors of the Bill, for her sponsorship speech.

SPONSORSHIP REMARKS OF REPRESENTATIVE BROSAS

Representative Brosas said that the lack of sufficient demographic data about indigenous peoples (IPs) is due to the latter's natural aversion to registration owing to their culture and way of life. The government must protect the rights of IPs, she however stressed, and should identify them as bonafide citizens of the country who deserve to enjoy basic social services. She explained that House Bill No. 7849 will ensure that the State provides a free and cultural-sensitive civil registration system for IPs without making them lose their identity.

TERMINATION OF PERIOD OF SPONSORSHIP AND DEBATE

There being no Member who wished to interpellate the Sponsor, on motion of Representative Herrera-Dy, there being no objection, the Body terminated the period of sponsorship and debate, and thereafter proceeded to the period of amendments.

TERMINATION OF PERIOD OF AMENDMENTS

There being no Committee and individual amendments, on motion of Representative Herrera-Dy, there being no objection, the Body terminated the period of amendments.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 7849

On further motion of Representative Herrera-Dy, there being no objection, the Body approved House Bill No. 7849 on Second Reading through *viva voce* voting.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 765 ON HOUSE BILL NO. 7785

Thereafter, on motion of Representative Herrera-Dy, there being no objection, the Body considered on Second Reading House Bill No. 7785 contained in Committee Report No. 765 as reported out by the Committees on Basic Education and Culture, Appropriations, and Ways and Means.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT ESTABLISHING A FRAMEWORK FOR THE SELECTION OF NATIONAL PERFORMING ARTS COMPANIES, DESIGNATING FOR THE PURPOSE CERTAIN PERFORMING ARTS GEN-RES AND APPROPRIATING FUNDS THEREFOR."

As copies of the Bill had been distributed to the Members, on motion of Representative Herrera-Dy, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Herrera-Dy, the Chair recognized Deputy Speaker Evelina G. Escudero, one of the principal authors of the Bill, for her sponsorship remarks.

SPONSORSHIP REMARKS OF DEPUTY SPEAKER ESCUDERO

On motion of Deputy Speaker Escudero, duly seconded by Representative Herrera-Dy, there being no objection, the Body adopted the Explanatory Note of the Bill as her sponsorship remarks on the measure.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Recognized by the Chair upon motion of Representative Herrera-Dy, Rep. Jose L. Atienza Jr. agreed with the Bill's intentions for the country to

develop its own national performing arts companies. He subsequently discussed with Representative Escudero the definition of a national performing arts company and the qualifications, criteria, and track record of companies applying for subsidy from the government through the Bill at hand. He then proposed to include during the period of amendments a provision requiring the applicant to cite its track record in the field of performing arts.

He next clarified with the Sponsor the classification of groups; minimum number of members from each group; whether limited to a group or individual; and whether the qualified applicant has to be a member of the mentioned performing arts companies. During the period of amendments, he urged the Sponsor to consider proposals that would protect the intent of the law.

Representative Atienza vowed to support the measure as he stressed that this would be an opportunity to give all art forms an opportunity to develop, while appreciating folk arts presentations. He then recommended to include a provision in the measure that would help groups which showcase Filipino shows and teach people how to appreciate and enjoy the country's native dance and music.

In conclusion, Representative Atienza moved to temporarily set aside the measure, and manifested his intent to sit with the Sponsors and work out specific amendments on the Bill.

Thereafter, on motion of Representative Herrera-Dy, there being no objection, the Body considered on Second Reading House Bill No. 8110 contained in Committee Report No. 824 as reported out by the Committee on Overseas Workers Affairs.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT MANDATING THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA) TO DEVELOP, PUBLISH, DISSEMINATE AND UPDATE A HANDBOOK ON THE RIGHTS AND RESPONSIBILITIES OF MIGRANT WORKERS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 8042, OTHERWISE KNOWN AS THE 'MIGRANT WORKERS AND OVERSEAS FILIPINOS ACT OF 1995,' AS AMENDED BY REPUBLIC ACT NO. 10022."

As copies of the Bill had previously been distributed to the Members, on motion of Representative Herrera-Dy, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On subsequent motion of Representative Herrera-Dy, the Chair recognized Rep. Jesulito A. Manalo, Chairperson of the sponsoring Committee, to sponsor the measure.

SPONSORSHIP REMARKS OF REPRESENTATIVE MANALO

Representative Manalo said the measure requiring a handbook for all overseas Filipino workers (OFWs) shall provide a ready reference material for OFWs about their rights and responsibilities, and the labor and living conditions of their countries of destination.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 8110

Thereupon, on successive motions of Representative Herrera-Dy, there being no objection, the Body terminated the period of sponsorship and debate; terminated the period of amendments in the

absence of Committee and individual amendments; and approved on Second Reading House Bill No. 8110 through *viva voce* voting.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 837 ON HOUSE BILL NO. 1700

On further motion of Representative Herrera-Dy, there being no objection, the Body considered on Second Reading House Bill No. 1700 contained in Committee Report No. 837 as reported out by the Committee on Overseas Workers Affairs.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT GRANTING THE OVERSEAS FILIPINO WORKERS THE RIGHT TO EQUAL PROTECTION ON MONEY CLAIMS, AMENDING FOR THE PURPOSE THE FIFTH PARAGRAPH OF SECTION 10 OF REPUBLIC ACT NO. 8042, AS AMENDED BY REPUBLIC ACT NO. 10022."

As copies of the Bill had been distributed to the Members, on motion of Representative Herrera-Dy, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Herrera-Dy, the Chair recognized Representative Manalo for his sponsorship remarks.

SPONSORSHIP REMARKS OF REPRESENTATIVE MANALO

In line with the Supreme Court ruling in the case of *Serrano vs. Gallant Maritime Services and Marlow Navigation*, Representative Manalo stated that House Bill No. 1700 seeks to give more rights to the OFWs so that they will be paid the full unexpired portion of their salaries in case of unlawful termination. As such, he enjoined his colleagues to favorably consider the measure.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 1700

Whereupon, on successive motions of Representative Herrera-Dy, there being no objection, the Body terminated the period of sponsorship and debate; terminated the period of amendments in the

absence of Committee and individual amendments; and approved on Second Reading House Bill No. 1700 through *viva voce* voting.

SUSPENSION OF SESSION

The session was suspended at 4:44 p.m. upon motion of Representative Herrera-Dy.

RESUMPTION OF SESSION

The session resumed at 4:46 p.m. with Deputy Speaker Mercedes K. Alvarez presiding.

ACKNOWLEDGMENT OF GUESTS

Representative Herrera-Dy acknowledged the presence in the Session Hall of the guests of Reps. Leopoldo N. Bataoil and Christopher V.P. de Venecia.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 776 ON HOUSE BILL NO. 7820

Thereafter, on motion of Representative Herrera-Dy, there being no objection, the Body considered on Second Reading House Bill No. 7820 contained in Committee Report No. 776 as reported out by the Committees on Government Enterprises and Privatization, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT GRANTING SURVIVORSHIP BENEFITS TO THE DEPENDENT CHIL-DREN OF A DECEASED RETIRED MEMBER OF THE COMMISSION ON AUDIT, CIVIL SERVICE COMMISSION, COMMISSION ON ELECTIONS, AND THE OMBUDSMAN, WHO IS A SOLO PARENT. OR THE SURVIVING PAR-ENTS OR NOMINATED PERSONS OF SUCH DECEASED RETIREE, AMEND-ING FOR THE PURPOSE REPUBLIC ACT NO. 10084, ENTITLED, 'AN ACT GRANTING SURVIVORSHIP BENE-FITS TO THE SURVIVING LEGITI-MATE SPOUSE OF A DECEASED RE-TIRED MEMBER OF THE COMMIS-SION ON AUDIT, CIVIL SERVICE COMMISSION, COMMISSION ELECTIONS AND THE OMBUDSMAN, AND FOR OTHER PURPOSES.""

As copies of the Bill had been distributed to the Members, on motion of Representative Herrera-Dy, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Herrera-Dy, the Chair recognized Rep. Jesus Nonato Sacdalan, Chairperson of the Committee on Government Enterprises and Privatization, for his sponsorship remarks.

SPONSORSHIP REMARKS OF REPRESENTATIVE SACDALAN

Representative Sacdalan enjoined his colleagues to support and approve House Bill No. 7820.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 7820

Subsequently, on successive motions of Representative Herrera-Dy, there being no objection, the Body terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved on Second Reading House Bill No. 7820 through *viva voce* voting.

SUSPENSION OF SESSION

The session was suspended at 4:50 p.m. upon motion of Representative Herrera-Dy.

RESUMPTION OF SESSION

The session resumed at 4:56 p.m.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 850 ON HOUSE BILL NO. 8204

On successive motions of Representative Noel, there being no objection, the Body considered on Second Reading House Bill No. 8204 contained in Committee Report No. 850 as reported out by the Committee on Youth and Sports Development, redefining the crime of game-fixing and prescribing stiffer penalties therefor; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; adopted the Explanatory Note of the Bill as the sponsorship remarks on the measure, on motion of Rep. Enrico A. Pineda, one of the authors of the said measure; terminated

the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting.

SUSPENSION OF SESSION

Thereupon, the session was suspended at 4:59 p.m. upon motion of Representative Noel.

RESUMPTION OF SESSION

The session resumed at 5:03 p.m.

PRIVILEGE HOUR

With the unanimous consent of the House, on motion of Representative Noel, there being no objection, the Chair declared a Privilege Hour and thereafter recognized Representative Brosas for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

Representative Brosas took the floor to express Gabriela Party-List's support to Ms. Sheila Eballe's call to the stoppage of Apo Cemex Corporation's quarrying activities in Cebu, and hold Department of Environment and Natural Resources Secretary Roy A. Cimatu accountable for the death of 72 individuals.

She related that a week after Ms. Eballe's fearless stand during President Rodrigo Roa Duterte's visit in Apo Quarrying and Landslide Evacuation Center Chamber, she was forced to seek refuge as she was intimidated by the security personnel of APO Cemex Corporation. This, as she underscored how President Duterte joked at her and tagged her as a member of the New People's Army. She condemned the Administration's policies that put premium on capitalist greed and environment plunder; asked that the DENR and its Mines and Geosciences Bureau (MGB) both be held responsible for the mining and quarrying operations throughout the country; and sought justice for the survivors of the Apo quarrying landslide.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

On motion of Representative Herrera-Dy, there being no objection, the Body referred Representative Brosas' privilege speech to the Committee on Rules.

Thereafter, on motion of Representative Noel, the Chair recognized Representative Herrera-Dy to deliver her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE HERRERA-DY

In line with the October 11 celebration of the International Day of the Girl, Representative Herrera-Dy emphasized the unique needs and challenges of girls, promotion of their empowerment, and fulfillment of their human rights.

In particular, she spoke about child marriage and its negative impact on the girls' health and development, with the Philippines ranking number 12 among the countries with the highest number of child marriages. She however emphasized that child marriage can be prevented, and cited the recommendations of the World Health Organization (WHO) to address this concern. With all legal systems harmonized, she stressed the need for a national law explicitly prohibiting child marriage and providing programs and services for its prevention and response, and enjoined her colleagues to create spaces for girls to grow as empowered women.

On motion of Representative Noel, the Chair recognized Representative Atienza.

MOTION OF REPRESENTATIVE ATIENZA

Representative Atienza stressed that Representative Herrera-Dy had delivered a meaningful speech, but that there were not enough Members on the floor, and moved for the adjournment of session.

SUSPENSION OF SESSION

The Chair *motu proprio* suspended the session at 5:18 p.m.

RESUMPTION OF SESSION

The session resumed at 5:25 p.m.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE HERRERA-DY

On motion of Representative Noel, there being no objection, the Body referred the privilege speech of Representative Herrera-Dy to the Committee on Rules.

SUSPENSION OF THE PRIVILEGE HOUR

On motion of Representative Noel, there being no objection, the Body suspended the Privilege Hour.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 891 ON HOUSE BILL NO. 8400

On motion of Representative Noel, there being no objection, the Body considered on Second Reading House Bill No. 8400 contained in Committee Report No. 891 as reported out by the Committee on Ways and Means.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT ESTABLISHING THE FISCAL RE-GIME FOR THE MINING INDUSTRY."

As copies of the Bill had been distributed to the Members, on motion of Representative Noel, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Noel, the Chair recognized Rep. Estrellita B. Suansing, Chairperson of the sponsoring Committee, to sponsor the measure.

SPONSORSHIP SPEECH OF REPRESENTATIVE SUANSING (E.)

Initially citing data on the contribution of the mining industry to the government's coffers in terms of collected taxes, fees and royalties, Representative Suansing then stressed that the proposed measure would 1) provide equitable fiscal responsibility to both large and small scale mining by imposing additional taxes, royalties, and margin-based tax on windfall profit; 2) ensure additional revenue and safety net for the government as owner of mineral wealth; and 3) exempt mining companies from the application of the confidentiality clauses of the amended National Internal Revenue Code of 1997.

Representative Suansing subsequently urged her colleagues to support the instant Bill's immediate passage into law.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 8400

Thereupon, on motion of Representative Noel, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 8400.

ADOPTION OF HOUSE RESOLUTION NO. 2214

On motion of Representative Noel, there being no objection, the Body considered House Resolution No. 2214, entitled: "RESOLUTION EXPRESSING THE PROFOUND CONDOLENCES OF THE HOUSE OF REPRESENTATIVES TO THE FAMILY OF CIRIACO "ACOY" S. CALALANG, KABAYAN PARTY-LIST REPRESENTATIVE DURING THE SEVENTEENTH CONGRESS"; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; and unanimously adopted the same in consolidation with House Resolutions No. 2195, 2916, and 2203.

RESUMPTION OF THE PRIVILEGE HOUR

On successive motions of Representative Noel, there being no objection, the Body resumed the Privilege Hour; and the Chair thereafter recognized Rep. Gary C. Alejano for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ALEJANO

Representative Alejano's speech focused on the enactment of Republic Act (R.A.) No. 8423, also called the Traditional and Alternative Medicine Act (TAMA), and government efforts and policies to strengthen, promote, develop and integrate into the national health care delivery system the country's traditional and alternative medicine.

Speaking on the recent Food and Drug Administration's (FDA) activity to shut down the Dr. Farrah Agustin-Bunch Natural Medical Center in Victoria, Tarlac, Representative Alejano subsequently mentioned Dr. Agustin-Bunch's academic and professional background and founding of her medical facility.

After informing the Body of the popularity and professional achievements of Dr. Agustin-Bunch's center in and outside of the Philippines, Representa-

tive Alejano related the events surrounding the filing of cases for alleged misconduct against Dr. Agustin-Bunch in the DOH and the FDA. He then related the events surrounding the closure of Dr. Agustin-Bunch's facility and confiscation of her products despite her having complied with the FDA's requirement.

Thereupon, Representative Alejano emphasized that Dr. Agustin-Bunch had been deprived of her right to due process and right to practice her profession and to earn a living; while the public had been denied the right to patronize medical doctors such as Dr. Agustin-Bunch and avail of alternative medicines and treatments. In this regard, he urged the appropriate committee to review the implementation of the TAMA or R.A. No. 8423.

INTERPELLATION OF REPRESENTATIVE BRAVO (A.)

On motion of Rep. Wilter "Sharky" Wee Palma II, the Chair recognized Rep. Anthony M. Bravo, PhD, who first stressed the vital support that the government had been giving alternative medicine in China, after which he and Representative Alejano discussed why Dr. Agustin-Bunch's facility was closed down despite its not being a hospital and its not having a drug pharmacy. Representative Alejano surmised that the closure was due to a technical issue of not submitting a document within the prescribed time to the FDA.

Representative Bravo then expressed his support to the conduct of a congressional investigation on the matter.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ALEJANO

On motion of Representative Palma, there being no objection, the Body referred the privilege speech of Representative Alejano and the interpellation thereon to the Committee on Rules.

Thereafter, on motion of Representative Palma, the Chair recognized Rep. Xavier Jesus D. Romualdo for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ROMUALDO

At the outset, Representative Romualdo stated that Presidential Decree 603 was issued to give due importance to the children and created a policy-making body called the Council for the Welfare of

Children (CWC) tasked to ensure that every child enjoys his or her rights. He cited the composition of the CWC Board and mentioned stories on the struggles faced by children who are victims of sexual abuse, without parents to care for them, affected by drugs, and victims of natural and man-made disasters.

In answer to the call for support and action, he said that the 17th Congress had included the rights of children in its Priority Executive-Legislative Agenda and that several laws had been enacted to respond to their plight in accordance with the provisions of the United Nations Convention on the Rights of the Child; and cited the various interagency bodies that deal with the implementation of laws thereon.

Representative Romualdo thereafter proposed to create an agency that would focus on policy formulation and implementation of programs and services for the children and appealed to the President to certify as urgent the enactment of the Bill creating the Philippine Commission on Children.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ROMUALDO

On motion of Representative Palma, there being no objection, the Body referred the privilege speech of Representative Romualdo to the Committee on Rules; and on his further motion, the Chair recognized Rep. Sarah Jane I. Elago for her privilege speech.

MANIFESTATION OF REPRESENTATIVE ELAGO

Thereupon, Representative Elago requested that the privilege speech which she was supposed to deliver the previous day in the presence of student leaders from various schools and officials of Sangguniang Kabataan, be inserted into the records of the House.

PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

Whereupon, Representative Elago read an excerpt from the unity statement of Southern Tagalog Youth and Faculty condemning the "Red October" conspiracy attacks on universities, which was signed by over a hundred organizations and institutions of youth leaders, parliamentarians, journalists, cultural workers, faculty, and academic employees across Southern Luzon.

She thereafter read the manifesto which, among others: (1) deemed as absurd and outrageous the allegation of the military about universities that allow their students to exercise their right to academic freedom, as recruitment grounds for any political armed group; (2) likened the conspiracy attack of the government as reminiscent of the grim days of martial law, where educational discussions were suppressed and youths were tagged as subversives or communists for the sake of political persecution; (3) called on the military to uphold its role to serve and protect, and urged other students, professors, and academicians to stand with them in their fight against political persecution; (4) pledged to uphold and protect academic freedom and various forms of expression; and (5) stressed that no fear-mongering will stop the ranks of the students from standing for what is right, just, and democratic.

Thereafter, Representative Elago thanked her colleagues who had provided support for student campaigns to defend their universities and colleges and promote academic freedom.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

On motion of Representative Palma, there being no objection, the Body referred Representative Elago's privilege speech to the Committee on Rules.

TERMINATION OF THE PRIVILEGE HOUR

There being no other Member who wished to avail of the Privilege Hour, on further motion of Representative Palma, there being no objection, the Body terminated the Privilege Hour.

ADJOURNMENT OF SESSION

Thereafter, on motion of Representative Palma, there being no objection, the Chair declared the session adjourned until three o'clock in the afternoon of Wednesday, October 10, 2018.
