# JOURNAL NO. 30 Monday, November 19, 2018

#### **CALL TO ORDER**

At 3:00 p.m., Deputy Speaker Prospero A. Pichay Jr. called the session to order.

#### NATIONAL ANTHEM AND PRAYER

Pursuant to Section 73, Rule XI of the amended Provisional Rules of the House, the Virlanie Voices led the singing of the National Anthem and thereafter delivered the doxology.

#### DEFERMENT OF ROLL CALL

Thereupon, on motion of Rep. Rodante D. Marcoleta, there being no objection, the Body deferred the calling of the Roll.

#### APPROVAL OF JOURNAL NO. 29

On motion of Representative Marcoleta, there being no objection, the Body approved Journal No. 29 dated November 14, 2018.

# SUSPENSION OF SESSION

On motion of Representative Marcoleta, the Chair suspended the session at 3:05 p.m.

#### RESUMPTION OF SESSION

The Chair resumed the session at 3:09 p.m.

# UNFINISHED BUSINESS: COMMITTEE REPORT NO. 389 ON HOUSE BILL NO. 6425

On motion of Representative Marcoleta, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6425 contained in Committee Report No. 389 as reported out by the Committees on Transportation, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

"AN ACT PRESCRIBING AN URGENT, COMPREHENSIVE AND INTEGRATED LAND-BASED TRAFFIC MANAGE-MENT POLICY TO EFFECTIVELY AD-DRESS THE TRAFFIC CONGESTION CRISIS IN METRO MANILA, METRO-POLITAN CEBU AND METROPOLI-TAN DAVAO AND APPROPRIATING FUNDS THEREFOR."

Representative Marcoleta stated that the parliamentary status was that the Bill was in the period of sponsorship and debate and on his further motion, the Chair recognized Rep. Cesar V. Sarmiento, Chairperson of the sponsoring Committee, who stated that he was ready to answer interpellations.

#### SUSPENSION OF SESSION

The Chair suspended the session at 3:12 p.m. upon Representative Marcoleta's motion.

#### RESUMPTION OF SESSION

At 3:13 p.m., the session resumed.

On motion of Representative Marcoleta, the Chair recognized Rep. Edcel C. Lagman for his interpellation.

# INTERPELLATION OF REPRESENTATIVE LAGMAN

Representative Lagman initially sought confirmation on the global extent of the issue of traffic gridlock and presented data and figures on traffic index on congestion in various cities around the world including Manila.

#### SUSPENSION OF SESSION

On motion of Representative Sarmiento (C.), the Chair declared a recess at 3:20 p.m.

#### RESUMPTION OF SESSION

At 3:22 p.m., the session resumed.

# INTERPELLATION OF REPRESENTATIVE LAGMAN

(Continuation)

Then responding to his colleague's succeeding questions, Representative Sarmiento (C.) explained various schemes adopted by other countries to address their traffic problem without resorting to the grant of emergency powers; and the provisions of the Bill that include such schemes as biking and traffic flow systems.

At this point, Representative Lagman emphasized that billions' worth of economic opportunities are lost due to traffic congestion. Congratulating the Chamber for pursuing the instant Bill despite the President's renouncement of the traffic problem in Metro Manila, he next inquired about the duration of said measure.

Representatives Sarmiento and Lagman then discussed the gestation period of so-called priority projects; whether a law is needed for the acquisition or procurement of traffic equipment and computers; and whether these priority projects involve infrastructure projects. Representative Lagman suggested that at the proper time, they should be able to introduce amendments to provide for the standards prescribed by Congress under which projects shall qualify as priority.

They next tackled the causes of horrendous traffic problems and whether a law is needed to address the problems of narrow roads and highways and the excessive volume of motor vehicles on the road; the bus terminals and malls abating the highways; and whether the Bill includes a provision addressing the relocation of bus terminals.

Subsequently, Representative Lagman asked the Sponsor about the following issues: 1) whether bus terminals along EDSA are considered as public nuisance; 2) if by definition of nuisance per se, bus terminals can be abated summarily; 3) inadequate mass transport system and infrastructure as another cause of traffic problem; 4) if there was an enabling statute or law authorizing the construction and operation of a subway system; 5) lack of discipline among Filipino drivers and pedestrians; 6) need for a law to increase the insurance premium of delinquent drivers; and 7) how the opening up of prominent subdivision private roads to traffic or the so-called friendship routes can be undertaken.

#### REMINDER FROM THE CHAIR

At this point, the Chair reminded Representative Lagman that he had already exceeded the time allotted to him under the Rules and requested him to wind up with his interpellation.

# MANIFESTATION OF REPRESENTATIVE LAGMAN

Representative Lagman said that at the proper time, the Body should amend the aforecited rule because the one-hour period included the answer of the Sponsor and not only the questions of the interpellator. He stated that he would propound more questions on the second round.

The Chair took note of Representative Lagman's manifestation.

With 202 Members responding to the Call, the Chair declared the presence of a quorum. (See Appendix)

#### SUSPENSION OF SESSION

On motion of Representative Marcoleta, the session was suspended at 4:33 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 4:40 p.m.

Thereafter, on motion of Representative Marcoleta, the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

#### REMARKS OF THE CHAIR

At this point, the Chair reminded Representative Atienza that it was his second round of questioning and gave the latter 30 minutes for his interpellation.

Representative Atienza stated that he merely gave way then to the other Members who wanted to interpellate and requested the Body not to limit his time as he was the last interpellator that day and that he would try his best to ask relevant questions.

The Chair stated that Representative Atienza would be able to ask relevant and intelligent questions within 30 minutes.

# INTERPELLATION OF REPRESENTATIVE ATIENZA

Proceeding with his interpellation, Representative Atienza discussed with Representative Sarmiento (C.) the purpose of the instant measure in relation to granting emergency powers to the President to address the traffic problem; and the root causes of the traffic problem in Metro Manila. He requested the Sponsor to see clearly the traffic conditions in the streets such as the illegal bus terminals, before pursuing the approval of the measure and emphasized that incompetence, mismanagement, rampant corruption in the streets, and proper implementation of the traffic laws are the primary problems that need to be addressed.

Representative Atienza then cited how Singapore solved its traffic problem by putting to jail corrupt traffic enforcers and asked why the country cannot do the same when it has a President who declared he would act immediately upon hearing even just a whiff of corruption.

In reply, Representative Sarmiento narrated the case of then Metro Manila Development Authority (MMDA) Chairperson Bayani Fernando whose attempt to order the closure of a bus terminal fired back at him when a case filed against him was acted upon favorably by the Supreme Court. Representative Atienza steered back the discussion to the issue of illegal parking of buses along the main highways of Metro Manila which he said is a reflection that

traffic enforcers are not doing their jobs. He suggested that the solution to the traffic problem is an urgent, comprehensive and integrated plan; otherwise, the passage of the instant Bill would only encourage rampant bribery in the streets.

Representative Atienza rounded up his points by saying that enforcement of the law is the solution to the traffic problems besetting Metro Manila and not the Bill at hand. He then stressed that emergency powers are not needed because they would only violate the rights of law-abiding citizens. He expressed concern about the worsening traffic condition which was aggravated by corruption of local government officials and law enforcers, to the detriment of law-abiding citizens; criticized the government especially the MMDA for its lack of response and action to solve the traffic problem; and urged his colleagues to defer the consideration of the measure at hand.

#### REMARKS OF THE CHAIR

Inquiring about Congress' declaration of a state of emergency as far as traffic is concerned, the Chair remarked that in the absence of a national emergency, certain functions of the Chief of Traffic like suspension and takeover of franchises cannot be considered legitimate.

# SUSPENSION OF SESSION

On motion of Representative Sarmiento (C.), the Chair suspended the session at 5:06 p.m.

### RESUMPTION OF SESSION

The Chair resumed the session at 5:09 p.m.

# INTERPELLATION OF REPRESENTATIVE ATIENZA

(Continuation)

Recognized anew by the Chair on motion of Representative Marcoleta, Representative Atienza enjoined his colleagues to go around the metropolis to see for themselves the actual traffic situation and gather as much data on the traffic problem before approving the instant Bill.

# SUSPENSION OF CONSIDERATION OF HOUSE BILL NO. 6425

On motion of Representative Marcoleta, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 6425.

# RATIFICATION OF CONFERENCE COMMITTEE REPORT ON HOUSE BILL NO. 4113 AND SENATE BILL NO. 1305

On successive motions of Representative Marcoleta, there being no objection, the Body considered and subsequently ratified the Conference Committee Report on the disagreeing provisions of House Bill No. 4113 and Senate Bill No. 1305, increasing the maternity leave period for female workers in the government service and in the private sector.

# DESIGNATION OF HOUSE CONFEREES ON HOUSE BILL NO. 7735 AND SENATE BILL NO. 1998

On further motion of Representative Marcoleta, there being no objection, the Body designated the following Members as House conferees to reconcile the disagreeing provisions of House Bill No. 7735 and Senate Bill No. 1998, replacing the quantitative import restrictions on rice with tariffs: Reps. Jose T. Panganiban Jr., CPA, LLB, Arthur C. Yap, Sharon S. Garin, Peter "Sr. Pedro" M. Unabia, Micaela S. Violago, Victor A. Yap, Lagman, Michael L. Romero, PhD, and Orestes T. Salon.

# CHANGE OF REFERRAL OF HOUSE MEASURES

On another motion of Representative Marcoleta, there being no objection, the Body changed the referral of the following measures to the Committees specified hereunder:

- 1. House Joint Resolution No. 30 from the Committee on Appropriations to the Committee on Rules:
- 2. Senate Bill No. 1898 from the Committee on Local Government to the Committee on Public Order and Safety; and
- 3. Senate Bill No. 1306 from the Committee on Youth and Sports Development to the Committee on Games and Amusements.

# RECOMMITMENT OF HOUSE RESOLUTION NO. 1645

As requested by Representative Belaro, author of the measure, on motion of Representative Marcoleta, there being no objection, the Body approved to recommit House Resolution No. 1645 as contained in Committee Report No. 595, to the Committee on Higher and Technical Education.

#### ACKNOWLEDGMENT OF GUESTS

At this point, Representative Marcoleta acknowledged the presence in the Session Hall of guests of Rep. Doy C. Leachon.

# MANIFESTATION OF MAJORITY LEADER ANDAYA

Upon recognition by the Chair, Majority Leader Rolando G. Andaya Jr. informed the Body of the following:

- 1. the receipt by the House of Representatives of a communication from Ms. Catalina Leonen-Pizarro, president of ABS Party-List, informing the House that said Party-List approved a board resolution expelling Atty. Eugene Michael B. De Vera as a member of said Party-List, removing him as its Party-List Representative in the House and naming Mr. Ulysses G. Garces, its second nominee, as its Representative to replace Attorney De Vera;
- 2. his referral of said letter to the Commission on Elections (Comelec); and
- 3. the Houses's receipt of Comelec *En Banc* Resolution No. 18-0842 directing its law department to reply to Ms. Catalina Leonen-Pizarro and to him, in the matter of the expulsion of Representative De Vera from ABS Party-List.

Subsequently, Majority Leader Andaya said that the aforecited Comelec resolution states pertinently that Representative De Vera, being a Member of the House of Representatives, is within its jurisdiction and covered by its rules and regulations.

He added that in compliance with the directive of the Comelec *en banc*, the Comelec Law Department through Director Maria Norina S. Tangaro-Casingal (1) informed the Speaker, through him, that the Comelec *en banc* proclaimed the ABS Party-List as the winner in the May 9, 2016 elections to entitle its first nominee to sit as Representative in the House of Representatives; and (2) attached the certificates of proclamation, nomination, and acceptance of the nominees of said Party-List.

In view of the foregoing, Majority Leader Andaya requested that the Secretary General be instructed to drop Representative De Vera's name from the Roll of Members of the House of Representatives, and allow the nominee next in line of the ABS Party-List, the Honorable Ulysses G. Garces,

to take his oath as the ABS Party-List Member of the House, pursuant to the certificates of nomination and acceptance of said Party-List on the decision as forwarded by the Comelec Law Department.

# POINT OF ORDER OF REPRESENTATIVE TY

Recognized by the Chair, Rep. Arnel U. Ty cited Section 17, Article VI of the Constitution which he read into the records. He asked on the status of the case filed against Representative De Vera in the House of Representatives Electoral Tribunal (HRET); and concluded that the House will be violating the provisions of the Constitution if the HRET had not yet rendered a decision thereon.

# REMARKS OF MAJORITY LEADER ANDAYA

Majority Leader Andaya said that he was not part of the case in the HRET and that he was merely in possession of a letter from the Comelec to drop Representative De Vera's name from the list of House Members. He clarified that his manifestation was not in the nature of a motion which will be voted upon, but of a request that Representative De Vera's name be dropped from the rolls.

#### REMARKS OF THE CHAIR

At this point, the Chair directed the Secretary General to drop Representative De Vera's name from the Roll of Members.

# MANIFESTATION OF REPRESENTATIVE DE VERA

Recognized by the Chair, Representative De Vera read into the records Section 4, Rule II of the amended Provisional Rules of the 17th Congress, which provides that in cases where a candidate has been proclaimed winner by the Comelec and the validity of the proclamation is put in question in any judicial or administrative body, such candidate who has been proclaimed winner and assumed office on June 30 following the election shall remain a Member of the House absent a final and executory judgement on or resolution of the question over the proclamation of the Member by the appropriate judicial or administrative bodies. He stressed that he has a pending case in the HRET-Case No. 16-31which was filed against him by Ms. Catalina Leonen-Pizarro and that he already submitted an answer thereto.

Representative De Vera also read into the records Section 17, Article VI of the 1987 Constitution,

which provides for an Electoral Tribunal which shall be the sole judge of all contests relating to the election, returns, and qualifications of the respective Members of the Senate and the House. He said that he mentioned this provision in his October 2, 2018 letter to the House leadership, which included Majority Leader Andaya; and stressed that he was still a sitting Member of the Chamber; the HRET had jurisdiction over his case as it was his bona fide membership in the ABS Party-List that was being questioned; a mere letter could not be the basis for unseating him; and the House could first wait for the results of the HRET's hearings on his case.

Representative De Vera further read into the records Section 9 of Republic Act No. 7941 or the Party-List System Act, which enumerates the qualifications of Party-List nominees including a bona fide membership of the party or organization which he seeks to represent for at least 90 days preceding the day of the election. He reiterated that his case falls under the ambit of the HRET because his bona fide membership in the ABS Party-List was the issue; and that he had already filed his answer to the petition filed against him.

# REMARKS OF MAJORITY LEADER ANDAYA

Majority Leader Andaya clarified that although it was not of his personal liking, he had to request that Representative De Vera's name be dropped from the rolls and that the same was a ministerial duty.

### OBJECTION OF REPRESENTATIVE DE VERA

Representative De Vera manifested his objection thereto.

#### REMARKS OF THE CHAIR

At this point, the Chair once again directed the Secretary General to follow the request of the Majority Leader to drop Representative De Vera's name from the Roll of Members.

#### SUSPENSION OF SESSION

At 5:29 p.m., the Chair *motu proprio* suspended the session.

#### RESUMPTION OF SESSION

The session resumed at 5:40 p.m.

#### ADJOURNMENT OF SESSION

On motion of Representative Marcoleta, there being no objection, the Chair declared the session adjourned until three o'clock in the afternoon of Tuesday, November 20, 2018.
