ACKNOWLEDGMENT OF GUESTS

At this juncture, Representative Ty acknowledged the presence in the Session Hall of guests of Reps. Francisco G. Datol Jr., Mohamad Khalid Q. Dimaporo, Ruby M. Sahali, Jose L. Atienza Jr., and Tom S. Villarín.

THE PRIVILEGE HOUR

It being a Monday, on motion of Representative Ty, there being no objection, the Chair declared a Privilege Hour.

On further motion of Representative Ty, the Chair recognized Representative Datol to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DATOL

Representative Datol initially adverted to the celebration of the Elderly Filipino Week in honor of some 10.5 million senior citizens in the country; and recalled the creation of the Senior Citizens Party-List in 2003 and stressed its intention to unify various organizations of senior citizens.

He subsequently discussed a bill that he filed seeking to create the National Senior Citizens Commission in order to monitor the implementation of Republic Act (R.A.) No. 7432, as amended by the Expanded Senior Citizens Acts of 2003 and 2010. He pointed out that existing laws do not fully serve and protect the needs of senior citizens and the aforesaid measures seek to address these flaws. He explained that the proposed Commission would get its funds from the one-percent appropriation for senior citizens of the budgets of different government agencies, without need of securing allocations from the national budget.

Thereafter, he enjoined his colleagues to support the measure that would give additional monetary and health benefits as well as incentives and recognition to senior citizens. He also informed the Body of several activities lined up in commemoration of the week dedicated to senior citizens. Finally, he expressed his gratitude to President Rodrigo Roa Duterte, Speaker Pantaleon D. Alvarez and his deputy speakers, Majority Leader Rodolfo C. Fariñas, and all his colleagues.

On motion of Representative Ty, the Chair recognized Representative Atienza for his interpellation.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Representative Atienza proposed to change the age requirement for the grant of a ₱100,000-cash gift from 100 to 90 years old, and to increase the senior citizens' discount on airfare to 50 percent. Representative Datol agreed with him that they needed to address the plight of senior citizens, protect their rights, and recognize their value to society.

REMARKS OF REPRESENTATIVE SALO

Rep. Ron P. Salo joined Representative Atienza in congratulating Representative Dalog for standing up for the welfare of the country's senior citizens.

REFERRAL OF REPRESENTATIVE DATOL'S PRIVILEGE SPEECH

Thereupon, on motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Datol, together with the interpellation thereon, to the Committee on Rules.

ACKNOWLEDGMENT OF GUESTS

At this point, Representative Salo acknowledged the presence in the Session Hall of guests of Rep. Juan Pablo "Rimpy" P. Bondoc.

MANIFESTATION OF REPRESENTATIVE TURABIN-HATAMAN

At this point, Rep. Sitti Djalila A. Turabin-Hataman manifested her intent to rise on a question of personal and collective privilege.

SUSPENSION OF THE PRIVILEGE HOUR

Thereafter, on motion of Representative Bondoc, there being no objection, the Body suspended the Privilege Hour and the Chair recognized Representative Turabin-Hataman on a question of privilege.

QUESTION OF PRIVILEGE OF REPRESENTATIVE TURABIN-HATAMAN

Representative Turabin-Hataman expressed gratitude for the opportunity to represent the Anak Mindanao (AMIN) Party-List in the Sixteenth and Seventeenth Congresses. She informed the Body that she was entrusting the advocacies of her party to their second nominee, the incumbent Rep. Makmod Mending Jr., as well as yielding her position to their third nominee, Ms. Amihilda Sangcopan, in order to resume her community work in Mindanao. She expressed hope that her party-mates will continue to promote their priority measures such as the bill against discrimination on account of ethnicity and religious belief and the Islamic Banking Bill.

Representative Turabin-Hataman stated that her decision was based on the need to be one with her people and break the barrier of a title or position; and on the war in Marawi City and reports that teenagers had joined the rebels therein.

Thereupon, she appealed to the President to hasten the passing of the Bangsamoro Basic Law (BBL) which she had coauthored and prayed for courage, strength, and guidance for the House of Representatives as a pillar of democracy.

MANIFESTATION OF REPRESENTATIVE BAG-AO

On motion of Representative Salo, the Chair then recognized Rep. Kaka J. Bag-ao who praised Representative Turabin-Hataman for advancing the

BBL and supporting the LGBT community. She underscored the void that her colleague was leaving behind and expressed support for her other advocacies.

REFERRAL OF REPRESENTATIVE TURABIN-HATAMAN'S SPEECH

Thereupon, on motion of Representative Salo, there being no objection, the Body referred the speech of Representative Turabin-Hataman to the Committee on Rules.

RESUMPTION OF THE PRIVILEGE HOUR

On successive motions of Representative Salo, there being no objection, the Body resumed the Privilege Hour; and the Chair recognized Representative Dimaporo (M.K.) for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DIMAPORO (M.K.)

After acknowledging the House leadership's filing of House Bill No. 6475 or the Bangsamoro Transition Commission's version of the BBL, Representative Dimaporo focused on the National Commission on Muslim Filipinos (NCMF) which was not able to adequately present and defend its budget during the budget deliberations in the House. He informed the Body that he had filed a resolution directing the Commission on Audit to provide the Committee on Muslim Affairs with a report on how the NCMF used its savings from 2011 to 2016; and discussed the law that created the Commission as well as the objectives of its seven bureaus.

After expressing disappointment over the unsatisfactory performance of the NCMF and the unprofessionalism of its officials, Representative Dimaporo suggested the re-evaluation of the Commission and possible amendment of the law that created it. He also sought support for a resolution that he filed on the Hajj pilgrimage trust fund which the NCMF had allegedly made money from. Likewise, he appealed for the strengthening of the NCMF as an institution to enable it to faithfully represent Muslim Filipinos.

REFERRAL OF REPRESENTATIVE DIMAPORO'S (M.K.) PRIVILEGE SPEECH

On motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Dimaporo to the Committee on Rules.

The Chair subsequently recognized Representative Villarín for his privilege speech upon Representative Salo's motion.

PRIVILEGE SPEECH OF REPRESENTATIVE VILLARIN

Stating that poverty was a complex problem that went beyond economic development and transcended all administrations, Representative Villarín posited that it could be defeated, along with its accompanying problems like malnutrition, drug abuse, and deterioration of family, by reinforcing the social protection system.

Thereupon, he called on the House and the Executive Department to join hands to improve the lives of the poor and change the disturbing trend of poverty. He focused on the Department of Social Welfare and Development's Conditional Cash Transfer (CCT) Program; and proposed the following in order to strengthen it: (1) make regular adjustments in the Program to account for inflation; (2) improve access to and availability of school and health facilities; (3) tighten coordination among all implementing agencies; and (4) nurture an open environment for all social protection measures such as CCT.

On motion of Representative Salo, the Chair subsequently recognized Rep. Edcel C. Lagman for his interpellation.

INTERPELLATION OF REPRESENTATIVE LAGMAN

Representatives Lagman and Villarín first agreed that the lack of health facilities and equipment especially at the community or barangay level hinders the significance of social protection programs such as the CCT Program and priority should be given to reengineering its design. They discussed the major causes of poverty, namely, a high population growth rate compounded by a low contraceptive prevalence rate and high incidences of teenage pregnancy and maternal morbidity; poor human capacity development; and health disabilities especially in the labor sector. They examined the poverty incidence rate including statistics on self-rated poverty, especially in Mindanao.

Thereupon, Representative Lagman said he would wait for the final form of the proposed Tax Reform for Acceleration and Inclusion (TRAIN) Act to assess what social protection measure was included in the Senate version. He then asked why the poor has to be burdened with increases in excise

taxes like in liquefied petroleum gas (LPG), kerosene and other goods; and then give them unconditional cash transfer benefits under the House version of the proposed TRAIN Act whose implementation could be a bureaucratic nightmare. He also queried if his colleague would agree that the Duterte Administration is not consistent with its policies to address, alleviate or solve the poverty problem because for him there were certain policies which demonizes the poor, like increases in excise taxes that would seriously affect the disadvantaged and the marginalized.

At this juncture, Deputy Speaker Villarica relinquished the Chair to Rep. Arthur R. Defensor Jr.

REFERRAL OF REPRESENTATIVE VILLARIN'S PRIVILEGE SPEECH

Thereupon, on motion of Rep. Jose Enrique "Joet" S. Garcia III, there being no objection, the Body referred the privilege speech of Representative Villarain, including the interpellation thereon, to the Committee on Rules.

Likewise, on motion of Representative Garcia, the Chair recognized Rep. France L. Castro for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE CASTRO (F.L.)

Representative Castro spoke about the commemoration on October 5, 2017 or the International Teachers' Day of the adoption of the Recommendation Concerning the Status of Teachers in 1966, by the International Labor Organization (ILO) and the United Nations Educational, Scientific and Cultural Organization (UNESCO). Speaking in Filipino, she said this was a historical document as it contained international standards on living wages and benefits; humanitarian conditions in the workplace; and participation of the teachers in the formulation and implementation of policies and laws affecting the teaching profession.

At this point, Representative Defensor relinquished the Chair to Deputy Speaker Villarica.

Representative Castro thereafter said that after more than one year, the President has failed to honor his promises to give salary increases for the teachers, that contractualization still remains, income tax is still high, the Department of Education's (DepEd) anti-teacher policies continue to work, and the condition of teachers in private schools worsens. She said come October 5, an extensive and national protest to call and fight for the salary increase and other

economic and political demands of education will be facilitated by teachers as it was in this context that they plan to commemorate the National Teachers' Day. She believed that any congratulations are useless without the realization of the government in the essence and direction of the 1966 ILO/UNESCO Recommendation. She concluded her speech by batting for an increase in the salary of teachers, objecting to new excise taxes and expanded VAT, and appealing to stop the killings of youth and to lift martial law in Mindanao.

On motion of Representative Garcia (J.E.), the Chair recognized Rep. Rosanna "Ria" Vergara for her manifestation.

MANIFESTATION OF REPRESENTATIVE VERGARA

Representative Vergara said that while she understood the frustrations of teachers and that the coming commemoration of International Teachers' Day on October 5 will be a forum for them to express their dissatisfaction, she asked her colleague to at least give their support to President Duterte on the hard work that he had been doing for the country. She said the problems beseeching the country were myriad and complex, such as global warming, climate change, war on drugs, extrajudicial killings (EJKs), and it would be counterproductive for the teachers to stage a rally while there are still many sectors that needed more help and attention from the President.

REFERRAL OF REPRESENTATIVE CASTRO'S (F.L.) PRIVILEGE SPEECH

On motion of Representative Garcia (J.E.), there being no objection, the Body referred Representative Castro's privilege speech to the Committee on Rules.

On further motion of Representative Garcia, the Chair recognized Rep. Manuel Monsour T. Del Rosario III to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DEL ROSARIO

Representative Del Rosario adverted to the recent 2017 Asian Indoor and Martial Arts Games (AIMAG) held in Ashgabat, Turkmenistan where he was appointed by the Philippine Olympic Committee as *Chef de Mission* and where 6,000 athletes from 62 nations competed in 21 top-level sporting events. He stressed that Team Philippines won two gold, 14 silver, and 14 bronze medals therein, thus enabling it to garner 19th place in the competition.

He thanked Speaker Pantaleon D. Alvarez, other government officials, and various sponsors who supported Team Philippines; and requested that all the winners and their coaches be invited to the House to be accorded proper recognition.

Thereafter, on motion of Representative Garcia (J.E.), the Chair recognized Rep. Manuel F. Zubiri for his interpellation.

INTERPELLATION OF REPRESENTATIVE ZUBIRI

To the initial queries of Representative Zubiri, Representative Del Rosario said that the key to the success of the Philippine delegation to the AIMAG was the members' cooperation, unity, and regard for each other like family members. He also acknowledged the fact that the team secretariat, medical team, and coaches did their jobs very well.

Representative Zubiri thereafter manifested his appreciation for Representative Del Rosario and Team Philippines for their achievements in sports, and said that they are the country's heroes.

REMARKS OF THE CHAIR

The Chair stated that the House of Representatives looks forward to seeing Team Philippines in its halls.

On motion of Representative Garcia (J.E.), the Chair recognized Rep. Manuel Luis T. Lopez for his interpellation.

INTERPELLATION OF REPRESENTATIVE LOPEZ (M.L.)

Representatives Lopez and Del Rosario discussed the reasons behind the increase in the number of countries that participated in the AIMAG and the success of the Philippine contingent therein.

The former then commended the latter for leading the country's victory and said that the event should serve as a guide in the country's preparations for the 2019 Southeast Asian (SEA) Games.

Thereafter, on motion of Representative Garcia (J.E.), the Chair recognized Rep. Conrado M. Estrella III for his interpellation.

INTERPELLATION OF REPRESENTATIVE ESTRELLA

Representative Estrella discussed with Representative Del Rosario the issue of bringing sports

down to the grassroots level; preparing for sporting events that the country could excel in light of the country's hosting the 2019 SEA Games; and allowing the public and private sectors to coordinate and help each other in order to achieve these goals. He also commended the Philippine Olympic Committee for recommending Representative Del Rosario as the *chef de mission* of the Philippine delegation to the 2019 SEA Games.

REFERRAL OF REPRESENTATIVE DEL ROSARIO'S PRIVILEGE SPEECH

On motion of Representative Garcia (J.E.), there being no objection, the Body referred Representative Del Rosario's privilege speech and its interpellations to the Committee on Rules.

Thereafter, on further motion of Representative Garcia, the Chair recognized Rep. Arlene D. Brosas for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

Speaking in Filipino, Representative Brosas adverted to the Armed Forces of the Philippines' (AFP) recent air bombings in Mt. Banoi in Batangas which resulted in the suspension of classes and death of three persons including a child. She said that she and Rep. Ariel "Ka Ayik" B. Casilao were part of a humanitarian mission to bring aid to the residents therein, but members of the AFP refused to let them through. She relayed reports that although the AFP said that it was conducting military operations against the New People's Army, it was actually bombing large-scale open pit mines on behalf of an Australian mining company and its local partners.

Condemning the military operations because they endangered the lives and livelihood of the civilian population, Representative Brosas stressed that they violated international agreements and laws on human rights and war operations. On behalf of Gabriela Party-List, she called for an end to the AFP's bullying stance so that the residents thereof could receive help; and for a congressional investigation on the matter.

REFERRAL OF REPRESENTATIVE BROSAS' PRIVILEGE SPEECH

On successive motions of Representative Garcia (J.E.), there being no objection, the Body referred Representative Brosas' privilege speech to the Committee on Rules, and the Chair recognized Representative Casilao for his privilege speech.

**PRIVILEGE SPEECH OF
REPRESENTATIVE CASILAO**

Speaking in Filipino, Representative Casilao also condemned the aerial bombings in Mt. Banoi, Batangas which were allegedly conducted to pursue the members of the NPA and the resulting displacement of students and families therein. He said that the Philippine National Police (PNP) harassed him and members of a delegation that was bringing relief goods to the victims, saying that it was equivalent to economic embargo and a human rights violation. He asked Congress to investigate the martial law-like actions of the AFP and PNP as well as the standard operating procedure of conducting aerial bombings despite its effect on marginalized communities, saying that it could be likened to a war crime.

Speaking on behalf of the Makabayan bloc, Representative Casilao also condemned the AFP's dictatorship over local government units which has resulted in the latter's failure to address the needs and concerns of the residents therein.

**REFERRAL OF REPRESENTATIVE
CASILAO'S PRIVILEGE SPEECH**

On motion of Representative Garcia (J.E.), there being no objection, the Body referred Representative Casilao's privilege speech to the Committee on Rules.

TERMINATION OF THE PRIVILEGE HOUR

At this juncture, on motion of Representative Garcia (J.E.), there being no objection, the Body terminated the Privilege Hour.

ADDITIONAL REFERENCE OF BUSINESS

Thereupon, on motion of Representative Garcia (J.E.), there being no objection, the Body proceeded to the Additional Reference of Business.
