APPROVAL OF THE JOURNAL

On motion of Representative Defensor, there being no objection, the Body approved Journal No. 31, dated October 2, 2017.

UNFINISHED BUSINESS: COMMITTEE REPORT NO. 393 ON HOUSE BILL NO. 6452

On motion of Representative Defensor, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6452 as embodied in Committee Report No. 393 and reported out by the Committees on Health, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ESTABLISHING A NATIONAL MENTAL HEALTH POLICY FOR THE PURPOSE OF ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS UTILIZING PSYCHIATRIC, NEUROLOGIC AND PSYCHOSOCIAL HEALTH SERVICES, AND APPROPRIATING FUNDS THEREFOR.”

At this juncture, Representative Defensor stated that the parliamentary status of the measure was that it was in the period of sponsorship and debate; and on his motion, the Chair recognized Rep. Cristina “Chiqui” Roa-Puno to sponsor the measure and Rep. Edcel C. Lagman to interpellate thereon.

INTERPELLATION OF REPRESENTATIVE LAGMAN

Representative Lagman stated at the outset that he was in favor of the Bill and that he would appreciate it if more Members would participate in the debate so that at the proper time, perfecting amendments can be introduced. After citing the World Health Organization’s statement and the Commission on Human Rights’ position paper submitted to the Committee on Health on the importance of community-based mental health care, he then discussed with Representative Roa-Puno the transition from a hospital-based to a comprehensive community-based mental health care system which shall consist of mental health care service development, capacity building reorientation and training, and research and development.

Thereafter, Representatives Lagman and Roa-Puno discussed how the Bill will address the lack of effective mental health care facilities nationwide. The Sponsor mentioned provisions of the measure on training mental health workers starting at the barangay level; capacitating mental health professionals such as psychiatrists and psychologists; and including psychiatry, neurology, and other mental health subjects in the primary, secondary, and tertiary school curricula. Representative Lagman proposed incentives and scholarship programs to encourage the study and entry of professionals in the delivery of mental health care services.

The Members next discussed the budgetary requirement for the establishment and operation of a community-based mental healthcare facility, with both agreeing to ask the Department of Health (DOH) to disaggregate the minimum amount for the same. They also examined the definition of a community-based rehabilitation program in the Bill, with Representative Lagman saying that he might introduce perfecting amendments thereon.

As regards the different kinds of mental disorders, Representative Lagman then suggested that the Bill specify the same and include within its coverage anxiety disorders; mood disorders such as depression and bipolar disorder; schizophrenia; psychotic disorders; dementia; eating disorders; postpartum depression; and post-traumatic stress disorder. He stressed that persons with bipolar disorder and depression should never be demeaned, humiliated, or disgraced as he mentioned the names of people who suffered from these ailments but contributed much to history and culture.

The two Members next discussed Representative Lagman’s suggestion to specify (1) the coverage of private hospitals in Section 18 of the measure, and (2) the members of the Philippine Council for Mental Health in Section 14 in order to make it independent and autonomous and to include more private sector groups as well as user groups and mental health advocates such as families, ex-patients, and sympathetic media practitioners.

Thereafter, Representative Lagman requested the suspension of his interpellation to be finished the following day.

On motion of Representative Defensor, the Chair recognized Deputy Speaker Pia S. Cayetano for her manifestation.

MANIFESTATION OF DEPUTY SPEAKER CAYETANO

Deputy Speaker Cayetano, as a coauthor of the measure who had worked for the crafting of a mental health bill during her term as Senator, manifested the importance of every person's access to the holistic treatment of mental illness through a multidisciplinary care plan approach. She said that being a health advocate, she would like to put on record her support for House Bill No. 6452 as well as her observation that mental health endeavors, especially in countries where they have stronger programs, make it easier for doctors to prescribe very strong medicines for depression and other mental health cases.

REMARKS OF REPRESENTATIVE ROA-PUNO

At this point, Representative Roa-Puno thanked Deputy Speaker Cayetano for her support for the Bill especially when she first approached her about it.
