With 188 affirmative votes, no negative votes, and no abstentions, the Body approved on Third Reading House Bill No. 6617.

Upon motion of Representative Matugas, the Chair recognized Rep. Kaka J. Bag-ao to explain her affirmative vote.

#### **EXPLANATION OF REPRESENTATIVE BAG-AO'S VOTE**

Representative Bag-ao explained in Filipino that the approval on Third Reading of House Bill No. 6617 or the Philippine HIV and AIDS Policy Bill was a significant milestone for Congress and

was a response to the alarming rise of HIV cases in the Philippines. As principal author thereof, she acknowledged the efforts and support of civil society; various organizations; former and current Committee on Health Chairpersons and Deputy Majority Leader Juan Pablo “Rimpy” P. Bondoc; and Senator Risa Hontiveros who was a primary advocate on certain health causes and whom she had drawn inspiration from. As she also expressed hope that the Bill would soon replace the existing law governing HIV/AIDS, she pointed out that it would safeguard the confidentiality and the right to privacy of persons living with HIV/AIDS.

With 192 affirmative votes, no negative votes, and no abstentions, the Body approved on Third Reading the aforementioned House Bills.

### **THE PRIVILEGE HOUR**

The day being a Monday, on motion of Representative Benhur B. Lopez Jr., there being no objection, the Chair declared a Privilege Hour, and thereafter recognized Rep. Jose L. Atienza Jr. to deliver his privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE ATIENZA**

Remembering former Senator Benigno “Ninoy” S. Aquino Jr. on his birthday on November 27, Representative Atienza recalled the former’s years as an academic scholar; a reporter covering the Korean War; and the youngest elected local chief executive during his time. As he spoke in Filipino, he likewise recalled the Senator’s performance in the Senate where he showed his honest assessment of what he thought was good for the country; as well as his arrest, imprisonment, illnesses, and death sentence during martial law where he exhibited his steadfastness and strength. He also said that after seeking medical treatment abroad, the then leader of the Liberal Party went home because of his quest for the country’s liberation from martial rule. He likewise opined that upon returning to the Philippines, Ninoy was not assassinated but murdered.

Representative Atienza then related the founding of the Lakas ng Bayan (Laban) Party and the Partido Demokratiko ng Pilipino (PDP-Laban) which was currently the “Super Majority” Party of the nation. He pointed out that the latter emanated from Ninoy and were it not for the Senator, there would be no PDP-Laban; no liberation through the so-called EDSA Revolution; and no return of democracy.

Saying that Ninoy served to inspire millions of Filipinos to fight abuse and suffering, Representative Atienza stressed that the citizenry should do so again under the present Administration.

### **REFERRAL OF REPRESENTATIVE ATIENZA’S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Atienza’s privilege speech to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Lopez, the Chair recognized Rep. Munir M. Arbison for his privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE ARBISON**

Representative Arbison denounced the current leader of the province of Sulu who he said was ruling like a dictator and took the reins of power under the illusion of becoming the ultimate uniting sultan of the province. He alleged that under Sulu's current administration, political opponents including himself and his family members have been arrested or charged with crimes; public prosecutors have become mere rubber stamps; police forces are under local executive control; and the activities of bandits, terrorists, criminals are unabated.

Representative Arbison then asked the Chamber to request the Judiciary and the Department of Justice (DOJ) to separately conduct investigations on officials, judges, and court personnel in Sulu. In particular, he asked the agencies to expedite the investigation of (1) the Sulu provincial prosecutor for numerous complaints of unprofessionalism, bias, and graft and corruption and (2) the local chief executive for his control over the police despite the suspension of such power by the National Police Commission.

To conclude, Representative Arbison asked for the immediate return of the criminal justice system and rule of law in Sulu and punishment of erring judges and court personnel.

### **REFERRAL OF REPRESENTATIVE ARBISON'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Arbison's privilege speech to the Committee on Rules for its appropriate action.

On motion of Representative Lopez, the Chair recognized Rep. Edgar R. Erice to deliver his privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE ERICE**

Representative Erice took the floor to address the allegations made in several articles written by Mr. Jarius Bondoc in the February and November 2017 issues of the *Philippine Star* regarding the mining operations of SR Metals, Inc. (SRMI) in Agusan del Norte during his term as company pres-

ident and director. As he clarified the issues involved, he stressed that Mr. Bondoc's revival of stale issues that were already answered and resolved was a continuous but vain attempt to taint the company and tie it to politics. He remarked that there was even no effort on Mr. Bondoc's part to get his or the mining company's side of the story.

Thereupon, he said that the country should not neglect the contributions of mining companies in nation-building and their socioeconomic multiplier effects as well as the SRMI's performance in environmental protection and social compliance. He also asked the media in general to help the country move forward through responsible journalism.

On motion of Representative Lopez (B.), the Chair next recognized Representative Atienza for his interpellation.

### **INTERPELLATION OF REPRESENTATIVE ATIENZA**

Taking note of the fact that his name was mentioned in Representative Erice's speech, Representative Atienza clarified that he was the one who signed the approval of the SRMI's mineral production sharing agreement when he was the Secretary of the Department of Environment and Natural Resources (DENR). He however stressed that he had nothing to do with Basiana Mining Exploration Corporation, nor with the complaint it filed against the SRMI and the resolution thereof, because all of this occurred during the term of his predecessor in the DENR. He added that when he learned about the SRMI's shortcomings when he assumed office in the DENR, he acted on the matter based on what the law required.

Representative Erice affirmed all of the same and said that the SRMI actually paid the biggest penalty ever paid by a mining company for its failure to comply with the DENR's mining rules and regulations.

### **REFERRAL OF REPRESENTATIVE ERICE'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Erice's privilege speech and the interpellation thereon to the Committee on Rules for its appropriate action.

On further motion of Representative Lopez, the Chair recognized Rep. Arlene D. Brosas to deliver her privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS**

Representative Brosas initially discussed how education leads to success and a bright future. She also cited constitutional provisions on the protection and promotion of the Filipino people's right to education, as well as international conventions and declarations on basic civil and political rights regardless of such factors as race, sex, religion, and birth status and on the right to education of indigenous peoples (IPs).

She thereupon focused on the plight of lumad children who were being adversely affected by military operations in Mindanao. She delved into the IPs' call to the Department of Education (DepEd) for an end to martial law, military presence, and delays in the issuance of school permits to operate. As she related incidents of crackdowns and bomb threats in lumad schools, she lamented DepEd Secretary Leonor Briones' insensitivity to the atrocities being committed against IPs.

Representative Brosas then pointed out that volunteer teachers and lumad schools were the ones who were filling in the shoes for the DepEd which is tasked to provide education to citizens.

### **EXTENSION OF THE PRIVILEGE HOUR**

At this point, on motion of Representative Lopez (B.), there being no objection, the Body extended the Privilege Hour for another 30 minutes.

### **PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS** (Continuation)

Thereupon, Representative Brosas added that the State must address the violations committed against the human rights and right to basic education of lumads; and called for an end to militarization.

### **REFERRAL OF REPRESENTATIVE BROSAS' PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Brosas' privilege speech to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Lopez, the Chair recognized Rep. Sarah Jane I. Elago for her privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO**

Representative Elago condemned the harassment, intimidation, arrest, trumped-up charges, and

killings made by State forces against human rights workers and activists, several instances of which she related. She held that this was a red flag of President Rodrigo Roa Duterte's increasing tendency to willingly shed blood to prolong his power and retaliate against his dwindling popularity.

Subsequently, she called for a strong and principled mass movement to counter the Administration's greed for power and for unity against systematic oppression, violence, and tyranny.

*At this juncture, Deputy Speaker Abu relinquished the Chair to Rep. Arthur R. Defensor Jr.*

### **REFERRAL OF REPRESENTATIVE ELAGO'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Elago's privilege speech to the Committee on Rules for its appropriate action.

On further motion of Representative Lopez, the Chair recognized Rep. Tom S. Villarin for his privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE VILLARIN**

Representative Villarin spoke about the government's decision to allow two private ports in Davao City to operate instead of utilizing and modernizing the Sasa Port. He explained how, in this kind of arrangement, the Philippine Ports Authority (PPA) will lose revenues from dockage, container handling, and wharfage fees. He discussed an Ateneo de Davao study that there are viable and immediately available options for the modernization of the Sasa Port.

Representative Villarin then pointed out that the operation of the Davao Sasa Port does not require emergency powers but mere common sense and a dose of political will.

### **REFERRAL OF REPRESENTATIVE VILLARIN'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred the privilege speech of Representative Villarin to the Committee on Rules for its appropriate action.

On further motion of Representative Lopez, the Chair recognized Rep. Carlos Isagani T. Zarate for his privilege speech.

### **PRIVILEGE SPEECH OF REPRESENTATIVE ZARATE**

Speaking in Filipino, Representative Zarate lambasted the present Administration for political



killings, civilian evacuations, and military operations; as well as human rights violations committed due to the war against illegal drugs. Adverting to this year's commemoration of the World Human Rights Day in December 10, he condemned President Duterte's recent declaration on a "crackdown" on legal organizations which Representative Zarate believed would target human rights advocates; farmer and labor leaders; and IPs. He also denounced the effects of counter-insurgency operations and a food blockade in Mindanao as well as the termination of peace talks, on the lives of lumads.

Finally, Representative Zarate urged his colleagues to show courage, condemn human rights violations, continue seeking peace in the negotiating table, and defend the Filipino people from tyranny and oppression.

#### **REFERRAL OF REPRESENTATIVE ZARATE'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred the privilege speech of Representative Zarate to the Committee on Rules for its appropriate action.

#### **EXTENSION OF THE PRIVILEGE HOUR**

Upon successive motions of Representative Lopez (B.), there being no objection, the Chair extended the Privilege Hour for another 10 minutes, and thereafter recognized Rep. Ron P. Salo to deliver his privilege speech.

#### **PRIVILEGE SPEECH OF REPRESENTATIVE SALO**

Tackling certain issues concerning public school teachers such as salary increases and pension payments, Representative Salo focused on the tutors' inability to pay loans incurred with the Government Service Insurance System (GSIS) and other private lending institutions. He discussed DepEd Order No. 55 that aimed to give teachers a leeway to pay for their loans. He called on Congress to urge (1) the GSIS to wave penalties for loan payments and condone loans of retirees among public school teachers; and (2) the DepEd, Department of Finance, and government financial institutions to

immediately conduct nationwide financial literacy seminars to empower public school teachers to better manage their personal finances.

In concluding his speech, Representative Salo said that he would file the pertinent resolution thereon.

#### **REFERRAL OF REPRESENTATIVE SALO'S PRIVILEGE SPEECH**

On motion of Representative Lopez (B.), there being no objection, the Body referred Representative Salo's privilege speech to the Committee on Rules for its appropriate action.

#### **TERMINATION OF THE PRIVILEGE HOUR**

There being no other Member who wished to avail of the Privilege Hour, on motion of Representative Lopez (B.), there being no objection, the Body terminated the Privilege Hour.

#### **TRANSMITTAL TO THE SENATE OF HOUSE BILLS APPROVED ON THIRD READING**

On further motion of Representative Lopez (B.), there being no objection, the Chair directed the Secretary General to immediately transmit to the Senate, copies of the House Bills that had been approved on Third Reading.

#### **ADJOURNMENT OF SESSION**

Subsequently, on motion of Representative Lopez (B.), there being no objection, the Chair declared the session adjourned until four o'clock in the afternoon of Tuesday, December 5, 2017.
