COMMITTEE REPORT NO. 504 ON
HOUSE JOINT RESOLUTION NO. 18**

Upon motion of Representative Hofer, there being no objection, the Body considered on Second Reading House Joint Resolution No. 18, as embodied in Committee Report No. 504 and reported out by the Committee on Appropriations.

Upon direction of the Chair, the Secretary General read the title of the measure, to wit:

“JOINT RESOLUTION AUTHORIZING THE INCREASE IN BASE PAY OF MILITARY AND UNIFORMED PERSONNEL IN THE GOVERNMENT, AND FOR OTHER PURPOSES.”

As copies of the House Joint Resolution had been distributed to the Members, on motion of Representative Hofer, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Subsequently, on motion of Representative Hofer, the Chair recognized the Chairperson of the Committee on Appropriations, Rep. Karlo Alexei B. Nograles for his sponsorship speech.

SPONSORSHIP REMARKS OF REPRESENTATIVE NOGRALES (K.A.)

Representative Nograles expressed his honor in sponsoring House Joint Resolution No. 18 which he said was authored by Speaker Pantaleon D. Alvarez, Majority Leader Rodolfo C. Fariñas, Minority Leader Danilo E. Suarez and himself. Due to time constraints, he then moved to insert his sponsorship speech into the Record of the House.

SPONSORSHIP REMARKS OF REPRESENTATIVE DEFENSOR

Rep. Arthur R. Defensor Jr. adopted the motion of Representative Nograles (K.A.) and also moved to consider the Explanatory Note as sponsorship remarks on the measure. There being no objection, the Body approved the same.

ADDITIONAL COAUTHORS

Thereafter, on motion of Rep. Alexandria P. Gonzales, there being no objection, the Body approved to include as additional coauthors of House Joint Resolution No. 18, Rep. Raul V. Del Mar and other Members as contained in the list to be submitted by the Committee on Rules.

Subsequently, on motion of Representative Gonzales (A.P.), the Chair recognized Rep. Antonio L. Tinio for his interpellation.

INTERPELLATION OF REPRESENTATIVE TINIO

Representative Tinio initially said that House Joint Resolution No. 18 is unprecedented and an important measure that Congress should focus on. He then asked the Sponsor if effective January 1, 2018, the salaries of police, soldiers, and uniformed personnel will be doubly increased.

To Rep. Tinio's query on policy changes in the implementation of salary increases of men in uniform, the Sponsor explained that the Duterte Administration recognizes their role in ensuring the country's national and internal security, this as he stressed that the needs of the civilian employees will also be addressed in the forthcoming annual budget hearings.

As to the implementation of House Joint Resolution No. 18, Rep. Nograles (K.A.) said that once it is approved by the Senate in a bicameral committee, the proposed amount for the salary increase would be fully funded. He thereafter disclosed the

amounts needed for the 2018 and 2019 salary increases under said Joint Resolution, and also clarified that said increments would not affect the 2018 performance-based bonus (PBB) of civilian employees.

Representative Tinio raised the concern of implementing another round of salary increases to civilian government personnel after the full implementation of Executive Order (E.O.) No. 201 by 2019, to which Representative Nograles stated that the Department of Budget and Management (DBM) is presently studying the matter.

Thereupon, both Members discussed the basis for the modified base pay schedule for the military and uniformed personnel (MUP); and the distortion in salaries between MUP and civilian government personnel considering that there are certain criteria and professional qualifications to consider.

Representative Nograles stated that there is no comparison on the classification between the MUP and civilian government personnel as they could be treated differently as they belong to different sectors.

Representative Tinio stated that public school teachers, nurses, doctors, and other government employees are also important to the nation and the Administration should focus on the Salary Standardization Law (SSL) for the benefit of all.

SUSPENSION OF CONSIDERATION OF HOUSE JOINT RESOLUTION NO. 18

On motion of Representative Defensor, there being no objection, the Body suspended consideration of House Joint Resolution No. 18.

ACKNOWLEDGMENT OF GUESTS

Rep. Gonzales (A.P.) acknowledged the presence in the Session Hall of guests of Speaker Alvarez, Reps. Henry S. Oaminal, Sabiniano S. Canama and Ann K. Hofer.

RESUMPTION OF CONSIDERATION ON SECOND READING OF HOUSE JOINT RESOLUTION NO. 18

On motion of Representative Defensor, there being no objection, the Body resumed consideration on Second Reading of House Joint Resolution No. 18.

On further motion of Representative Defensor, the Chair recognized Representatives Nograles

(K.A.) and Tinio, as sponsor and interpellator, respectively.

INTERPELLATION OF REPRESENTATIVE TINIO (Continuation)

Representative Tinio next discussed with the Sponsor the reduction in the PBB for the year 2018 as compared to 2017 which Representative Nograles (K.A.) explained was due to the low utilization rate in 2017 and would be allotted to those with a high utilization rate.

Representative Tinio then asked if the reduction would be the source of funds for the instant measure as he stressed that other government employees should also receive an increase in their salaries and remarked that there seems to be an attempt by the Administration to get military and police support for the war against illegal drugs and the Communist Party of the Philippines-New People's Army (CPP-NPA) which the Administration declared as terrorists, through the passing of the measure. Representative Nograles clarified that the government is not advocating the measure in order to support a revolutionary government.

REMARKS OF REPRESENTATIVE DEFENSOR

At this point, Representative Defensor stated that the time allotment of Representative Tinio had already expired.

REMINDER FROM THE CHAIR

Deputy Speaker Garcia-Albano thus reminded Representative Tinio to wind up his interpellation.

INTERPELLATION OF REPRESENTATIVE TINIO (Continuation)

To Representative Tinio's concern on giving the same substantial salary increases especially to rank-and-file government employees, Representative Nograles (K.A.) pointed out that it would be at both Houses of Congress' discretion and should be decided upon together with the Executive branch.

SUSPENSION OF CONSIDERATION OF HOUSE JOINT RESOLUTION NO. 18

Upon motion of Representative Defensor, there being no objection, the Body suspended consideration of House Joint Resolution No. 18.

APPROVAL ON SECOND READING OF CERTAIN HOUSE BILLS UNDER THE BUSINESS FOR THE DAY

On successive motions of Representative Defensor, there being no objection, the Body considered on Second Reading the following House Bills, as contained in various Committee Reports and submitted by the Committee on Legislative Franchises; dispensed with the reading of the texts of the measures without prejudice to their insertion into the Record of the House; adopted the Explanatory Notes as the sponsorship remarks on the measures as concurred by Rep. Franz E. Alvarez, Chairperson of the Committee on Legislative Franchises; terminated the period of sponsorship and debate; approved the amendments as contained in the Committee Reports or as presented on the floor, if any; terminated the period of amendments; and approved the same on Second Reading through *viva voce* voting:

1. House Bill No. 6707 as embodied in Committee Report No. 488, extending for another twenty-five (25) years the franchise granted to Raven Broadcasting Corporation, under Republic Act (R.A.) No. 8084 ; and
2. House Bill No. 6708 as embodied in Committee Report No. 489, extending for another twenty-five (25) years the franchise granted to Advanced Media Broadcasting System, Inc., under R.A. No. 8061.

ADOPTION OF HOUSE RESOLUTION NO. 1463

On further successive motions of Representative Defensor, there being no objection, the Body considered House Resolution No. 1463 as embodied in Committee Report No. 481 and reported out by the Committee on Tourism, entitled: “A RESOLUTION STRONGLY URGING HIS EXCELLENCY, PRESIDENT RODRIGO DUTERTE, TO RENEW THE POLICY WHICH GRANTS TRAVEL TAX EXEMPTION TO TRAVELLERS DEPARTING FROM ALL INTERNATIONAL AIRPORTS AND SEAPORTS IN MINDANAO AND PALAWAN TO ANY DESTINATION IN THE BRUNEI DARUSSALAM-INDONESIA-MALAYSIA-PHILIPPINES - EAST ASEAN GROWTH AREA (BIMP-EAGA)””; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; and unanimously adopted the same.

RATIFICATION OF THE CONFERENCE COMMITTEE REPORT ON HOUSE BILL NO. 4863 AND SENATE BILL NO. 1239

Upon motion of Representative Defensor, there being no objection, the Body considered and subsequently ratified the Conference Committee Report on the disagreeing provisions of House Bill No. 4863 and Senate Bill No. 1239, granting the Chief of the Philippine National Police, the Director and the Deputy Director for Administration of the Criminal Investigation and Detection Group the authority to administer oath and to issue subpoena.

SUSPENSION OF SESSION

At 5:30 p.m., the session was suspended on motion of Representative Defensor.

RESUMPTION OF SESSION

The session resumed at 5:32 p.m.

BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 460 ON HOUSE RESOLUTION NO. 1418

On motion of Representative Defensor, there being no objection, the Body considered House Resolution No. 1418 as contained in Committee Report No. 460 and reported out by the Committee on Tourism.

Upon direction of the Chair, the Secretary General read the title of the Resolution, to wit:

“A RESOLUTION REQUESTING THE DEPARTMENT OF TOURISM (DOT), THROUGH THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA), TO ALLOCATE FUNDS FOR THE CONSTRUCTION AND MAINTENANCE OF PUBLIC RESTROOMS ALONG THE EASTERN AND WESTERN NAUTICAL HIGHWAYS OF THE PHILIPPINES.”

Considering that copies of the Resolution had been distributed to the Members, on motion of Representative Defensor, there being no objection, the Body dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House.

Upon Representative Defensor’s further motion, the Chair recognized Rep. Lucy T. Gomez, Chairperson of the Committee on Tourism, to sponsor the measure.

COMMITTEE AMENDMENTS

As presented by Representative Defensor and accepted by the Sponsor, there being no objection, the Body approved the Committee amendments on the first, second, third, and resolatory clauses as well as the title of House Resolution No. 1418.

TERMINATION OF THE PERIOD OF AMENDMENTS

There being no other Committee and individual amendments, on motion of Representative Defensor, there being no objection, the Body terminated the period of amendments.

ADOPTION OF HOUSE RESOLUTION NO. 1418, AS AMENDED

On motion of Representative Defensor, there being no objection, the Body adopted House Resolution No. 1418, as amended.

RESUMPTION OF CONSIDERATION OF HOUSE JOINT RESOLUTION NO. 18

Upon motion of Representative Defensor, there being no objection, the Body resumed consideration of House Joint Resolution No. 18, as embodied in Committee Report No. 504 and reported out by the Committee on Appropriations, entitled:

“JOINT RESOLUTION AUTHORIZING THE INCREASE IN BASE PAY OF MILITARY AND UNIFORMED PERSONNEL IN THE GOVERNMENT, AND FOR OTHER PURPOSES.”

Representative Defensor stated that the status of the House Joint Resolution was that it was in the period of sponsorship and debate; and on his successive motions, the Chair recognized Representative Nograles (K.A.) to sponsor the same and Rep. Gary C. Alejano to interpellate thereon.

INTERPELLATION OF REPRESENTATIVE ALEJANO

At the outset, Representative Alejano lauded the Committee on Appropriations headed by Representative Nograles (K.A) in its effort to increase the salaries of the uniformed sector; manifested his support for House Joint Resolution No. 18; and recounted the history of a bill on a fourth tranche on salary standardization for all government employees, that he had filed as an anti-corruption measure.

Representatives Alejano and Nograles then discussed the Joint Resolution’s provision on the suspension of military retirees’ pension indexation to active personnel’s base pay in accordance with E.O. No. 201. The latter pointed out that the suspension would be temporary and the Committee was willing to accept an amendment whereby the suspension would be only for a period of up to January 1, 2019 or upon the effectivity of a new Pension Reform Law, whichever will come earlier, so that retirees will be covered by the increases in pension.

Next discussing the amount needed for pension indexation, Representative Alejano asked whether there will also be increases in hazardous pay, flying pay, and other benefits connected to the increase of the MUP base pay. Representative Nograles cited the breakdown of the increase in the monthly base pay which includes all other allowances that military personnel have been receiving, after which he said that the funds for the third tranche of salary standardization under E.O. No. 201 were already released to the different civilian and military agencies.

Thereupon, Representative Alejano discussed the following issues with the Sponsor: sources and amounts of funds to implement the third tranche of E.O. No. 201 for the MUP; the seemingly bigger increases in the year 2018 for enlisted personnel as compared to officers; the comparative net salaries that the MUP will receive under E.O. No. 201 and House Joint Resolution No. 18; and the comparative risks faced by civilian employees in agencies such as the Department of National Defense and Bureau of Jail Management and Penology on one hand, and by the MUP on the other hand.

After Representative Nograles said he will provide Representative Alejano with the pertinent computation and data thereon, the latter then opined that the armed forces will not support the declaration of President Rodrigo Roa Duterte of a revolutionary government and that insurgency could not be solved by creating another problem.

Representative Alejano subsequently thanked the sponsoring Committee for its initiative to improve the morale of soldiers and policemen, and expressed hope that the instant House Joint Resolution will not aim to buy their loyalty as they should be faithful only to the Constitution.

On motion of Representative Gonzales (A.P.), the Chair recognized Rep. Rolando G. Andaya Jr. for his interpellation.

**INTERPELLATION OF
REPRESENTATIVE ANDAYA**

Representative Andaya, after expressing support for House Joint Resolution No. 18, inquired whether Representative Nograles (K.A.) would agree with his observation as a former Chairperson of the Committee on Appropriations that while the desire of Congress is to give salary increases every year, it has to first consider the sources therefor. He traced the history of the Salary Standardization Laws and recalled that during the Ramos and Macapagal-Arroyo Administrations, salary increases were coupled with an increase in the value-added tax; were given to one sector at a time; and although it was assured after several years that another round of salary standardization would be in the offing for another sector, there would be a tendency to increase tax collections.

Representative Nograles agreed with Representative Andaya's observations.

On motion of Representative Gonzales (A.P.), the Chair recognized Rep. Frances L. Castro for her interpellation.

**INTERPELLATION OF
REPRESENTATIVE CASTRO (F.L.)**

Representative Castro first discussed with Representative Nograles (K.A.) the effects of the proposed salary increase for the MUP on their retirement benefits; as well as the seeming distortion in the salary scale, as prepared by the DBM, between rank-and-file personnel and officers.

Thereupon, Representative Castro stressed the need to explain the swift and huge increase in the salaries of uniformed personnel as she pointed out that civilian personnel are also affected by the increasing cost of goods and services.

The Sponsor clarified that the increase in the salaries of other government employees was still under study and would depend on the increase in government revenues such as those that could be raised with the proposed tax reform bill. He assured his colleague, who emphasized that no one should be left behind, that he will coordinate with the DBM about the matter.

**TERMINATION OF THE PERIOD
OF SPONSORSHIP AND DEBATE**

There being no more interpellations, on successive motions of Representative Defensor, there being no objection, the Body terminated the period of sponsorship and debate on House Joint Resolution No. 18; and proceeded to the period of amendments.

**AMENDMENTS OF
REPRESENTATIVE DEFENSOR**

As proposed by Representative Defensor and accepted by the Sponsor, there being no objection, the Body approved amendments on pages 1, 2, 3, and 4 of the measure.

**PROPOSED AMENDMENT
OF REPRESENTATIVE TINIO**

Representative Tinio, recognized by the Chair upon Representative Defensor's motion, proposed an amendment in Sections 1 and 2 of the measure.

SUSPENSION OF SESSION

The Chair suspended the session at 6:59 p.m. upon Representative Defensor's motion.

RESUMPTION OF SESSION

The session resumed at 7:00 p.m.

**PROPOSED AMENDMENT
OF REPRESENTATIVE TINIO
(Continuation)**

The Sponsor did not accept the aforecited proposal of Representative Tinio.

**REMARKS OF
REPRESENTATIVE DEFENSOR**

Representative Defensor remarked that Representative Tinio's proposed amendment could be accommodated in an impending bill on another round of salary standardization; and requested his colleague to forego with the same to give way to the approval of the instant measure.

REMARKS OF REPRESENTATIVE TINIO

Representative Tinio stated that it is on record that he made a concrete proposal and it was rejected by the Sponsor.

**TERMINATION OF THE
PERIOD OF AMENDMENTS**

There being no other Committee and individual amendments, on motion of Representative Defensor, there being no objection, the Body terminated the period of amendments on House Joint Resolution No. 18.

**APPROVAL ON SECOND READING
OF HOUSE JOINT RESOLUTION
NO. 18, AS AMENDED**

On further motion of Representative Defensor, there being no objection, the Body approved House Joint Resolution No. 18, as amended, on Second Reading through *viva voce* voting.

**REFERRAL OF HOUSE RESOLUTIONS ON
INQUIRIES IN AID OF LEGISLATION**

In accordance with the Rules governing inquiries, in aid of legislation, on motion of Representative Defensor, there being no objection, the Body approved to refer the following House Resolutions to the appropriate Committees hereunder indicated:

1. House Resolution No. 1460, on the proliferation of the off-dock Container Yard/Container Freight Stations (CY/CFS) in the Philippines causing an imperil on the Bureau of Customs' capacity to closely supervise and control these sensitive areas of customs operations – to the Committee on Ways and Means;
2. House Resolution No. 1464, on the implementation of Proclamation No. 518 (S. 1990) – to the Committee on Housing and Urban Development;
3. House Resolution No. 1468, on the continued proliferation of illegal drugs in correctional facilities as well as to identify government officials and/or employees involved in the illegal drug trade – to the Committee on Dangerous Drugs;
4. House Resolution No. 1474, on the extent of the country's foreign debt – to the Committees on Ways and Means; and Appropriations;
5. House Resolution No. 1480, on the implementation of road projects in the Autonomous Region in Muslim Mindanao (ARMM) by the Department of Public Works and Highways in comparison to the ARMM Regional Government – to the Committee on Public Works and Highways;
