THE PRIVILEGE HOUR

With leave of the House, on motion of Rep. Defensor, there being no objection, the Chair declared a Privilege Hour.

SUSPENSION OF SESSION

On motion of Rep. Defensor, the Chair suspended the session at 4:09 p.m.

RESUMPTION OF SESSION

The session resumed at 4:10 p.m.

Upon resumption of session and on motion of Rep. Defensor, the Chair recognized Rep. Aniceto "John" D. Bertiz III who delivered the following privilege speech:

PRIVILEGE SPEECH OF REP. BERTIZ

Rep. Bertiz urged the government to intensify the war against human trafficking especially among overseas Filipino workers (OFWs), including child trafficking through cyber pornography. He pointed out that the Philippines belonged to the top countries in the world which were fighting human trafficking, but had made very few convictions. He proposed to address the issuance of fake passports, legislate a Trafficking of Victims Assistance Act, train barangays as the primary watchdogs against non-licensed illegal recruiters and cybersex operators, and encourage the Department of Labor and Employment to establish more one-stop OFW processing centers.

Thereafter, on motion of Rep. Defensor, the Chair recognized Rep. Anthony M. Bravo, Ph.D. for his interpellation.

INTERPELLATION OF REP. BRAVO (A.)

Reps. Bravo and Bertiz discussed the difference between human trafficking and human smuggling; number of foreigners convicted for human trafficking; penalties for human trafficking as provided for in RA No. 10364; reasons behind the low conviction rate for human traffickers; and Congress' inclusion of human trafficking and child pornography in the list of heinous crimes.

Thereafter, on motion of Rep. Defensor, the Chair recognized Rep. H. Harry L. Roque Jr. for his interpellation.

INTERPELLATION OF REP. ROQUE (H.)

Reps. Roque and Bertiz discussed the rationale for the Philippines' Tier-1 or excellent ranking in the USGRHT. The former then asked about the number of human trafficking cases that had been filed and the conviction rate of offenders; while the latter cited the low figures thereon for 2015 and 2016 and expressed concern about the country's risk of losing such rank.

The two Members further discussed the poor prosecution of human trafficking cases; falsification of passports and travel documents including the alleged involvement of the DFA and Bureau of Immigration therein; failure of the DFA to implement the Shared Government Information System for Migration and

the initiation of criminal charges for dereliction of duty by said agency; and the conduct of a House investigation on nefarious schemes to produce fake Philippine passports. Commending Rep. Bertiz, Rep. Roque stressed that human traffickers are principals in the modern-day crime of slavery.

On motion of Rep. Defensor, the Chair recognized Rep. Edcel C. Lagman for his interpellation.

INTERPELLATION OF REP. LAGMAN

After obtaining his colleague's affirmative reply on whether there was an international covenant on human trafficking which assigned the United States (US) as the rating country, Rep. Lagman asked what standards the US was using. Rep. Bertiz first said that countries are classified into three tiers depending on their compliance with the Trafficking Victims Protection Act (TVPA) and then enumerated the minimum standards for the elimination of trafficking as stated in said law.

SUSPENSION OF SESSION

On motion of Rep. Bertiz, the Chair suspended the session at 5:07 p.m.

INTERPELLATION OF REP. LAGMAN (Continuation)

Subsequently, Rep. Lagman said that the Philippines was already complying with its own laws on heinous crimes including human trafficking as well as on the protection of children and disadvantaged sectors. On Rep. Bertiz' advocacy for the death penalty, he pointed out that the TVPA only called for adequate punishment; the standards did not include the rate of conviction; and conviction depended on many factors such as the efficiency of the prosecution and defense, the innocence of the accused, and miscarriage of justice.

Rep. Lagman then proposed that the Department of Justice channel its resources not only to the drug problem but also to human trafficking; and employ its prosecutors to assist human trafficking victims especially those who are poor and come from the provinces. Rep. Bertiz agreed therewith.
