TO THE COMMITTEE ON RULES

**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 572
ON HOUSE BILL NO. 6973**

On motion of Representative Pimentel, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6973 as embodied in Committee Report No. 572 and reported out by the Committee on Metro Manila Development.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ENHANCING THE EFFECTIVENESS OF THE METROPOLITAN MANILA COUNCIL IN FORMULATING POLICIES, RULES, REGULATIONS, AND IN ENACTING ORDINANCES FOR METRO MANILA, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7924, ENTITLED 'AN ACT CREATING THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY, DEFINING ITS POWERS AND FUNCTIONS, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES'.”

Representative Pimentel stated that the parliamentary status of the Bill was that it was in the period of sponsorship and debate and upon his motion, the Chair recognized Rep. Bayani F. Fernando, main author of the measure, to sponsor the same and Rep. Jose L. Atienza Jr., for his interpellation.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Representative Atienza discussed with Representative Fernando the absence of a development plan of the Metropolitan Manila Development Authority (MMDA) and how the proposed measure would strengthen and make more effective the MMDA Law. This, as the former referred to his interpellation two weeks ago when he expressed his observation that giving more power to an experimental agency has failed to solve the problems of urban living because of the lack of a development plan. He also opined that the materials sent to him by the sponsoring Committee do not qualify as a development plan as what is contained therein should have been implemented some 25 years ago. He added that local government units (LGUs) have their own development plan and in the same manner, the MMDA should have a bible of how it will develop the metropolis.

Representative Fernando clarified that since 2012, the Metropolitan Manila Council (MMC) always had a development plan, copies of which were given to the LGUs; and stressed that while he accepted the fact that the MMDA may have been part of a great experiment, all enterprises undergo experimentation. He added that the thrust of the instant Bill is simple – to cure the limitations of the MMDA Law.

After the Sponsor explained that the Bill provides that the decisions of the MMDA would still be submitted to the LGUs for approval or adoption, Representative Atienza observed that the MMDA has been competing with the LGUs and has been acting in a capricious and whimsical manner in view of the absence of a development plan to address the basic needs of the metropolis. He pointed out that adding more powers to the MMDA is not going to be a step forward and that the latter should instead be restructured and its officials should be elected instead of appointed. He also suggested that the rationalization of the MMDA be suspended until federalism, which the Duterte Administration has been espousing, shall have been put in place.

Representative Fernando stressed that the powers of the MMDA were restricted by the local autonomy of the LGUs and several government agencies. He explained that through House Bill No. 6973, the consultation and involvement of LGUs in policy and decision-making, will be institutionalized.

Interjecting his serious objection to the instant Bill for being out of tune, out of character, and unnecessary, Representative Atienza explained that

the enhancement of the MMDA could contradict the spirit of federalism because it will have appointed officers while the regional governments will have elected officials. He also expressed apprehension over the fact that the Bill gives additional power to an agency that has not formulated a development plan for flood control, mass transportation system including a subway system, water treatment facilities, information and communication, traffic management, and public safety. He appealed to his colleague to review the measure as he opined that it would not answer but instead aggravate the problems of the metropolis.

On motion of Representative Pimentel, there being no objection, the Chair next recognized Rep. Tobias "Toby" M. Tiangco to interpellate the Sponsor.

INTERPELLATION OF REPRESENTATIVE TIANGCO

At the outset, Representative Fernando apologized for the inclusion of Representative Tiangco as a co-sponsor of House Bill No. 5057. While the latter reaffirmed his support for measures that would strengthen and alleviate the delivery of services to Metro Manila residents, he explained that he did not sign the measure because he doubted the constitutionality of giving the MMDA certain powers as provided for in the measure.

Representative Tiangco then read into the records the constitutional provisions on the local autonomy of territorial and political subdivisions; contended that the MMDA is a special development and administrative region; and cited pertinent jurisprudence. He and Representative Fernando exchanged views thereon.

Representative Fernando thereupon clarified that the Bill does not ask for ordinance-making powers for the MMDA and requires the approval of the LGUs' legislative councils for any ordinance that is approved by the MMC before the same is promulgated.

Rep. Winston "Winnie" Castelo, Chairperson of the sponsoring Committee, whom the Chair also recognized to sponsor the measure, stressed that the measure is not unconstitutional because it will respect and will not interfere with the LGUs' constitutional power of legislation. He added that House Bill No. 6973 is necessary in view of the absence of a comprehensive approach to the problems that the MMDA is mandated to address.

**REMINDER OF
REPRESENTATIVE DEFENSOR**

At this point, Rep. Arthur R. Defensor Jr. reminded the Members to address the Chair as Madam Speaker.

QUERY OF THE CHAIR

After concurring with Representative Defensor, the Chair asked whether Representative Tiangco was adverting to the proposed amendment in Section 3 of the proposed Bill which speaks about the power and function of the MMDA to implement ordinances.

Representative Tiangco held that there are other sections in the measure which authorize the MMDA to enact, adopt, implement, formulate, and issue ordinances.

**INTERPELLATION OF
REPRESENTATIVE TIANGCO**
(Continuation)

At this point, Representative Castelo stressed that the MMC shall only propose ordinances for the approval of the local legislative bodies and no resolution shall have an effect of a law unless it is sanctioned by the latter as he adverted to Section 5(h) of the Bill.

After saying that he was not satisfied with the Sponsors' answers, Representative Tiangco turned to another subject matter. He asked the Sponsor whether the policy of local autonomy is contradicted when an ordinance is implemented in all of the LGUs in Metro Manila even if some did not approve of it. Stressing that the Body should uphold the Constitution and pass laws that are in accordance with the Constitution, he said that the MMDA's alternative was to propose pertinent bills in Congress including those on the creation of a special metropolitan political subdivision.

For his part, Representative Fernando pointed out that Congress has passed on to the MMDA what it should have legislated; and that while Republic Act No. 7924 or the MMDA Law is a good law, it has infirmities that House Bill No. 6973 sought to address.

MOTION OF REPRESENTATIVE TIANGCO

At this point, Representative Tiangco said that the Sponsor has not proven the constitutionality of the Bill's provision on giving ordinance-making powers to the MMDA. He moved for the recommitment of the measure to the Committee on Metro Manila Development.

SUSPENSION OF SESSION

On motion of Representative Defensor, the session was suspended at 6:04 p.m.

RESUMPTION OF SESSION

The session resumed at 6:07 p.m.

**WITHDRAWAL OF REPRESENTATIVE
TIANGCO'S MOTION**

Representative Tiangco withdrew his motion to recommit House Bill No. 6973; and the Chair took note of the same.

On motion of Representative Pimentel, there being no objection, the Body suspended further consideration on Second Reading of House Bill No. 6973.

The session resumed at 6:10 p.m.

**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 532
ON HOUSE BILL NO. 6775**

On motion of Representative Defensor, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 6775, as contained in Committee Report No. 532 and reported out by the Committees on Government Reorganization, Housing and Urban Development, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT CREATING THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT, DEFINING ITS MANDATE, POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR.”

Representative Defensor stated that the parliamentary status was that the Bill was in the period of amendments and on his motion, the Chair recognized Rep. Xavier Jesus D. Romualdo, one of the authors of the Bill, to sponsor the measure.

PERIOD OF AMENDMENTS

In the absence of Committee amendments, on further motion of Representative Defensor, there being no objection, the Body proceeded to the period of individual amendments.

AMENDMENTS OF REPRESENTATIVE SALO

On motion of Rep. Ron P. Salo, and accepted by the Sponsor, there being no objection, the Body approved the former's amendments on pages 1 and 2 of House Bill No. 6775.

TERMINATION OF THE PERIOD OF AMENDMENTS

There being no other individual amendments, on motion of Representative Defensor, there being no objection, the Body terminated the period of amendments.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 6775, AS AMENDED

Thereupon, on motion of Representative Defensor, there being no objection, the Body approved on Second Reading House Bill No. 6775, as amended, through *viva voce* voting.

SUSPENSION OF SESSION

The session was suspended at 6:15 p.m., upon motion of Representative Defensor.

RESUMPTION OF SESSION

The session resumed at 6:15 p.m.

ADOPTION OF HOUSE RESOLUTION NO. 1522

On successive motions of Representative Defensor, there being no objection, the Body considered House Resolution No. 1522, entitled: "A RESOLUTION URGING THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) TO HASTEN THE PROCESS OF IMPROVING THE TARGETING OF BENEFICIARIES SO AS TO LESSEN PROGRAM LEAKAGE; TO INCREASE THE LEVEL OF EFFECTIVENESS OF THE DELIVERY OF SOCIAL PROTECTION/WELFARE SERVICES TO 4Ps BENEFICIARIES; AND TO IMMEDIATELY LIFT THE SUSPENSION OF REGISTRATION OF NEW BENEFICIARIES OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps)"; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; and unanimously adopted the same.

1. House Resolution No. 1265, on the violent dispersal by the Philippine National Police (PNP) of the residents of Barangay Manggahan, Pasig City, and the plight of the residents in the area – to the Committee on Public Order and Safety;
2. House Resolution No. 1275, on the illegal dismissal of workers under the Samahan ng Manggagawa ng Sorosoro Ibaba Development Cooperative (SMSIDC-Liga Batangas) and the continuing practice of contractualization of labor of the SIDC-Feedmill Plant in Sorosoro Karsada, Batangas City – to the Committee on Labor and Employment;
3. House Resolution No. 1276, on the lack of action by the Department of Foreign Affairs (DFA) and Department of Labor and Employment (DOLE) on the petition of overseas Filipino workers (OFWs) in Cyprus to initiate the forging of a bilateral social security agreement between the governments of the Philippines and Cyprus – to the Committee on Overseas Workers Affairs;
