EXPLANATIONS OF VOTE

The following Members explained their votes:

1. Speaking in Filipino, Representative Brosas stated that she voted against House Bill No. 6834 because it contained provisions that were direct violations of human rights. This, as she also criticized Congress for recently passing several measures that went against the freedom of expression. She then stressed the Gabriela Party-List's position that such right should be protected not only because it was guaranteed by the Constitution but also because it resulted from the struggle of citizens all over the world.
2. Representative Casilao stated his opposition to the instant Bill as he posited that it was a step backwards in the preservation of human rights because it would restrict the people's right to criticize government policies and programs. Also speaking in Filipino, he further criticized the severity of the penal provisions of the Bill.
3. In explaining his negative vote, Representative Zarate said that despite being one of the proponents of the law repealing or amending B.P. No. 880, he opposed the instant Bill because it added provisions that will further suppress the people's right of expression and right to redress of grievances. Likewise speaking in Filipino, he concluded that the measure will not serve the interest of the citizenry.

REMARKS OF REPRESENTATIVE LAGMAN

Initially inquiring on how his vote was recorded, Rep. Edcel C. Lagman stressed that he was

voting "No" to the measure because it contained regressive provisions inimical to the right of free expression, right to peaceful assembly, and right to redress grievances. He stated that he would explain his vote more extensively and reserved his right to file an explanation of vote before the proper office of the Chamber.

REMARKS OF THE CHAIR

The Chair instructed the Secretariat to correct the result of the voting on House Bill No. 6834 to indicate the negative vote of Representative Lagman. She also noted the reservation made by Representative Lagman as to the explanation of his vote.

THE PRIVILEGE HOUR

The day being a Monday, on motion of Representative Gullas, there being no objection, the Chair declared a Privilege Hour and thereafter recognized Rep. Rodol M. Batocabe for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BATOCABE

Initially, Representative Batocabe cited Section 21 of the Magna Carta for Public School Teachers which sought to protect public school teachers' salaries by prohibiting deductions in their monthly pay slips unless otherwise authorized by law. Subsequently, he expressed concern about private lending institutions seeking accreditation from the Department of Education (DepEd) to participate in its salary deduction scheme for public school teachers.

He said that some big commercial and universal banks hiding in the corporate veils of rural and thrift banks capitalize on the financial plight of teachers and offer low interest rates and quick loan approval, thus resulting in their low actual net take-home pay and long lists of un-deducted obligations in their pay slips.

He maintained that DepEd officials and personnel who are supposed to defend teachers' rights even act as collection agents of private banks in return for cash or perks. Citing pertinent facts on the teachers' plight, he pointed out that deductions in the salaries of teachers should not exceed 50 percent of their basic salaries.

In order to protect public teachers' interests in the salary deduction scheme, Representative Batocabe then suggested that the DepEd veer away from the "first-in, first served" queuing system anent the salary deduction scheme; abolish the participation of rural, thrift, and subsidiary banks of commercial and universal banks and terminate the renewal of previous memoranda of agreement thereon; and discourage the policy for loan buy-outs and protraction of loan terms. He then enjoined his colleagues to help free the teachers from the vicious cycle of commercial exploitation.

MOTION TO REFER REPRESENTATIVE BATOCABE'S PRIVILEGE SPEECH

Thereafter, Representative Gullas moved to refer Representative Batocabe's privilege speech to the Committee on Rules for its appropriate action.

MANIFESTATION OF REPRESENTATIVE OCAMPO

Recognized by the Chair, Rep. Rosenda Ann Ocampo stood for a manifestation.

WITHDRAWAL OF REPRESENTATIVE GULLAS' MOTION

Representative Gullas then withdrew his previous motion to refer Representative Batocabe's speech.

MANIFESTATION OF REPRESENTATIVE OCAMPO

Recognized by the Chair, Representative Ocampo stressed that the minimum take-home pay of government employees has been her advocacy since 2011. She rued the fact that the provision on the ₱5,000-minimum take-home pay of government employees was removed in the 2018 General Appropriations Bill, thus reducing the amount to ₱3,000. She stressed that only the private lenders will benefit from such a situation as she expressed her support for Representative Batocabe's advocacy.

REMARKS OF REPRESENTATIVE BATOCABE

Representative Batocabe affirmed that the oversupply of credit and the banks' money-lending businesses entice more spending among poorly-paid teachers. He stressed that the situation cannot be stopped unless there is a political will to do so.

MANIFESTATION OF REPRESENTATIVE OCAMPO (Continuation)

After Representative Ocampo condemned the usurious rates of loans availed by the teachers, she and Representative Batocabe agreed that Congress must ensure that the interest of the educators of the country will be protected in the national budget and in the banking sector.

REFERRAL OF REPRESENTATIVE BATOCABE'S PRIVILEGE SPEECH

On motion of Representative Gullas, there being no objection, the Body referred Representative Batocabe's privilege speech and manifestation thereon to the Committee on Rules for its appropriate action.

On motion of Representative Gullas, the Chair recognized Rep. Aniceto "John" D. Bertiz III to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BERTIZ

Representative Bertiz spoke about the ban on the deployment of Filipino domestic workers to Kuwait as he thanked President Rodrigo Roa Duterte

for showing moral backbone in ensuring their safety and protection. He asked why the government continued to send overseas Filipino workers (OFWs) to that country despite reports of abuse and absence of a labor agreement for their welfare and protection. He stressed that upholding the rights and welfare of OFWs should take precedence over business interests and the fear of offending a valued ally.

As he related efforts by the Philippine embassy to reach out to its Kuwait counterparts to address the aforementioned issues, he asked his colleagues; the Department of Foreign Affairs; and the Department of Labor and Employment to unite behind the President's call to aid the OFWs.

REFERRAL OF REPRESENTATIVE BERTIZ' PRIVILEGE SPEECH

On motion of Representative Gullas, there being no objection, the Body referred Representative Bertiz' privilege speech to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Gullas, the Chair recognized Rep. Salvador B. Belaro Jr. to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BELARO

Representative Belaro thanked the House leadership and several House Committees for the enactment of the Free College Education Law and the Free Wifi in Public Places Law which he called life-changing pieces of legislation, and then discussed three factors that have an impact on the same.

He first cited the synchronization of data among, as well as studies, policies, and needs of the Commission on Higher Education (CHED), Technical Education and Skills Development Authority (TESDA), and DepEd.

He then cited the CHED's computerization program, creation of an online portal for its record, and updating of its management information system; as well as its delays in the release of scholarship funds. He proposed to make such delays as one of the punishable offenses under the Anti-Graft and Corrupt Practices Act.

Thereupon, Representative Belaro asked Congress to exercise its oversight powers and plenary duty to institute legislative reforms in the education sector. He stated that he will file a resolution seeking the merging of the DepEd, CHED, and TESDA or amendment of Republic Act (R.A.) No. 7722 or the CHED Charter to make the law more attuned to the need for synchronizing policies in education.

REFERRAL OF REPRESENTATIVE BELARO'S PRIVILEGE SPEECH

Thereupon, on motion of Representative Gullas, there being no objection, the Body referred the privilege speech of Representative Belaro to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Gullas, the Chair recognized Rep. Arnolfo "Arnie" A. Teves Jr. for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE TEVES

Representative Teves opined that the doctrine of condonation should not be applied on graft cases because it would just encourage or result in a vicious cycle of committing crime and because it does not constitute a law passed by Congress but what is called a judicial piece of legislation. He stated that he plans to send a letter to the Supreme Court about the matter and requested his colleagues to sign the same.

REFERRAL OF REPRESENTATIVE TEVES' PRIVILEGE SPEECH

Thereupon, on motion of Representative Gullas, there being no objection, the Body referred the privilege speech of Representative Teves to the Committee on Rules for its appropriate action.

EXTENSION OF THE PRIVILEGE HOUR

At this point, on motion of Representative Gullas, there being no objection, the Body extended the Privilege Hour for another 15 minutes.

Thereafter, on motion of Representative Gullas, the Chair recognized Rep. Gary C. Alejano for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ALEJANO

Representative Alejano discussed the failure of Presidential Decree (P.D.) 415 or the Philippine Self-Reliant Defense Posture (SRDP) Program to address the need for a reliable and indigenous defense industry. He mentioned the contributory factors thereto, namely, the country's overdependence on its allies; inability to sustain demand for the defense industry; decline in government support; lack of upstream activities; and absence of a clear and definite SRDP strategy.

Then urging the Body to elevate P.D. No. 415 to a republic act, Representative Alejano stressed the need for the country to have its own Defense Research and Development Agency (DRDA) under the Department of National Defense (DND) in order to increase its defensive capability in its territorial waters. He explained that the DRDA will provide defense-related technology, produce defense materials, and acquire the technology for the production thereof.

REFERRAL OF REPRESENTATIVE ALEJANO'S PRIVILEGE SPEECH

Thereupon, on motion of Representative Gullas, there being no objection, the Body referred the speech of Representative Alejano to the Committee on Rules for its appropriate action.

TERMINATION OF THE PRIVILEGE HOUR

Subsequently, on motion of Representative Gullas, there being no objection, the Body terminated the Privilege Hour.

CHANGE OF REFERRAL OF CERTAIN MEASURES

On motion of Representative Gullas, there being no objection, the Body changed the referral of the following measures:

1. House Bills No. 943, 2603, 2605, 3680, 4467, 4905, 5570, 5804, and 5851 – from the Committee on Public Works and Highways to the Committees on Public Works and Highways, and Ways and Means;
2. House Bill No. 3339 – from the Committee on Agriculture and Food to the Committee on Health;
3. House Bill No. 6732 – from the Committee on Natural Resources to the Committee on Government Enterprises and Privatization;
4. House Bill No. 6909 – from the Committee on Local Government to the Committee on Transportation; and
5. House Bill No. 6957 – from the Committee on Justice to the Committee on Population and Family Relations.

ADJOURNMENT OF SESSION

Whereupon, on motion of Representative Gullas, there being no objection, the Chair declared the session adjourned until four o'clock in the afternoon of Tuesday, February 6, 2018.
