### ACKNOWLEDGMENT OF GUESTS

Representative Roa-Puno then acknowledged the presence in the Session Hall of guests of Rep. Estrellita B. Suansing.

### BUSINESS FOR THE DAY: COMMITTEE REPORT NO. 582 ON HOUSE BILL NO. 7033

On motion of Representative Roa-Puno, there being no objection, the Body considered on Second Reading House Bill No. 7033, as contained in Committee Report No. 582 and reported out by the Committees on Social Services, Appropriations, and Ways and Means.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ESTABLISHING A COMPREHENSIVE SYSTEM FOR REGISTRATION AND LICENSING OF SOCIAL WELFARE AND DEVELOPMENT AGENCIES AND ACCREDITATION OF SOCIAL WELFARE AND DEVELOPMENT PROGRAMS AND SERVICES, AND APPROPRIATING FUNDS THEREFOR.”

As copies of the Bill had been distributed to the Members, on motion of Representative Roa-Puno, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Sandra Y. Eriguel, M.D., Chairperson of the Committee on Social Services, to sponsor the measure.

### SPONSORSHIP REMARKS OF REPRESENTATIVE ERIGUEL

Upon request of Representative Eriguel, there being no objection, the Body considered the Explanatory Note as the sponsorship remarks on the measure.

Thereafter, on motion of Representative Roa-Puno, the Chair recognized Rep. Anthony M. Bravo, Ph.D., one of the authors of the measure, to sponsor the measure.

### SPONSORSHIP SPEECH OF REPRESENTATIVE BRAVO (A.)

Representative Bravo emphasized that House Bill No. 7033 aims to define and classify social welfare and development agencies (SWDAs); stipulate the requirements for their registration, licensing and accreditation; and give the Department of Social Welfare and Development (DSWD) regulatory powers and functions over them. He explained that the measure aims to provide the grounds for the suspension, revocation of license, or closure of erring SWDAs; provide penal provisions for SWDAs which are operating without licenses; and grant benefits and privileges to registered SWDAs.

After adding that existing laws lack provisions on benefits for compliant social welfare organizations and on stronger sanctions for erring ones, he asked his colleagues to support the instant Bill.

### ACKNOWLEDGMENT OF GUESTS

At this point, Representative Roa-Puno acknowledged the presence in the Session Hall of guests of Representatives Bravo (A.) and Sabiniano S. Canama.

### TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE

There being no Member who wished to interpellate the Sponsor, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of sponsorship and debate on House Bill No. 7033 and thereafter, proceeded to the period of amendments.

### **RECONSIDERATION OF THE APPROVAL ON SECOND READING OF HOUSE BILL NO. 7033**

On motion of Rep. Juan Pablo “Rimpy” P. Bondoc, there being no objection, the Body reconsidered the approval on Second Reading of House Bill No. 7033 in order to give way to the interpellation of Deputy Speaker Pia S. Cayetano.

### **CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 7033**

On motion of Representative Bondoc, there being no objection, the Body considered on Second Reading House Bill No. 7033 as contained in Committee Report No. 582 and reported out by the Committees on Social Services, Appropriations, and Ways and Means, entitled: “AN ACT ESTABLISHING A COMPREHENSIVE SYSTEM FOR REGISTRATION AND LICENSING OF SOCIAL WELFARE AND DEVELOPMENT AGENCIES AND ACCREDITATION OF SOCIAL WELFARE AND DEVELOPMENT PROGRAMS AND SERVICES, AND APPROPRIATING FUNDS THEREFOR.”

On successive motions of Representative Bondoc, there being no objection, the Body reopened

the period of sponsorship and debate on House Bill No. 7033; and the Chair recognized Representative Eriguel, Chairperson of the sponsoring Committee, and Deputy Speaker Cayetano to sponsor and interpellate thereon, respectively.

### **INTERPELLATION OF DEPUTY SPEAKER CAYETANO**

Deputy Speaker Cayetano initially apologized to the Body that it had to reopen the period of sponsorship and debate on House Bill No. 7033, stating that she was listed the previous day as an interpellator but was attending awhile back an ongoing hearing of the Committee on Population and Family Relations. She then expressed concern about the implementation of the foster care and adoption programs of the Department of Social Welfare and Development (DSWD) due to inadequate manpower and financial resources, and the flaws in the program. She added that the Bill’s registration requirements for foundations might also affect said implementation.

At this point, Deputy Speaker Cayetano offered her assistance so that the Bill will be improved and approved. When Representative Eriguel assured her that her proposal to increase the manpower of the DSWD and to provide benefits to donor organizations will be included in the instant measure or its implementing rules and regulations, she asked for ample time to submit the proper amendments.

### **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no further interpellations, on motion of Representative Roa-Puno, there being no objection, the Body terminated the period of sponsorship and debate on House Bill No. 7033.
