THE PRIVILEGE HOUR

The day being a Monday, on motion of Representative Nograles (J.J.), there being no objection, the Chair declared a Privilege Hour and thereafter recognized Rep. Emmi A. De Jesus for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DE JESUS

Speaking in Filipino, Representative De Jesus invited her colleagues and countrymen to join the country's fifth-year commemoration of the One Billion Rising global campaign which uses dance to highlight the plight of women and to protest violence against women. As she cited the current year's theme of "Rise, Resist, and Unite," she condemned the remarks that President Rodrigo Roa Duterte had uttered against women in a recent ceremony in Malacañang. She said that they promote State violence against women; contribute to the climate of impunity of women's rights abuses; and embolden State forces to commit more violations of international humanitarian law.

Thereafter, she reminded her colleagues of the historical role of the women sector in fighting abuse, violence, and despotism; and urged them to help fight for the cause of the women sector. She added that in the forthcoming celebration of International Women's Day, various activities will be held to protest against the Duterte Administration's human rights violations and dictatorial tendencies.

REFERRAL OF REPRESENTATIVE DE JESUS' PRIVILEGE SPEECH

On motion of Representative Nograles (J.J.), there being no objection, the Body referred Representative De Jesus' privilege speech to the Committee on Rules for its appropriate action.

Thereafter, on motion of Representative Nograles, the Chair recognized Rep. Carlos Isagani T. Zarate to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ZARATE

Speaking in Filipino, Representative Zarate rued the fact that the termination of the peace talks between the Government of the Republic of the Philippines (GRP) and the National Democratic Front of the Philippines (NDFP) has prevented final negotiations on the Comprehensive Agreement on Social and Economic Reforms (CASER). He explained that the CASER is the most important and critical part of the peace talks because it will provide a framework that will address poverty, which is the root cause of armed conflict. He added that it contains a socio-economic alternative to neoliberal policies.

Subsequently, Representative Zarate discussed the negative effects of neoliberalism worldwide. In the Philippines, he explained how neoliberalism has caused the privatization of basic services and utilities which has resulted in higher fees and rates as well as inefficiency; poverty and hunger; unemployment, contractualization, insufficient pension funds and daily wages; a widening gap between the rich and poor; low productivity in the agriculture and manufacturing sector; exploitation of natural resources; hollow implementation of land reform; illegal drug trade; a lagging economy; and higher taxes

After assailing the current government's policies that benefit the rich sector and big businesses rather than the ordinary people, he said that the CA-SER aims to attain genuine agrarian reform and countryside development; national industrialization; protection of natural resources, socio-economic rights, and rights of cultural communities; a nationalistic, scientific, and pro-poor kind of culture; and an anti-imperialist framework for reform.

REFERRAL OF REPRESENTATIVE ZARATE'S PRIVILEGE SPEECH

On motion of Representative Nograles (J.J.), there being no objection, the Body referred Representative Zarate's privilege speech to the Committee on Rules for its appropriate action.

On further motion of Representative Nograles, there being no objection, the Chair recognized Rep. Ariel "Ka Ayik" B. Casilao to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE CASILAO

Representative Casilao expressed apprehension over recent news reports that the National Food Authority (NFA) had only two days' worth of rice stock and that most of its outlets no longer had rice; a denial from the Department of Agriculture (DA) and NFA Council that there was a rice shortage despite an NFA official's confirmation of rice importation; and the announcement by the Grains Retailers Confederation of the Philippines of a P5/kilo increase in the price of rice.

He then pointed out that there was a seeming synchronization in the aforecited pronouncements of the NFA, on one hand; and of the rice cartels' plan to raise the price of commercial rice and the rice smugglers' plan to import rice, on the other hand. He concluded that there was a scheme to revive an artificial rice shortage as what had occurred in past administrations, in order to make money at the expense of the majority of the population that patronizes the cheaper NFA rice compared to commercial rice.

He subsequently cited the following recommendations to offset the artificial rice shortage, which, he said, he had articulated time and again: ensure the adequacy of farmlands which have been giving way to big plantations; increase subsidies and facilities for rice production; increase the NFA purchasing rate; dismantle rice cartels; and promote genuine agrarian reform which is the basis of food productivity and food security. He also said that he would file a resolution for an investigation on the matter.

Thereafter, on motion of Representative Nograles (J.J.), the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

INTERPELLATION OF REPRESENTATIVE ATIENZA

Representative Atienza initially stressed that the rice problem will not be solved unless manipulation and corruption in the rice industry is addressed.

Subsequently, he exchanged views with Representative Casilao about the primary mandate of the NFA in ensuring an adequate rice supply; the corruption in said agency; the recurring issues of shortage, control, smuggling and manipulation of rice supply; and self-sufficiency in rice production.

Emphasizing his intent to support a resolution that would investigate the alleged rice shortage and the performance of the NFA, Representative Atienza urged his colleagues to do the same.

ACKNOWLEDGMENT OF GUESTS

At this point, Representative Nograles (J.J.) acknowledged the presence in the Session hall of guests of Rep. Lord Allan Jay Q. Velasco.

EXTENSION OF THE PRIVILEGE HOUR

On motion of Representative Nograles (J.J.), there being no objection, the Body extended the Privilege Hour for another 30 minutes.

On further motion of Representative Nograles, there being no objection, the Chair recognized Rep. Michael L. Romero, Ph. D. for his interpellation.

INTERPELLATION OF REPRESENTATIVE ROMERO

To Representative Romero's initial queries, Representative Casilao explained how the artificial rice crisis benefits the rice cartels and smugglers but compromises importation policies and rice production. Representative Romero then said that he was concerned about the negotiated process in the NFA and on the creation of an artificial rice shortage. He said that he will support his colleague's resolution as he expressed hope that the bidding process in said agency will also be scrutinized.

MANIFESTATION OF REPRESENTATIVE VIOLAGO

Recognized by the Chair, Rep. Micaela S. Violago said that the Second District of Nueva Ecija is the number one producer of palay and rice in the country. She agreed with Representative Casilao that there is a huge increase in the buying price of commercial rice because demand was higher than supply; assured the latter that there is enough supply of rice especially in her province and in other provinces like Isabela; agreed with the latter on the need to regulate the importation of rice to help the farmers; and asked the help of the government to help the farmers regarding free irrigation and the regulation of fertilizer prices.

Thereupon, on motion of Representative Nograles (J.J.), the Chair recognized Rep. Elisa "Olga" T. Kho for her manifestation.

MANIFESTATION OF REPRESENTATIVE KHO

Representative Kho cited her recent consultation with farmers in Cagayan de Oro and Bukidnon about the planting of Bt corn. She discussed how rice importation could be lessened by the propagation of corn along with rice as the staple food of the country.

REMARKS OF REPRESENTATIVE CASILAO

Despite expressing apprehension on the consumption of Bt corn and stressing that the main agenda of the government should be ensuring food security, Representative Casilao stressed that rice importation should be avoided because it kills local rice production.

REFERRAL OF REPRESENTATIVE CASILAO'S PRIVILEGE SPEECH

On motion of Representative Nograles (J. J.), there being no objection, the Body referred the privilege speech of Representative Casilao including the interpellations and manifestations thereon to the Committee on Rules for its appropriate action.

PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

Upon recognition by the Chair, Rep. Sarah Jane I. Elago first said that the planned tuition increase of several schools denies equal access to higher education and jeopardize the successful completion of tertiary studies.

She then cited the Rise for Education Alliance which monitors public and private schools' consultations regarding tuition increases, as provided for in Commission on Higher Education (CHED) Memorandum Order No. 3, series of 2012. She enumerated certain schools which did not conduct such consultations, conducted bogus consultations, or conducted consultations without taking into consideration the inputs by stakeholders therein. She however said that instead of addressing the matter, the CHED issued supplementary guidelines to the aforecited CHED issuance which resulted in exorbitant and unreasonable miscellaneous and other school fees.

Subsequently, Representative Elago urged the Commission to immediately stop all tuition and other fee increases; tuition deregulation; and the commercialization and privatization of education. She also called on her colleagues to pass the necessary legislation thereon.

REFERRAL OF REPRESENTATIVE ELAGO'S PRIVILEGE SPEECH

On motion of Representative Nograles (J.J.), there being no objection, the Body referred Representative Elago's privilege speech to the Committee on Rules for its appropriate action.

TERMINATION OF THE PRIVILEGE HOUR

Thereafter, on motion of Representative Nograles (J.J.), there being no objection, the Body terminated the Privilege Hour.

RATIFICATION OF THE CONFERENCE COMMITTEE REPORT ON HOUSE BILL NO. 6452 AND SENATE BILL NO. 1354

On motion of Representative Nograles (J.J.), there being no objection, the Body considered and subsequently ratified through *viva voce* voting, the Conference Committee Report on the disagreeing provisions of House Bill No. 6452 and Senate Bill No. 1354, both establishing a national mental health policy.
