TO THE COMMITTEE ON RULES

On motion of Rep. Victoria Isabel G. Noel, the Chair recognized Deputy Speaker Gwendolyn F. Garcia to rise on a question of personal and collective privilege.

QUESTION OF PRIVILEGE OF DEPUTY SPEAKER GARCIA (G.)

Deputy Speaker Garcia said that she was rising on a matter that was both personal and collective because it involves a decision in an administrative case before the Office of the Ombudsman in which she was a respondent, and the enforcement thereof would impinge upon the constitutional and statutory authority of the House to exclusively discipline its

Members. She then cited Speaker Pantaleon D. Alvarez’ public pronouncement that he would not enforce said decision because there is no constitutional provision allowing him to do so.

Subsequently, Deputy Speaker Garcia adverted to a statement of Rep. Edcel C. Lagman where he disagreed with the opinion of Speaker Alvarez; insisted that the Speaker enforce the decision of the Office of the Ombudsman; and cited the Ombudsman Law.

She read into the records Section 13 (1) to (8), Article XI and Section 16 (3), Article VI of the 1987 Constitution which define the powers, functions, and duties of the Ombudsman and vests upon the House of Representatives the exclusive power to discipline any of its Members, respectively. She concluded that the Ombudsman does not have the power to discipline the Members of the House and the House can dismiss or remove any of its Members only by a two-thirds vote of its total membership.

She also cited Section 21 of Republic Act (R.A.) No. 6770 or The Ombudsman Act of 1989 which specifically and expressly excludes all Members of Congress from the disciplinary authority of the Office of the Ombudsman.

Deputy Speaker Garcia then enjoined her colleagues to stand together and guard the constitutional and statutory authority of the House and not allow an illegal encroachment of its power.

REFERRAL OF DEPUTY SPEAKER GARCIA’S (G.) SPEECH

As Deputy Speaker Garcia had signified her wish not to entertain interpellations, on motion of Representative Lopez (B.), there being no objection, the Body referred the former’s speech to the Committee on Rules for its appropriate action.

Thereafter, the Chair recognized Representative Lagman for his manifestation.

MANIFESTATION OF REPRESENTATIVE LAGMAN

As his name was extensively mentioned by Deputy Speaker Garcia (G.), Representative Lagman manifested his right to rebut the former’s speech at the proper time.

The Chair noted the manifestation of Representative Lagman.

Thereafter, on motion of Representative Lopez (B.), the Chair recognized Rep. Milagros Aquino-Magsaysay on a question of personal and collective privilege.

QUESTION OF PRIVILEGE OF REPRESENTATIVE AQUINO-MAGSAYSAY

Representative Aquino-Magsaysay appealed to her colleagues to support the swift passage of House Bill No. 5038 or the Universal Social Pensions Bill for the betterment of the lives of senior citizens. She stressed that the population has reached the ageing point with over 7.5% of the populace at 60 years of age and above; and that the government has to mitigate the impact of ageing in society.

Representative Aquino-Magsaysay stated that the Universal Social Pensions Bill prescribes a solution to the problem of inadequacy and insufficiency in the living conditions of senior citizens. She explained that it makes the scope of existing beneficiaries as universal and increases their benefit level as a bid for a more inclusive and empowering social pension system. She then appealed for her colleagues' support for the immediate passage of the instant Bill.

REFERRAL OF REPRESENTATIVE AQUINO-MAGSAYSAY'S PRIVILEGE SPEECH

On motion of Representative Lopez (B.), there being no objection, the Body referred the privilege speech of Representative Aquino-Magsaysay to the Committee on Rules for its appropriate action.
