Thereupon, on motion of Rep. Ron P. Salo, there being no objection, the Chair recognized Rep. Edcel C. Lagman on a question of personal and collective privilege.

QUESTION OF PRIVILEGE OF REPRESENTATIVE LAGMAN

Representative Lagman adverted to the speech of Deputy Speaker Gwendolyn F. Garcia on February 14, 2018 which repeatedly scored him for criticizing Speaker Pantaleon D. Alvarez' position of not enforcing the Ombudsman's decision to dismiss her for grave misconduct with perpetual disqualification from the government service, because it could be invalid and only the House can discipline or dismiss its Members.

Initially, Representative Lagman recalled a February 12, 2017 briefing where the media sought the Magnificent 7 opposition group's reaction to the Speaker's announcement on the issue. He said that without mentioning the name of Deputy Speaker Garcia or insisting that she should be removed, he told the media that (1) under the Rules of Procedure of the Office of the Ombudsman, its decision is immediately executory despite a pending motion for reconsideration; and (2) the Constitution does not exempt Members of Congress and Judiciary from the investigatory jurisdiction of the Ombudsman, even as the power of the House to discipline or expel its Members is not exclusive. It was in that context, he added, that he had asked what Constitution Speaker Alvarez was referring to. He has nothing personal against Deputy Speaker Garcia, he stressed, and what they discussed were purely legal and ethical questions.

In support of his arguments, he subsequently cited and explained the following to the Body: (1) provisions of the 1987 Constitution about the investigatory jurisdiction and function of the Office of the Ombudsman; (2) provisions of Republic Act (R.A.) No. 6770 or the Ombudsman Act of 1989 which provide for the Ombudsman's jurisdiction over all administrative complaints and the executory nature of the Ombudsman's decision despite pending motions for reconsideration or appeal; and (3) R.A. No. 3019, as amended, or the Anti-Graft and Corrupt Practices Act which covers all public officers and employees, including Members of Congress, without any exception.

Nevertheless, he also cited the unconstitutionality of some provisions of R.A. No. 6770 which provide for the removal of a deputy or special pros-

ecutor by the Office of the President and which exempt Members of Congress and the Judiciary from the disciplinary authority of the Ombudsman.

EXTENSION OF THE TIME OF REPRESENTATIVE LAGMAN

At this point, the Chair reminded Representative Lagman to wind up with his speech; but upon the request of the latter, there being no objection, the Chair extended his time for 10 minutes.

QUESTION OF PRIVILEGE OF REPRESENTATIVE LAGMAN (Continuation)

Representative Lagman thereafter pointed out that three incumbent Members of the House had voluntarily submitted to the jurisdiction of the Office of the Ombudsman.

Whereupon, he emphasized that the fundamental issue is whether Deputy Speaker Garcia would submit to the decision of the Ombudsman despite a pending motion for reconsideration or appeal. Stressing that public office is a public trust, he asked whether she was calling for the Members' exemption from this salutary principle when she asked them to stand together for their immunity from the Ombudsman's alleged encroachment. He concluded that the ball was now in Speaker Alvarez' court and whether he freezes it or throws it out of bounds is his accountability.

REFERRAL OF REPRESENTATIVE LAGMAN'S QUESTION OF PRIVILEGE

On motion of Representative Salo, there being no objection, the Body referred Representative Lagman's question of privilege to the Committee on Rules for its appropriate action.

ACKNOWLEDGMENT OF GUESTS

Representative Salo then acknowledged the presence in the Session Hall of the guests of Reps. Sabiniano S. Canama and Anthony M. Bravo, Ph.D.

THE PRIVILEGE HOUR

The day being a Monday, on successive motions of Representative Salo, there being no objection, the Chair then declared a Privilege Hour and recognized Rep. Ciriaco S. Calalang to deliver his privilege speech.

Representative Calalang said that despite the current era of scientific advancement and technological innovation, Filipinos still suffer from the negative effects of bureaucracy and red tape. He called for data interconnectivity among government agencies to streamline their functions and thus facilitate the conduct of their transactions with the public. He noted that even with the passage of the Anti-Red Tape Act of 2007, each government agency maintains its own database and information system and thus requires an applicant to submit several documents, mostly the original copies thereof, for the issuance of clearances, licenses, passports, or identification cards.

In view of the citizens' demand for speed and real time in their dealings with the government, Representative Calalang then stressed the need for a dynamic and responsive way of governance through data interconnectivity and asked his colleagues to support the Philippine Data Interconnectivity Act.

REFERRAL OF REPRESENTATIVE CALALANG'S PRIVILEGE SPEECH

On motion of Representative Salo, there being no objection, the Body referred Representative Calalang's privilege speech to the Committee on Rules for its appropriate action.

On further motion of Representative Salo, the Chair recognized Rep. Maximo B. Rodriguez Jr. to deliver his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE RODRIGUEZ (M.)

Representative Rodriguez decried Mindanao's meager share in the national budget from 2014 to 2017. While he acknowledged the increase in its share in the 2018 national budget, he said that it still pales in comparison with the National Capital Region's share and the nationwide allocation especially if one considers the huge number of poor families in his region. Citing facts and figures, he also said that despite the budget increases of several executive departments, Mindanao's allocations for the same were much smaller than those of Luzon.

Taking note of the fact that the President comes from Mindanao, Representative Rodriguez then expressed hope that Mindanao would finally receive a just and equal share in the national budget which will help it to develop and reach its potentials.

REFERRAL OF REPRESENTATIVE RODRIGUEZ'(M.) PRIVILEGE SPEECH

Thereafter, on motion of Representative Salo, there being no objection, the Body referred Representative Rodriguez' privilege speech to the Committee on Rules for its appropriate action.

The Chair subsequently recognized Rep. Carlos Isagani T. Zarate to deliver his privilege speech, on motion of Representative Salo.

PRIVILEGE SPEECH OF REPRESENTATIVE ZARATE

Speaking in Filipino, Representative Zarate took the floor in behalf of public-sector unions in general and the Consolidated Union of Employees (CUE) of the National Housing Authority (NHA) in particular.

After saying that government employees were also fighting for regularization and security of tenure and were experiencing contractualization like private employees, he decried (1) the NHA's suppression of the members of the CUE to assert the need for genuine and pro-poor housing services, and (2) the NHA Board Chairman's accusation that the CUE was a front of the Communist Party of the Philippines.

Representative Zarate then said that the right to form unions and to peaceably assemble were guaranteed by the Constitution; and pointed out that the NHA Chairman's pronouncement placed the lives of union members in danger of the fascist and tyrannical acts of the current administration. He adverted to the sexually-violent remarks that President Rodrigo Roa Duterte recently uttered against female rebels and the military's attacks against civilians especially the lumads in Mindanao; and said that these clearly show the capability of the government and its armed forces to commit persistent acts of violence against its citizens.

As he subsequently cited the harassment and intimidation of the members of the Confederation for Unity, Recognition and Advancement of Government Employees or COURAGE, Representative Zarate urged his colleagues to support the rights of government employees to form and join unions.

**REFERRAL OF REPRESENTATIVE
ZARATE'S PRIVILEGE SPEECH**

On motion of Representative Salo, there being no objection, the Body referred Representative Zarate's privilege speech to the Committee on Rules for its appropriate action.

On further motion of Representative Salo, the Chair recognized Rep. Emmi A. De Jesus for her privilege speech.

**PRIVILEGE SPEECH
OF REPRESENTATIVE DE JESUS**

Speaking in Filipino, Representative De Jesus condemned the ongoing crackdown on old and smoke-belching jeepneys under the "Tanggal-Bulok, Tanggal-Usok" program.

She expressed apprehension that the jeepney phase-out and public utility vehicle (PUV) modernization program will lead to the corporatization of public transport where drivers and operators will be buried in debt as a result of buying new but expensive jeepney units while capitalists will profit from the same.

She explained how the phase-out of jeepneys will adversely affect various stakeholders including the drivers and operators themselves and their families, commuters, and students -- all of whom are already suffering from new taxes and the higher cost of goods and services.

Then stressing that no sufficient feasibility studies have been conducted about the program, Representative De Jesus said that the Gabriela Women's Party-List will fight against its implementation. She said that the government should instead focus on fixing the light rail transit system and public transportation services.

**REFERRAL OF REPRESENTATIVE
DE JESUS' PRIVILEGE SPEECH**

On motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative De Jesus to the Committee on Rules for its appropriate action.

The Chair thereafter recognized Rep. Sarah Jane I. Elago to deliver her privilege speech, upon Representative Salo's motion.

**PRIVILEGE SPEECH
OF REPRESENTATIVE ELAGO**

Representative Elago spoke about the right of the youth to admonish a profit-oriented system that prevents them from realizing their right to education. She also discussed the need to stop reprimanding students from joining protest actions because this isolates them from being aware of societal ills and the plight of the marginalized and oppressed.

Thereupon, she informed the Body that the youth and student sectors will conduct a nationwide action called Youth Quake 2.0 on February 23, 2018 to express a resolute commitment to fight for rights, freedom, and democracy for the Filipino people.

She encouraged the Members to stand in solidarity with the ranks of the voiceless and the oppressed and fight for genuine social reform and democracy. She further asked the youth to show the administration and its leaders that protest and learning in the classroom are not mutually exclusive but should complement each other.

**REFERRAL OF REPRESENTATIVE
ELAGO'S PRIVILEGE SPEECH**

On motion of Representative Salo, there being no objection, the Body referred the privilege speech of Representative Elago to the Committee on Rules for its appropriate action.

TERMINATION OF THE PRIVILEGE HOUR

On motion of Representative Salo, there being no objection, the Body terminated the Privilege Hour.

ON HOUSE BILL NO. 7134**

On successive motions of Representative Salo, there being no objection, the Body considered on Second Reading House Bill No. 7134, as contained in Committee Report No. 599 and submitted by the Committees on Health, and Appropriations providing policies and prescribing procedures on surveillance and response to notifiable diseases, epidemics, and health events of public health concern; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; as concurred by Rep. Angelina "Helen" D.

L. Tan, M.D., Chairperson of the Committee on Health, adopted the Explanatory Note of House Bill No. 3163 as the sponsorship remarks on the measure; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting.
