SUSPENSION OF SESSION

On motion of Representative De Venecia, the session was suspended at 4:13 p.m.

RESUMPTION OF SESSION

The session resumed at 4:25 p.m.

UNFINISHED BUSINESS: COMMITTEE REPORT NO. 262 ON HOUSE BILL NO. 5745

Thereupon, on motion of Representative De Venecia, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 5745 as embodied in Committee Report No. 262 and reported out by the Committees on Agriculture and Food, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT ESTABLISHING THE COCONUT FARMERS AND INDUSTRY DEVELOPMENT TRUST FUND AND PROVIDING FOR ITS MANAGEMENT AND UTILIZATION.”

Whereupon, Rep. Gerald Anthony “Samsam” V. Gullas Jr. stated that the parliamentary status of the measure was that it was in the period of sponsorship and debate.

On further motion of Representative Gullas, the Chair recognized Rep. Jose T. Panganiban Jr., CPA, LLB, Chairperson of the Committee on Agriculture and Food, to sponsor the measure, and Rep. Edcel C. Lagman for his interpellation.

SUSPENSION OF SESSION

At this point, the session was suspended at 4:27 p.m., upon motion of Representative Gullas.

RESUMPTION OF SESSION

The session resumed at 4:32 p.m.

REMARKS OF REPRESENTATIVE GULLAS

Representative Gullas reiterated that the parliamentary status of the measure was that it was in the period of sponsorship and debate and on his motion, the Chair recognized anew Representatives Panganiban and Lagman to sponsor the measure and interpellate thereon, respectively.

INTERPELLATION OF REPRESENTATIVE LAGMAN

At the outset, Representative Lagman expressed his gratitude to the Sponsor for submitting the documents he had requested. He clarified that he was in favor of the measure and intended to introduce pertinent amendments in the interest of the small coconut farmers.

Representatives Lagman and Panganiban then discussed the utilization of the coconut levy funds. While both agreed that the Supreme Court did not provide for a percentage allocation of the funds between the coconut farmers and the coconut industry, the former stressed that House Bill No. 5745 was a social justice measure and suggested an 80%-20% allocation in favor of the coconut farmers. The latter however stated that the coco levy funds were public funds which should be utilized as a whole and explained that the development of the coconut industry would redound to the benefit of the coconut farmers.

Representative Lagman thereafter traced the genesis of the Philippine Coconut Authority (PCA) and cited the creation of various pre-PCA offices, to stress that the government was developing the coconut industry and funding the same for the longest time with or without the coconut levy funds. He also cited the fact that the coconut farmers had always been languishing and had been forced to contribute to government coffers, to emphasize that a bias in their favor was reasonable and warranted. His colleague said that a proposed Ad Hoc Committee will prepare a Coconut Farmers and Industry Development Plan that included socio-economic programs for coconut farmers, but he opined that Congress had to set up parameters and guidelines on the powers that it was delegating to said Committee under Section 21 of the Bill.

After Representative Lagman reiterated that the coconut levy funds were divisible and were subject to Congress' discretion and that he wanted to introduce perfecting amendments to the Bill, he and Representative Panganiban compared the Declaration of Policy of the measure with the Senate version and with the definition of a coconut farmer in House Bill No. 6135 that the 16th Congress had passed on Third Reading. The former pointed out that the Senate's Declaration of Policy had a justifiable bias in favor of the coconut farmers. The latter said that the sponsoring Committee held a lengthy discussion on the definition of a coconut farmer depending on the hectareage of coconut land, but eventually decided not to make any such distinction.

Representative Lagman stressed that the Bill was a piece of social justice legislation that should directly benefit the coconut farmers owning less than five hectares of coconut land; while Representative Panganiban emphasized that all coconut farmers were equal stakeholders in the coconut industry regardless of the hectareage. After the Members agreed to find out whether the Senate version of the Bill had a cap on the hectareage, Representative Lagman said that he will propose an amendment disallowing the United Coconut Planters Bank from being designated as a depository bank of the coconut industry trust fund because it was a party to the imposition and utilization of the coconut levy funds

At this point, Representative Lagman requested the suspension of his interpellation until another date. He said that he wanted to question the funds given to the PCA and its predecessors even as he clarified that he was not against the use of same but merely wanted them to be rationalized.

SUSPENSION OF SESSION

On motion of Representative De Venecia, the Chair suspended the session at 5:30 p.m.

RESUMPTION OF SESSION

The session resumed at 5:34 p.m.

SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 5745

On motion of Representative De Venecia, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 5745.

THE PRIVILEGE HOUR

The day being a Monday, on motion of Representative De Venecia, there being no objection, the Chair declared the Privilege Hour.

On further motion of Representative De Venecia, the Chair recognized Representative Bataoil for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BATAOIL

Representative Bataoil stood to manifest the clamor of the retirees of the Philippine National Police (PNP) regarding their pension arrearages as he dedicated his speech in honor of Philippine Constabulary-Integrated National Police (PC-INP) and PNP retirees; the Armed Forces of the Philippines (AFP); as well as the Pangasinan Police Retirees Association. He expressed sadness as many of them were in their sickbeds while others had already passed away, as they awaited the pension increases that they deserved for their lengthy, dedicated, and loyal service.

He thereafter traced the history of the PNP establishment and emphasized how policemen and soldiers lived up to difficulties and challenges despite budgetary constraints and meager resources. He said that good, dedicated, and brave policemen outnumbered those who were involved in nefarious activities and

cited the Metrobank Foundation's recognition of the country's outstanding policemen. He showed pictures of such policemen and police officers while in action, citing his colleagues, namely, Rep. Amado T. Espino Jr., who almost lost his life in a New People's Army (NPA) encounter and Rep. Romeo M. Acop who led an operation against the Kuratong Baleleng group.

As he further stressed the valor and loyalty of men in uniform, Rep. Bataoil explained that the adjustments in pension rates due to the implementation of the 2009 Salary Standardization Law, had not been paid to the PNP retirees because of lack of appropriations. He enjoined his colleagues to support House Resolution No. 1117 urging the Department of Budget and Management and the Department of the Interior and Local Government to immediately include the pension differentials of PNP retirees in the 2018 national budget and expedite its immediate release to the pensioners.

Thereafter, on motion of Representative De Venecia, the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

INTERPELLATION OF REPRESENTATIVE ATIENZA

As he recalled the golden years of policemen who were keepers of peace and harmony and were respected by the community, Representative Atienza rued the fact that the pensions of PNP retirees had not yet been released. He stressed that law enforcers needed backing and motivation to continue serving the community and enjoined his colleagues to support the call of Representative Bataoil for the immediate release of their pensions considering the billions of unspent money in the PNP's 2017 budget. Citing the Mamasapano tragedy which claimed the lives of 44 Special Action Force personnel, he stated that he was committing his support in order to give justice, honor, and recognition to police retirees who have served their country well.

REFERRAL OF REPRESENTATIVE BATAOIL'S PRIVILEGE SPEECH

Thereupon, on motion of Representative De Venecia, there being no objection, the Body referred the privilege speech of Representative Bataoil, as well as the interpellation thereon, to the Committee on Rules.

Thereafter, on motion of Representative De Venecia, the Chair recognized Rep. Maximo B. Rodriguez Jr. for his privilege speech.

**PRIVILEGE SPEECH OF
REPRESENTATIVE RODRIGUEZ (M.)**

Expressing support for the declaration of martial law in Mindanao and for the AFP and PNP troops fighting terrorists therein, Representative Rodriguez stressed the need to end the crisis considering its socio-economic impact. After citing the recommendations of the Mindanao Development Authority, he also proposed to restore livelihood as well as economic and transportation programs linking Marawi with the rest of Mindanao through Bangsamoro development corridors; promote special financing facilities for damaged businesses; and rebuild trust and review approaches to countering violent extremism.

Rep. Rodriguez sought the help of all concerned agencies including the AFP in order to provide concrete information, long-term plans and solutions, and adequate resources for the rehabilitation of Marawi City and achievement of peace and development in the region.

Thereafter, on motion of Representative De Venecia, the Chair recognized Rep. Mohamad Khalid Q. Dimaporo for his interpellation.

**INTERPELLATION OF
REPRESENTATIVE DIMAPORO (M.K.)**

Representative Dimaporo said that according to the Secretary of Budget and Management, ₱5 billion for the remaining months of 2017 and ₱20 billion for 2018 had been earmarked for the rehabilitation of Marawi City. He urged the Body to be proactive in working with national line agencies to determine how the funds will be used.

Rep. Rodriguez (M.) stated that he had not yet seen any rehabilitation plan. He explained that he delivered his speech to make the agencies concerned evaluate their plans and inform Congress thereon so that the latter could sponsor pertinent amendments in the National Expenditure Program.

**REFERRAL OF REP. RODRIGUEZ' (M.)
PRIVILEGE SPEECH**

On motion of Representative De Venecia, there being no objection, the Body referred the privilege speech of Representative Rodriguez (M.) together with the interpellation to the Committee on Rules.

Subsequently, the Chair recognized Rep. France L. Castro to deliver her privilege speech, on motion of Representative De Venecia.

**PRIVILEGE SPEECH OF
REPRESENTATIVE CASTRO (F.L.)**

Representative Castro condemned the military operations, harassment, and killings involving (1) lumads or indigenous people (IP) communities in Mindanao who suffered from the environmental plunder of the natural resources of their ancestral lands; and (2) personnel and staff of alternative school systems who provided IPs with transformative and holistic education. She cited some schools such as the Alternative Learning Center for Agricultural and Livelihood Development (ALCADEV) and school networks such as the Salupongan International (SI) which, despite the lack of permits to operate, had been contributing to community-building and national development by promoting the social, political, and cultural wellbeing of the lumads. She also cited some of the military attacks, saying they worsened when martial law was declared in Mindanao; and condemned President Rodrigo Roa Duterte's threat to bomb lumad schools.

Speaking on behalf of the IPs and alternative schools, Representative Castro challenged the current Administration to provide free and quality education to all and to end militarization as well as martial law.

EXTENSION OF THE PRIVILEGE HOUR

On motion of Representative De Venecia, there being no objection, the Body approved to extend the Privilege Hour for another 30 minutes.

Thereafter, on further motion of Representative De Venecia, the Chair recognized Rep. Dimaporo (M.K.) for his privilege speech.

**PRIVILEGE SPEECH OF
REPRESENTATIVE DIMAPORO (M.K.)**

Representative Dimaporo spoke about the inaction of the Department of Justice (DOJ) on three cases filed against Vice Mayor Lacson Lantud of Pantao Ragat, Lanao Del Norte in 2013 for violation of Presidential Decree (P.D.) No. 1866, as amended by Republic Act (R.A.) Nos. 8294 and 9516, regarding the illegal possession of firearms, ammunition, and explosives. He said that the raid on the Vice Mayor's cache of firearms can be considered as either the biggest successful law enforcement operation in the region at the time or a monumental disappointment in the application of law for the benefit of the general public's welfare. He cited the penalty provisions of the abovementioned laws and the follow-up efforts that he as well as his predecessor in the previous Congress had made.

Representative Dimaporo then said that he had filed a Resolution calling for an investigation on the matter and asked for the Body's support for the facilitation of the cases and observance of due process. He also appealed to the DOJ to intensify its role in the criminal justice system.

On motion of Representative De Venecia, the Chair recognized Rep. Abdullah D. Dimaporo for his interpellation.

INTERPELLATION OF REPRESENTATIVE DIMAPORO (A.)

To the queries of Representative Dimaporo (A.) on the history and background of Vice Mayor Lantud, Representative Dimaporo (M.K.) said that he was aware thereof and this included killings and acts of violence that the local official had allegedly committed especially against his political enemies.

To his colleague's question on what the authorities were doing about the matter, Rep. Dimaporo (M.K.) said that there was a clear-cut policy on handling violence, private armies, and warlords; and the police as well as Congress had done their part. He concluded that it was thus time for the courts and the DOJ to function.

REFERRAL OF REPRESENTATIVE DIMAPORO'S (M.K.) PRIVILEGE SPEECH

On motion of Representative De Venecia, there being no objection, the Body referred Representative Dimaporo's privilege speech together with the interpellation thereon to the Committee on Rules.

Thereafter, on further motion of Representative De Venecia, the Chair recognized Rep. Sarah Jane I. Elago for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ELAGO

Adverting to the forthcoming celebration of International Youth Day 2017, Representative Elago thanked President Duterte for signing R.A. No. 10931 or the Universal Access to Quality Tertiary Education Act. She however urged the Body to be on guard and remain vigilant as regards the following: 1) the opposition of the country's economic managers to the

measure; 2) Budget Secretary Benjamin E. Diokno's declaration that he will make sure that not a single peso will be allocated for its implementation in the 2018 proposed budget; and 3) limitations to the law that may be inserted in the implementing rules and guidelines. Giving details on the inadequacy of government resources for education, she called on her colleagues to support the funding of R.A. No. 10931 and the adoption of a resolution that she will file thereon.

Representative Elago however said that free quality education was just one of the youth sector's advocacies. She stressed that they still had to fight for other causes such as the high cost of living; labor issues; and most especially, peace and order.

REFERRAL OF REPRESENTATIVE ELAGO'S PRIVILEGE SPEECH

On motion of Representative De Venecia, there being no objection, the Body referred Representative Elago's privilege speech to the Committee on Rules.

APPROVAL OF THE JOURNAL

Likewise, on motion of Representative De Venecia, there being no objection, the Body approved Journal No. 6, dated August 2, 2017.

ADJOURNMENT OF SESSION

Subsequently, on motion of Representative De Venecia, there being no objection, the Chair declared the session adjourned until four o'clock in the afternoon of Tuesday, August 8, 2017.
