ACKNOWLEDGMENT OF GUESTS

At this point, Representative Zamora (M.C.) acknowledged the presence in the Session Hall of guests of Deputy Speaker Villarica, and Reps. Jennifer Austria Barzaga, Calixto-Rubiano, Greg G. Gasataya, Christopher "Toff" V.P. de Venecia, Ron P. Salo, Pablo C. Ortega, Rozanno Rufino B. Biazon, Tom S. Villarin, and Lorna C. Silverio.

On motion of Representative Zamora, the Chair recognized Rep. Abigail Faye C. Ferriol-Pascual for a parliamentary inquiry.

PARLIAMENTARY INQUIRY OF REPRESENTATIVE FERRIOL-PASCUAL

Representative Ferriol-Pascual inquired on the status of House Bill No. 2793. With the Chair's permission, Representative Herrera-Dy, Chairperson of the Committee on Women and Gender Equality, responded that it will be scheduled for deliberation soon because it was one of the seven priority measures identified by the Committee.

MANIFESTATION OF REPRESENTATIVE VILLARAZA-SUAREZ

Upon recognition by the Chair, Rep. Anna Marie Villaraza-Suarez manifested her intent to be a coauthor of House Bill No. 2793. She expressed support for the purpose and immediate consideration of the measure.

SUSPENSION OF SESSION

At 4:36 p.m., the session was suspended, upon motion of Representative Zamora (M.C).

At this juncture, Deputy Speaker Villarica relinquished the Chair to Representative Nuñez-Malanyaon.

RESUMPTION OF SESSION

The session resumed at 4:36 p.m.

PRIVILEGE HOUR

The day being a Monday, on motion of Rep. Ma. Lucille L. Nava, M.D., there being no objection, the Chair declared a Privilege Hour and thereafter recognized Rep. Elisa "Olga" T. Kho for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE KHO

Representative Kho gave tribute to Mesdames Socorro Ramos, Corazon Ong, Julie Gandiongco, Mila Ferrer, and Rebecca Bustamante; related their achievements after having overcome various obstacles; and stressed that they were worthy of emulation.

She concluded that women could succeed and achieve their dreams and need not experience suffering and hardship, if the government gives them more access to education and economic opportunities as well as discards archaic and discriminatory laws. With regards to the latter, she enumerated several provisions of the Civil Code.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE KHO

On motion of Representative Nava, there being no objection, the Body referred the privilege speech of Representative Kho to the Committee on Rules.

SUSPENSION OF SESSION

On motion of Representative Nava, the Chair suspended the session at 4:48 p.m.

RESUMPTION OF SESSION

The session resumed at 4:48 p.m.

On motion of Representative Nava, the Chair recognized Rep. Ruby M. Sahali for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE SAHALI

Representative Sahali lauded the Philippines' progress towards gender parity. She cited and explained the roles and achievements of Filipino women in politics, local and foreign employment,

education, and health care. She stressed that to observe International Women's Month is to recognize the rights and aspirations of Filipinas; ventilate issues affecting their health, income, and security; empower them; and protect them from violence and abuse.

Thereafter, Representative Sahali stressed that women empowerment has been her flagship program in Tawi-Tawi; acknowledged the contributions of women in her district and in the entire Bangsamoro community; and called on the Members to speak loudly about women's rights and women empowerment.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE SAHALI

On motion of Representative Nava, there being no objection, the Body referred the privilege speech of Representative Sahali to the Committee on Rules.

SUSPENSION OF SESSION

On motion of Representative Nava, the Chair suspended the session at 4:48 p.m.

RESUMPTION OF SESSION

At 4:59 p.m., the session resumed with Representative Herrera-Dy presiding.

On motion of Rep. Cristal L. Bagatsing, the Chair recognized Rep. Tricia Nicole Q. Velasco-Catera for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE VELASCO-CATERA

Representative Velasco-Catera cited the Philippine legislature's strides over the years to address women's issues; as well as the World Economic Forum's recent recognition of the country as among those that have minimized gender disparity.

She however underscored that the Seventeenth Congress must ensure that such laws are effectively implemented. Likewise, she said that it should pass other measures to achieve genuine equality and empowerment for women such as House Bill No. 4113, increasing the maternity leave period for female workers; House Bill No. 5156, ensuring the fundamental equality of men and women under the laws on marriage and family relations; and House Bills No. 218 and 759, both defining and penalizing the crime of sexual infidelity.

REFERRAL OF REPRESENTATIVE VELASCO-CATERA'S PRIVILEGE SPEECH

On motion of Representative Bagatsing, there being no objection, the Body referred Representative Velasco-Catera's privilege speech to the Committee on Rules.

Likewise, on motion of Representative Bagatsing, the Chair recognized Rep. Anna Katrina M. Enverga for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ENVERGA

Representative Enverga first talked about the differences between men and women, gender stereotyping, and double standards for the two sexes.

She then said that over the years, women have struggled with being taken seriously and being recognized on equal terms as men. In the Philippines, she clarified, this has meant nothing short of redefining what being a strong Filipina means – not just subservient but capable of critical thinking; not just reserved but articulate and confident; and not only nurturing but tenacious and passionate as well.

Thereupon, Representative Enverga stressed that women need not deny their femininity in order to continue to push for equality and a meaningful agenda for their sector inasmuch as femininity and strength are not mutually exclusive.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ENVERGA

On motion of Representative Bagatsing, there being no objection, the Body referred Representative Enverga's privilege speech to the Committee on Rules.

SUSPENSION OF SESSION

At 5:12 p.m., the Chair suspended the session upon Representative Bagatsing's motion.

RESUMPTION OF SESSION

The session resumed at 5:13 p.m. with Representative Limkaichong presiding.

ACKNOWLEDGMENT OF GUESTS

At this point, Representative Zamora (M.C.) acknowledged the presence in the Session Hall of guests of Reps. Antonio L. Tinio, France L. Castro, Sandra Y. Eriguel, M.D., and Vini Nola A. Ortega.

Thereafter, on motion of Rep. Ma. Lourdes Acosta-Alba, the Chair recognized Representative Ortega (V.N.) for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ORTEGA (V.N.)

In her speech, Representative Ortega spoke of her role as a daughter, wife, mother, Representative of the ABONO Party-List, and servant of the Lord. She stressed that lawmakers have to discuss and consider the impact of their decision-making on the protection, promotion, and development of the welfare of the women's sector. She also said that women should support and encourage each other with love and grace.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ORTEGA (V.N.)

On motion of Representative Acosta-Alba, there being no objection, the Body referred Representative Ortega's (V.N.) privilege speech to the Committee on Rules.

SUSPENSION OF SESSION

The session was suspended at 5:22 p.m., upon motion of Representative Acosta-Alba.

RESUMPTION OF SESSION

The session resumed at 5:22 p.m.

ACKNOWLEDGMENT OF GUESTS

At this point, Representative Acosta-Alba acknowledged the presence in the Session Hall of guests of Representative Herrera-Dy.

On further motion of Representative Acosta-Alba, the Chair recognized Rep. Jennifer Austria Barzaga to deliver her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BARZAGA

Representative Barzaga spoke about the evolution of women in the Philippines. She explained that Filipinas first went through great lengths to free themselves from inequality and the dictates of a very conservative society; then garnered recognition for their immense contributions to education, health, socioeconomic platforms, and civil and political policies and programs; and thereafter celebrated their empowered status. She said that they

currently continue to promote their empowerment as well as their co-equality and partnership with men.

Thereafter, Representative Barzaga thanked society for the recognition, equal opportunities, and trust that it has given to the women's sector; her fellow-Filipinas who continue to promote their advocacies; and her constituents who have displayed unwavering support and cooperation.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE BARZAGA

On motion of Representative Acosta-Alba, there being no objection, the Body referred Representative Barzaga's privilege speech to the Committee on Rules.

SUSPENSION OF SESSION

Thereafter, on motion of Representative Acosta-Alba, the Chair suspended the session at 5:29 p.m.

At this point, Representative Limkaichong relinquished the Chair to Representative Calixto-Rubiano.

RESUMPTION OF SESSION

The session resumed at 5:31 p.m..

On further motion of Representative Nava, the Chair recognized Rep. Marlyn B. Alonte to deliver her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE ALONTE

Representative Alonte spoke about the physical, emotional, psychological, and spiritual struggles and challenges of female overseas Filipino workers (OFWs) who compose more than one-half of the total number of OFWs. She cited the recent cases of two Filipina OFWs who experienced maltreatment from their employers and ended up mentally-imbalanced and/or dead.

Representative Alonte subsequently urged her colleagues to be more aggressive in taking care of female OFWs and changing their lives by working with the government to (1) reduce abuse and violence committed against them; (2) ensure their security; and (3) provide them with basic services such as education and health care as well as livelihood opportunities. She added that the massive change for women empowerment has to begin at the grassroots level.

REFERRAL OF THE PRIVILEGE SPEECH OF REPRESENTATIVE ALONTE

On motion of Representative Nava, there being no objection, the Body referred Representative Alonte's privilege speech to the Committee on Rules.

SUSPENSION OF SESSION

On motion of Representative Nava, the session was suspended at 5:41 p.m.

RESUMPTION OF SESSION

The session resumed at 5:41 p.m.

ACKNOWLEDGMENT OF GUESTS

Upon resumption of session, Representative Bagatsing acknowledged the presence in the Session Hall of the guests of Representative Herrera-Dy.

On motion of Representative Zamora (M.C.), the Chair recognized Rep. Emmi A. De Jesus to deliver her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE DE JESUS

Speaking in Filipino, Representative De Jesus enjoined her colleagues to fight for a comprehensive and pro-poor health care program for women in general and for mothers in particular as she stressed that mothers always sacrifice their well-being for the sake of their families. She described the impact of incomplete pregnancy services, insufficient PhilHealth funds, and risks of Dengvaxia vaccination, on the physical, emotional, and mental health of Filipino mothers. She likewise described the effects of new tax rates and neoliberal policies on the cost of basic commodities and employment opportunities among the poor and underprivileged.

REFERRAL OF REPRESENTATIVE DE JESUS' PRIVILEGE SPEECH

On motion of Representative Bagatsing, there being no objection, the Body referred Representative De Jesus' privilege speech to the Committee on Rules.

SUSPENSION OF SESSION

On motion of Representative Bagatsing, the session was suspended at 5:51 p.m.

RESUMPTION OF SESSION

The session resumed at 5:51 p.m.

TERMINATION OF THE PRIVILEGE HOUR

On motion of Representative Acosta-Alba, there being no objection, the Body terminated the Privilege Hour.

At this point, Representative Calixto-Rubiano relinquished the Chair to Deputy Speaker Villarica.

ACKNOWLEDGMENT OF GUESTS

Representative Zamora (M.C.) thereupon acknowledged the presence in the Session Hall of the guests of Rep. Sarah Jane I. Elago.

**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 13
ON HOUSE BILL NO. 4113**

On motion of Representative Zamora (M.C.), there being no objection, the Body resumed consideration on Second Reading of House Bill No. 4113 as contained in Committee Report No. 13, and submitted by the Committee on Women and Gender Equality.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INCREASING THE MATERNITY LEAVE PERIOD TO ONE HUNDRED (100) DAYS FOR FEMALE WORKERS IN THE GOVERNMENT SERVICE AND IN THE PRIVATE SECTOR, AND GRANTING AN OPTION TO EXTEND FOR AN ADDITIONAL THIRTY (30) DAYS WITHOUT PAY.”

Representative Zamora stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and on her motion, the Chair recognized Representative Herrera-Dy, Chairperson of the sponsoring Committee, to sponsor the measure and Representative Elago to make a manifestation thereon.

MANIFESTATION OF REPRESENTATIVE ELAGO

Representative Elago manifested that the Members are duty-bound to protect the rights and welfare of working women in view of their maternal functions. She urged her colleagues to support House

Bill No. 4113 and to act even outside the confines of Congress in pursuit of the well-being and rights of this sector especially in the workplace and especially its marginalized and oppressed members.

**REMARKS OF
REPRESENTATIVE HERRERA-DY**

Recognized by the Chair on motion of Representative Zamora (M.C.), Representative Herrera-Dy, on behalf of the sponsoring Committee, thanked Representative Elago for supporting House Bill No. 4113, and expressed confidence that the support of the leadership and their colleagues would ensure its passage.

**SUSPENSION OF CONSIDERATION

On motion of Representative Acosta-Alba, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 4113.
