Thereafter, on motion of Representative Herrera-Dy, the Chair recognized Rep. Jose L. Atienza Jr. on a question of personal and collective privilege.

#### **QUESTION OF PRIVILEGE OF REPRESENTATIVE ATIENZA**

Representative Atienza brought to the attention of the Body the disappearance in the Manila City Mayor's office of National Artist Carlos “Botong” Francisco's obra maestra that was commissioned by the city and depicts the historical and cultural character of the Philippines. He lamented the fact that it

was replaced by a duplicate painting done in tarpaulin because the original painting was allegedly being restored.

As said art masterpiece is a national treasure and some quarters might surmise that it had been stolen, Representative Atienza called on Congress to investigate the matter and to ask those responsible for its disappearance to make an explanation thereon. He also appealed to Manila Mayor Joseph Ejercito Estrada to take action thereon or else he will have to do something to defend the national heritage of the country.

To Deputy Speaker Castro's series of questions, Representative Atienza underscored that Congress has the responsibility to conduct an investigation on the whereabouts of the missing artwork of Mr. Francisco; the beauty, life and essence of the original painting could hardly be replaced with a replica printed on tarpaulin; and those responsible for the said disappearance or unauthorized transfer should be held liable.

Representative Atienza said that he will go to the National Museum to ask why the officials thereof are holding on to a masterpiece which is a property of the people of the City of Manila.

COMMITTEE REPORT NO. 658  
ON HOUSE BILL NO. 7376**

As copies of the Bill had been distributed to the Members, on motion of Representative Bondoc, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative Bondoc, the Chair recognized Rep. Reynaldo V. Umali, Chairperson of the Committee on Justice, to deliver his sponsorship speech.

**SPONSORSHIP SPEECH  
OF REPRESENTATIVE UMALI**

Representative Umali stressed that House Bill No. 7376 seeks to amend R.A. No. 9417 or the OSG Reform Law and streamline the legal services which the OSG provides to various government offices. He said that the significant amendments introduced by the Bill pertain to the organizational structure, expanded powers and functions, personnel compensation and benefits, and funding source of the OSG and to the effects of the abolition of the Office of the Government Corporate Counsel (OGCC) and the Presidential Commission on Good Government (PCGG).

He then asked for the Members' approval of the instant Bill.

**SUSPENSION OF CONSIDERATION  
ON SECOND READING OF  
HOUSE BILL NO. 7376**

On motion of Representative Defensor, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 7376.

**UNFINISHED BUSINESS:  
COMMITTEE REPORT NO. 640  
ON HOUSE BILL NO. 7303**

On motion of Representative Defensor, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7303, as contained in Committee Report No. 640 and reported out by the Committee on Population and Family Relations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INSTITUTING ABSOLUTE DIVORCE AND DISSOLUTION OF MARRIAGE IN THE PHILIPPINES.”

**RECONSIDERATION OF THE  
TERMINATION OF THE PERIOD  
OF SPONSORSHIP AND DEBATE**

On successive motions of Representative Defensor, there being no objection, the Body reconsidered the termination of the period of sponsorship

and debate; and the Chair recognized Representative Lagman to sponsor the Bill and Rep. Raul V. Del Mar to continue his previous day's interpellation.

### **INTERPELLATION OF REPRESENTATIVE DEL MAR**

Representative Del Mar said that the proposed measure violates Constitutional provisions which recognize marriage as an inviolable social institution and the foundation of the family and the State's protection thereof; and opined that it will harm marriages.

The Sponsor however said that in his sponsorship speech, he had underscored that the commissioners of the 1986 Constitutional Commission (CONCOM) were unanimous in asserting that the foregoing principles do not prevent or foreclose Congress from enacting a divorce law.

Representative Lagman added that the measure is not for harmonious and vibrant but dysfunctional and irreparable marriages and does not derogate against the family whose protection is enshrined in the Constitution; and that seeking guidance from other constitutions which allow divorce, does not mean surrendering the country's sovereignty. To his colleague's statement that the desire of the people on the issue should be followed and most of his constituents are against legalizing divorce, he said that surveys have consistently shown that majority of Filipinos, including Catholics, favor absolute divorce.

After both Members expressed respect for each other's dissenting views and for the will of the majority in the House, they discussed the Bill's declaration on giving spouses the opportunity to secure an absolute divorce decree while recognizing the State's protection and preservation of marriage as a social institution and foundation of the family. While Representative Del Mar considered it a contradictory and confusing statement, Representative Lagman explained that the State should also protect couples in distress and there is no more marriage to protect in dysfunctional and irreparable relationships.

They also discussed the need for the instant measure and its effect on children. Representative Del Mar mentioned the existing legal remedies such as legal separation and annulment and the greater stress and pain that children might suffer after their parents get a divorce. Representative Lagman cited his previous day's argument on the need for an option that provides full relief to couples in distress as

well as empirical studies showing that children of divorced parents are better off than those who are exposed to constant marital strife.

Representative Del Mar rebutted thereafter that the Divorce Bill would just encourage troubled couples to resort to quick-fix solutions and would do more harm than good for children.

### **MANIFESTATION OF REPRESENTATIVE ATIENZA**

At this point, Representative Atienza manifested his intention to join the discussion.

### **REMARKS OF REPRESENTATIVE LAGMAN**

Representative Lagman however said that he and Representative Del Mar had the floor.

### **REMARKS OF REPRESENTATIVE ATIENZA**

Representative Atienza clarified that he was asking permission from Representative Del Mar and not from Representative Lagman.

### **REMARKS OF REPRESENTATIVE DEL MAR**

Although Representative Del Mar said that he was not waiving his right and remaining time to interpellate the Sponsor, he would allow Representative Atienza to interject in the discussion.

### **REMARKS OF REPRESENTATIVE DEFENSOR**

Representative Defensor said that he could move to recognize Representative Atienza so that the latter could ask questions, but pointed out that Representative Del Mar had only three minutes left of his time.

### **INTERPELLATION OF REPRESENTATIVE DEL MAR (Continuation)**

Asking Representative Atienza to just wait for him to finish his interpellation, Representative Del

Mar then scrutinized the grounds for absolute divorce under the instant Bill and said that they were not fully explained or defined.

#### **REMINDER FROM THE CHAIR**

The Chair subsequently reminded Representative Del Mar that his one-hour allotment had already expired; and recognized Representative Atienza upon Rep. Ron P. Salo's motion.

#### **REMARKS OF REPRESENTATIVE LAGMAN**

Before Representative Atienza proceeded to ask questions, Representative Lagman said that he was willing to debate with him and asked him to refrain from making unparliamentary remarks like he did in the previous session.

#### **INTERPELLATION OF REPRESENTATIVE ATIENZA**

Representative Atienza then asked whether the word "inviolable" appears in the Constitution. After the Sponsor affirmed the same, he said that he will ask no more questions on the provisions of a proposed law that violates the Constitution.

Both Members then stated that they will face one another in any forum to defend their stand on the measure.

#### **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no other Members who wished to interpellate the Sponsor, on motion of Representative Bondoc, there being no objection, the Body terminated the period of sponsorship and debate.

#### **SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 7303**

On motion of Representative Bondoc, there being no objection, the Body then suspended consideration on Second Reading of House Bill No. 7303.

#### **RATIFICATION OF THE CONFERENCE COMMITTEE REPORT ON HOUSE BILL NO. 6573 AND SENATE BILL NO. 1662**

On motion of Representative Defensor, there being no objection, the Body considered and subse-

quently ratified through *viva voce* voting the Conference Committee Report on the disagreeing provisions of House Bill No. 6573 and Senate Bill No. 1662, prohibiting hazing and other initiation rites of fraternities and sororities.

#### **RECONSIDERATION OF THE APPROVAL ON SECOND READING OF HOUSE BILL NO. 7230**

With leave of the House, on successive motions of Representative Defensor, there being no objection, the Body reconsidered the approval on Second Reading of House Bill No. 7230 for some perfecting amendments; and thereafter proceeded to the period of amendments.

#### **AMENDMENT OF REPRESENTATIVE DEFENSOR**

As proposed by Representative Defensor, there being no objection, the Body approved the amendment on Section 1 of the Bill.

#### **TERMINATION OF THE PERIOD OF AMENDMENTS**

There being no other Committee and individual amendments, on motion of Representative Defensor, there being no objection, the Body terminated the period of amendments.

#### **APPROVAL ON SECOND READING OF HOUSE BILL NO. 7230, AS AMENDED**

On motion of Representative Defensor, there being no objection, the Body approved on Second Reading House Bill No. 7230, as amended, through *viva voce* voting.

#### **RECOMMITMENT OF HOUSE BILL NO. 7296**

As requested by Rep. Ben P. Evardone, Chairperson of the Committee on Banks and Financial Intermediaries, on motion of Representative Defensor, there being no objection, the Body approved to recommit House Bill No. 7296 to the said Committee.

#### **ADDITIONAL COAUTHORS**

On motion of Representative Defensor, there being no objection, the Body approved to include as additional coauthors of House Bills No. 7260, 7303, 7309, 7376, and 7378; and House Resolution No. 1767, the names of Members contained in the lists to be submitted by the Committee on Rules.

**ADJOURNMENT OF SESSION**

On motion of Representative Defensor, there being no objection, the Chair declared the session adjourned until four o'clock in the afternoon of Wednesday, March 14, 2018.
