**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 639
ON HOUSE BILL NO. 7302**

On motion of Representative Mercado, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7302, as contained in Committee Report No. 639 and reported out by the Committee on Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT TO REFORM THE BUDGET PROCESS BY ENFORCING GREATER ACCOUNTABILITY IN PUBLIC FINANCIAL MANAGEMENT (PFM), PROMOTING FISCAL SUSTAINABILITY, STRENGTHENING CONGRESS’ POWER OF THE PURSE, INSTITUTING AN INTEGRATED PFM SYSTEM, AND INCREASING BUDGET TRANSPARENCY AND PARTICIPATION.”

At this point, Representative Mercado stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and upon his motion, the Chair recognized Rep. Joey Sarte Salceda to sponsor the measure and Rep. Edcel C. Lagman to continue his previous day’s interpellation.

**INTERPELLATION OF
REPRESENTATIVE LAGMAN**

Representative Lagman initially followed up the request he made before the session adjourned the previous day, for data on the overall savings of the Philippines in fiscal year 2017.

SUSPENSION OF SESSION

On motion of Representative Salceda, the Chair suspended the session at 4:26 p.m.

RESUMPTION OF SESSION

The session resumed at 4:27 p.m.

**INTERPELLATION OF
REPRESENTATIVE LAGMAN**

(Continuation)

Citing the total savings from the 2017 General Appropriations Act (GAA) of around ₱10 billion, the Sponsor explained how this was used to augment certain budgetary items. He welcomed Representative Lagman’s proposed amendment to require the Department of Budget and Management (DBM) to disclose the amount of total savings at the end of the year and the utilization of the same.

The two Members then discussed practices that derogate Congress’ power of the purse, such as the reenactment of the budget; and the provisions of the Bill that will address such derogation, including those on cash-based budgeting and limitations on the use of Unprogrammed Funds.

SUSPENSION OF SESSION

The session was suspended at 4:51 p.m., on motion of Representative Salceda.

RESUMPTION OF SESSION

The session resumed at 4:52 p.m.

**INTERPELLATION OF
REPRESENTATIVE LAGMAN**

(Continuation)

Representatives Lagman and Salceda also discussed the practice of automatic debt appropriations by virtue of Presidential Decree (P.D.) No. 1177 as reiterated by Executive Order (E.O.) No. 292. Representative Lagman proposed to repeal P.D. No. 1177 or include provisions in the Budget Reform Bill (BRB) which will enable Congress to scrutinize debt servicing. Representative Salceda said that Section 14 of the measure provides for the principles of fiscal responsibility and that Congress’ oversight functions were not being repealed by the BRB.

After Representative Lagman proposed to preclude the payment of behest loans through automatic appropriations, he and the Sponsor debated on the safeguards against Executive impoundment of the budget, which was another practice that demeans Congress’ power of the purse. He proposed provisions stating that (1) outside of those appropriations that are authorized to be impounded, no other

impoundment could be made by the Executive; and (2) if the Executive's proposal for an impoundment is not acted on by Congress within a specified period, then it is deemed disapproved.

Subsequently, the Members debated on Section 27 of the Bill which provides for Special Purpose Funds (SPFs) whose details could not be determined during the budget preparation stage and are based on the parameters to be set in the implementing rules and regulations of the GAA.

Representative Lagman then asked the Body to look into the ballooning of the aforesaid funds; and into the practice of empowering a small committee of the House to effect amendments to the General Appropriations Bill (GAB), thus depriving the Members of the right to introduce amendments on the floor.

INTERPELLATION OF REPRESENTATIVE BRAVO (A.)

Next recognized by the Chair upon motion of Representative Mercado, Rep. Anthony M. Bravo, Ph.D. first asked whether the Sponsor could delete the provision on Congress' additional powers and responsibilities in the BRB because such is already stipulated in the Constitution and E.O. No. 292. The Sponsor replied in the affirmative.

Representative Bravo then asked if the Sponsor could also delete Section 7 on the Commission on Audit's coordination with the DBM on the timely accounting and reporting of public finances because it might diminish the power of an independent branch of government. The latter said that he was willing to do so.

Thereafter, the two Members discussed the availment by national government agencies such as the Department of Education of the multi-year obligational authority that is provided for in the BRB; and the retention of the provision in E.O. No. 292 on the formulation of a budget priority framework.

TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE

There being no other Members who wished to interpellate the Sponsor, on successive motions of Representative Mercado, there being no objection, the Body terminated the period of sponsorship and debate and thereafter proceeded to the period of amendments.

TERMINATION OF THE PERIOD OF COMMITTEE AMENDMENTS

There being no Committee amendments, on successive motions of Representative Mercado, there being no objection, the Body terminated the period of Committee amendments and proceeded to consider individual amendments. The Chair then recognized Rep. Magnolia C. Antonino to present her individual amendment.

PROPOSED AMENDMENT OF REPRESENTATIVE ANTONINO

Representative Antonino proposed an amendment in Section 58 of the Bill.

REMARKS OF REPRESENTATIVE LAGMAN

Upon recognition by the Chair, Representative Lagman requested that he be given up to the following day to study the Committee amendments and prepare his individual amendments.

REMARKS OF REPRESENTATIVE MERCADO

With the permission of the Chair, Representative Mercado requested Representative Lagman's consideration of the fact that the Bill was of utmost importance and was certified as urgent by the President.

SUSPENSION OF SESSION

At this juncture, the Chair *motu proprio* suspended the session at 5:55 p.m.

RESUMPTION OF SESSION

The session resumed at 5:58 p.m.

APPROVAL OF REPRESENTATIVE ANTONINO'S PROPOSED AMENDMENT

As accepted by the Sponsor, there being no objection, the Body approved Representative Antonino's amendment in Section 58 of the Bill.

AMENDMENT OF REPRESENTATIVE ANTONINO

On further motion of Representative Antonino and accepted by the Sponsor, there being no objection, the Body also approved the amendment in Section 81 of the Bill.

SUSPENSION OF SESSION

On motion of Representative Mercado, the Chair suspended the session at 6:00 p.m.

RESUMPTION OF SESSION

The session resumed at 6:14 p.m.

Upon resumption of session, Rep. Juan Pablo “Rimpy” P. Bondoc stated that the parliamentary status was that the Body was considering individual amendments to House Bill No. 7302.

AMENDMENT OF REPRESENTATIVE BRAVO (A.)

On motion of Representative Bravo and accepted by the Sponsor, there being no objection, the Body approved the amendment in Section 7 of the Bill.

MOTION OF REPRESENTATIVE BONDOC

At this point, Representative Bondoc moved to close the period of individual amendments.

Before the Body could act on the same, on further motion of Representative Bondoc, the Chair recognized Representative Lagman for his amendments.

AMENDMENTS OF REPRESENTATIVE LAGMAN

On motion of Representative Lagman and accepted by the Sponsor, there being no objection, the Body approved the amendments in Section 28 and the insertion of a new section on “Report on Savings and Augmentation” on page 22 of the Bill.

PROPOSED AMENDMENTS OF REPRESENTATIVE LAGMAN

Representative Lagman thereafter proposed amendments pertaining to “Amendments to the General Appropriations Bill” and the SPFs on pages 13 and 11 of the Bill, but the Sponsor did not accept the same.

TERMINATION OF THE PERIOD OF AMENDMENTS

There being no other individual amendments, on motion of Representative Bondoc, there being no objection, the Body terminated the period of amendments.

APPROVAL ON SECOND READING OF HOUSE BILL NO. 7302, AS AMENDED

On motion of Representative Bondoc, there being no objection, the Body approved on Second Reading House Bill No. 7302, as amended, through *viva voce* voting.

APPROVAL ON THIRD READING OF HOUSE BILL NO. 7302

Whereupon, on motion of Representative Bondoc, there being no objection, the Body proceeded to the approval on Third Reading of House Bill No. 7302, a certified urgent Bill, pursuant to Section 26(2), Article VI of the Constitution.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT TO REFORM THE BUDGET PROCESS BY ENFORCING GREATER ACCOUNTABILITY IN PUBLIC FINANCIAL MANAGEMENT (PFM), PROMOTING FISCAL SUSTAINABILITY, STRENGTHENING CONGRESS’ POWER OF THE PURSE, INSTITUTING AN INTEGRATED PFM SYSTEM, AND INCREASING BUDGET TRANSPARENCY AND PARTICIPATION.”

The Chair directed the Secretary General to call the Roll for nominal voting. Thereafter, pursuant to the amended Provisional Rules of the House, a second Roll Call was made.

With 158 affirmative votes, eight negative votes, and one abstention, the Body approved on Third Reading House Bill No. 7302.

MANIFESTATION OF SEVERAL MEMBERS

During the voting, Representatives Lagman and Carlos Isagani T. Zarate manifested their desire to explain their votes.

EXPLANATION OF VOTES

The following Members explained their votes:

1. Representative Lagman said that he could not totally embrace the measure and was constrained to abstain from voting on it in

order to await developments in the bicameral committee meeting. He explained that the Bill did not recapture the congressional ascendancy over public funds and the Sponsor did not accept the salient amendments that he proposed.

2. Representative Zarate voted against the proposed law because it would only continue to legitimize highly-criticized budget practices such as the inclusion of unlimited items under SPFs without being subject to congressional scrutiny and the use of lump sum appropriations by the Executive. He added that it further enlarges the power of the Executive over the national budget through such provisions as those allowing deviations from fiscal objectives and authorizing the President to propose and submit a Special Appropriations Bill.
3. Representative Elago cast a negative vote. She said that the measure allows the President to withhold fund releases that would empower him to discontinue the funding of public programs, thereby usurping the congressional power of the purse, and use this as a leverage for political motives. She also said that it allows the DBM to circumvent the national budget through impoundment, thus subverting the will of Congress and allowing the use of funds to be spent on unauthorized budget items.

ACKNOWLEDGMENT OF GUESTS

At this point, Representatives Mercado and Oscar "Richard" S. Garin Jr. acknowledged the presence in the Session Hall of guests of Reps. "Kuya" Jose Antonio R. Sy-Alvarado, Benhur L. Salimbanon, Mercedes "Didi" C. Cagas; and officials of the Office of the Solicitor General (OSG) headed by Solicitor General Jose C. Calida.

**UNFINISHED BUSINESS:
COMMITTEE REPORT NO. 658
ON HOUSE BILL NO. 7376**

On motion of Representative Mercado, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7376, as contained in Committee Report No. 658 and reported out by the Committees on Justice, Appropriations, and Ways and Means.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT FURTHER STRENGTHENING THE OFFICE OF THE SOLICITOR GENERAL (OSG) BY INCREASING ITS POWERS AND FUNCTIONS, AND REDEFINING, EXPANDING, AND RATIONALIZING ITS ORGANIZATION, REPEALING FOR THE PURPOSE REPUBLIC ACT NO. 9417, REPUBLIC ACT NO. 2327, AND EXECUTIVE ORDER NOS. 1 AND 2, S. 1986, AND APPROPRIATING FUNDS THEREFOR.”

Representative Mercado stated that the parliamentary status was that the Bill was in the period of sponsorship and debate; and upon his motion, the Chair recognized Rep. Vicente “Ching” S.E. Veloso, Vice Chairperson of the Committee on Justice, to sponsor the measure, and Representative Zarate to interpellate thereon.

INTERPELLATION OF REPRESENTATIVE ZARATE

To the queries of Representative Zarate, Representative Veloso affirmed that the purpose of House Bill No. 7376 is to rightsize the bureaucracy and abolish the Presidential Commission on Good Government (PCGG) and the Office of the Government Corporate Counsel (OGCC).

The Sponsor also explained the Bill’s provision on retirement and separation pay for employees who will be affected by the streamlining and cited the savings that the government will incur from the same.

Thereupon, Representatives Zarate and Veloso discussed whether the proposed measure was an attack on job security and does not give an assurance that the employees concerned will be absorbed or rehired by the Office of the Solicitor General (OSG). They debated on whether the Bill strengthens or weakens the OSG and puts aside the laws that created the charters of the PCGG and OGCC.

Next, the two Members discussed the advantages and disadvantages of consolidating the two agencies into the OSG in terms of functions, capabilities, and funding. Representative Zarate explained the conflict of interest in cases where the OSG and OGCC are opposing counsels and concluded that the OSG might just perform a transactional function. Representative Veloso pointed out that conflicts can be settled amicably under the proposed set-up; the guiding argument among the agencies is what is legal and correct; and the OSG and the OGCC champion the interest of only one client and that is the Republic of the Philippines.

Furthermore, they compared the operating costs and personnel complement of retaining the three agencies as against merging them into one office.

At this juncture, Deputy Speaker Castro (F. H.) relinquished the Chair to Rep. Arthur R. Defensor Jr.

Representative Zarate subsequently stressed that the abolition of the PCGG and its demotion into a mere task force clearly attacks the reason behind its creation which is the recovery of the alleged ill-gotten wealth of former President Ferdinand E. Marcos and his family and cronies.

At this point, Representative Defensor relinquished the Chair to Deputy Speaker Castro (F. H.).

REMINDER FROM THE CHAIR

At this point, the Chair reminded Representative Zarate that his time had expired.

INTERPELLATION OF REPRESENTATIVE ZARATE (Continuation)

In ending his interpellation, Representative Zarate reiterated that the Bill does not strengthen the OSG; attacks job security; results in more government spending; and is part of the Duterte Administration’s plan to re-empower the Marcoses and their cronies.

On motion of Representative Garin (R.), the Chair recognized Rep. France L. Castro for her interpellation.

INTERPELLATION OF REPRESENTATIVE CASTRO (F.L.)

To Representative Castro’s queries, Representative Veloso first reiterated that the OSG could be strengthened and streamlined by abolishing the PCGG and OGCC and transferring their powers to the OSG.

The two Members thereafter discussed the advantages of merger in terms of handling cases, resolution of cases involving government corporations, sequestration powers, and recovery of ill-gotten wealth allegedly amassed by former President Marcos. Representative Castro pointed out that it would be impossible for a super body like the OSG to perform all of these functions. Representative Veloso explained that the instant Bill provides for a structural reorganization in the sense that there will be no duplicate tasking and there will be savings.

To the subsequent concerns of Representative Castro, the Sponsor explained that nothing is more supreme than the law; and that no agreement can be entered into that is contrary to law, morals, and public policy that the OSG cannot represent the interest of two conflicting agencies in a litigation. The two Members thereafter analyzed the OSG's pending cases that involved government-owned and -controlled corporations (GOCCs).

They also discussed how the OSG would handle more efficiently the cases before the PCGG; the transfer of the PCGG's sequestration powers to the OSG; the strengthening of the PCGG instead of putting it under the OSG; the salaries, separation pay, and retirement benefits of the affected employees; and the disparity in the salaries of the affected ordinary employees as compared to those in higher positions.

Thereafter, Representative Castro expressed belief that the PCGG and OGCC should not be placed under the OSG and that the government should strengthen the OSG by giving more incentives to its employees and making the salary standardization program more effective.

MANIFESTATION OF REPRESENTATIVE ELAGO

Recognized by the Chair on motion of Representative Garin (R.), Rep. Sarah Jane I. Elago manifested that the concerns and issues she would like to raise were already addressed by the previous interpellators.

TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE

There being no other interpellations, on motion of Representative Mercado, there being no objection, the Body terminated the period of sponsorship and debate.

TERMINATION OF THE PERIOD OF AMENDMENTS

There being no Committee or individual amendments, on motion of Representative Mercado, there being no objection, the Body terminated the period of amendments.

MOTION OF REPRESENTATIVE MERCADO

Representative Mercado thereupon moved for the approval on Second Reading of House Bill No. 7376.

MANIFESTATION OF REPRESENTATIVE TINIO

Whereupon, Rep. Antonio L. Tinio sought the Chair's recognition.

SUSPENSION OF SESSION

On motion of Representative Mercado, the session was suspended at 8:55 p.m.
