**REMARKS OF  
MAJORITY LEADER FARIÑAS**

Recognized by the Chair, Majority Leader Rodolfo C. Fariñas, as Chairperson of the *Ad-hoc* Committee and the House of Representatives Familiarization and Inspection Trips, informed the Body of Speaker Pantaleon D. Alvarez' project of bringing the Members all over the country to be familiarized firsthand on the actual conditions of the roads and highways. He said that this will help them report on the actual needs of their constituencies when the Executive submits its National Expenditure Program in July or August 2018.

Majority Leader Fariñas then reported that the first trip occurred in March 2017 starting from Manila and going to Davao through the West Nautical Highway and back to Manila using the Eastern Nautical Highway. He said that the second trip occurred in June 2017 for the Northern and Central Luzon Familiarization and Inspection Trip (NCLFIT) covering the provinces of Bulacan, Pangasinan, Tarlac, La Union, Ilocos Sur, Ilocos Norte, Cagayan, Isabela, Kalinga, Ifugao, Nueva Vizcaya, Pangasinan, and Zambales, as well as Baguio City.

At this point, Majority Leader Fariñas presented a video documentary on the NCLFIT's most recent familiarization and inspection trip which was

conducted from March 15-18, 2018. He said that it covered Northwestern Luzon or the provinces of Nueva Ecija, Aurora, Quirino, Nueva Vizcaya, and Tarlac as well as the City of Angeles.

Subsequently, he thanked Speaker Alvarez for providing leadership and vision; his colleagues for joining the caravan; the Members concerned for hosting the NCLFIT when it visited their constituencies; as well as the chairpersons of the House committees concerned, local and national officials, and heads of government agencies for coordinating the caravan and making the necessary preparations.

Thereafter, on motion of Representative Daza as seconded by Representative de Venecia, the session was suspended at 5:21 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 5:24 p.m.

#### **REMARKS OF REPRESENTATIVE DE VENECIA**

Upon resumption of session, Representative de Venecia stated that the parliamentary status was that the Body had just adopted House Resolution No. 1770.

#### **WITHDRAWAL OF**

#### **REPRESENTATIVE DAZA’S MOTION**

Thereupon, Representative Daza withdrew his previous motion, stating that the Majority Leader had informed him that the measure which was previously adopted was just a Resolution.

The Chair noted the manifestation of Representative Daza.

Appropriations, providing a framework for the right to adequate food and providing penalties for violation thereof; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; inserted into the Record the sponsorship speech of Rep. Cheryl P. Deloso-Montalla, Chairperson of the Committee on Human Rights, upon the latter's motion; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting.

**BUSINESS FOR THE DAY:  
COMMITTEE REPORT NO. 608  
ON HOUSE BILL NO. 7180**

On motion of Representative de Venecia, there being no objection, the Body considered on Second Reading House Bill No. 7180 as contained in Committee Report No. 608 and reported out by the Committee on Justice.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT GRANTING PHILIPPINE CITIZENSHIP TO FATHER JULIAN C. MAZANA.”

As copies of the Bill had been distributed to the Members, on motion of Representative de Venecia, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative de Venecia, the Chair recognized Rep. Tobias “Toby” M. Tiangco, one of the main authors of House Bill No. 7180, to sponsor the measure.

**SPONSORSHIP REMARKS OF  
REPRESENTATIVE TIANGCO**

Upon the request of Representative Tiangco, on motion of Representative de Venecia, there being no objection, the Body considered the Explanatory Note of the Bill as the sponsorship speech on the measure.

Thereafter, on motion of Representative de Venecia, the Chair recognized Rep. Edcel C. Lagman for his interpellation.

**INTERPELLATION OF  
REPRESENTATIVE LAGMAN**

Representative Lagman, after first stating that he would not object to the approval of the measure, said that he merely wanted to be consistent with his observation that the Committee on Justice and the House has not adopted policy standards under which foreigners can be granted Filipino citizenship.

Representative Tiangco agreed with his colleague on the need to harmonize existing laws such as Commonwealth Act (C.A.) No. 473 and Republic Act (R.A.) No. 9139 with the guidelines that Congress will formulate. Nevertheless, he explained how Fr. Mazana has complied with C.A. No. 473 and is not covered by R.A. No. 9139.

**REMARKS OF THE CHAIR**

At this point, the Chair informed the Members that he had debated with the chairperson of the Committee on Justice when Fr. Mazana's citizenship was being deliberated at the Committee level, because he believed that Congress could not grant citizenship merely on the basis of an application.

**INTERPELLATION OF  
REPRESENTATIVE LAGMAN  
(Continuation)**

After Representative Tiangco confirmed the statement of the Chair, Representative Lagman thanked the latter for joining the call for policy directions and standards on the grant of Filipino citizenship.

**BUSINESS FOR THE DAY:

ON HOUSE BILL NO. 7387**

On motion of Representative de Venecia, there being no objection, the Body considered on Second Reading House Bill No. 7387 as contained in Committee Report No. 665 and reported out by the Committee on Justice.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT GRANTING PHILIPPINE CITIZENSHIP TO KWOK HING CARLOS YEUNG.”

As copies of the Bill had been distributed to the Members, on motion of Representative de Venecia, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

On motion of Representative de Venecia, the Chair recognized Deputy Speaker Gwendolyn F. Garcia for her sponsorship speech.

**SPONSORSHIP SPEECH OF  
DEPUTY SPEAKER GARCIA (G.)**

Deputy Speaker Garcia relayed how Mr. Kwok Hing Carlos Yeung worked and lived for 40 years in the country, raised a family with his Cebuana wife, and became a successful businessman. She explained that because of his diverse businesses, he created employment opportunities for thousands of Filipinos and funded several programs and projects to help the poor. She concluded that he deserves to be a Filipino because of his good qualities.

On motion of Representative de Venecia, the Chair recognized Representative Lagman for his interpellation.

**INTERPELLATION OF  
REPRESENTATIVE LAGMAN**

Representative Lagman first reiterated that he had no intention of derailing measures on citizenship, but that he would like to be consistent with the need for the Committee on Justice and the House to adopt policy guidelines and standards in the grant of Filipino citizenship. He thereafter inquired whether the Committee had acted accordingly, pursuant to his interpellation on February 21, 2018 on the proposed grant of citizenship to Mr. Phillip Leach.

Despite reading into the records the minimum standards on the legislative grant of Philippine citizenship as stated in the Internal Rules of Procedure of the Committee on Justice, Deputy Speaker Garcia joined Representative Lagman in calling for more stringent standards in accepting foreigners. She said that she was willing to be a coauthor of any measure thereon that Representative Lagman will file.

**REMARKS OF THE CHAIR**

The Chair remarked that there was no need for legislation for an internal rule on the requirements for citizenship applicants. He said that the Committee on Justice's current internal rule thereon, would suffice.

On motion of Representative de Venecia, the Chair next recognized Rep. Raul V. Del Mar for his manifestation.

**MANIFESTATION OF  
REPRESENTATIVE DEL MAR**

Representative Del Mar expressed support for Representative Lagman's proposal for the adoption of policy standards on congressional grants of Philippine citizenship, stated that Mr. Yeung is his constituent and was worthy of such a grant, and requested that he be made a coauthor of the proposed measure.

**ADDITIONAL COAUTHOR  
OF HOUSE BILL NO. 7387**

On motion of Representative de Venecia, and as concurred by Deputy Speaker Garcia (G.), there being no objection, the Body approved to include Representative Del Mar as additional coauthor of House Bill No. 7387.

**TERMINATION OF THE PERIOD  
OF SPONSORSHIP AND DEBATE**

There being no other Member who wished to interpellate the Sponsor, on Representative de Venecia's motion, there being no objection, the Body terminated the period of sponsorship and debate; and thereafter proceeded to the period of amendments.

There being no Committee or individual amendments, on motion of Representative de Venecia, there being no objection, the Body terminated the period of amendments.

There being no Member who wished to interpellate the Sponsor, on successive motions of Representative de Venecia, there being no objection, the Body terminated the period of sponsorship and debate; and thereafter proceeded to the period of amendments.

There being no Committee amendments, on motion of Representative de Venecia, there being no objection, the Body proceeded to consider individual amendments.

#### **AMENDMENT OF REPRESENTATIVE LAGMAN**

As proposed by Representative Lagman and accepted by the Sponsor, there being no objection, the Body approved to include locomotives or trains in the coverage of the Bill, subject to style.

To Representative Lagman’s queries on the distribution of the Special Local Road Support Fund, Representative Romualdo clarified that 75% will be given to the district engineering offices (DEOs) while 25% will remain with the central office of the Department of Public Works and Highways (DPWH). He also welcomed Representative Lagman’s suggestion to include a specific provision in the Bill on the intent to allocate such a percentage to the DPWH central office.

To Representative Lagman’s proposal to amend the fund shares to 85% for the DEOs and 15% for the central office, Representative Romualdo said that he had no problem therewith. Nevertheless, he asked for time to confer with the other Committee members on the matter.

Chair suspended the session at 6:36 p.m.

### **RESUMPTION OF SESSION**

The session resumed at 6:42 p.m.

Upon resumption of session, on motion of Representative de Venecia, the Chair recognized Rep. Celso L. Lobregat, Chairperson of the Committee on Public Works and Highways, to sponsor the measure.

### **INTERPELLATION OF REPRESENTATIVE LAGMAN (Continuation)**

House Bill No. 7422 as contained in Committee Report No. 671 and submitted by the Committee on Higher and Technical Education, mandating the integration of the National Building Code of the Philippines as one of the major subjects in the Bachelor of Science courses in Civil Engineering, Mechanical Engineering, Electrical Engineering, Sanitary Engineering and Architecture, and its inclusion in the licensure examinations for these courses; and
10. House Bill No. 7321 as contained in Committee Report No. 644 and submitted by the Committee on Information and Communications Technology, establishing the “No Call and No Text Registration” System.

#### **REFERRAL OF HOUSE RESOLUTIONS ON INQUIRIES IN AID OF LEGISLATION**

In accordance with the Rules of Procedure Governing Inquiries in Aid of Legislation, on motion of Representative de Venecia, there being no objection, the Body referred the following House Resolutions to the appropriate Committees hereunder indicated:

1. House Resolution No. 1751, on the cause of interruption in the water supply of Maynilad – to the Committee on Government Enterprises and Privatization;
2. House Resolution No. 1752, on the death of Ifugao environmental activist Ricardo Pugong Mayumi and the worsening attacks against indigenous peoples around the country – to the Committee on Indigenous Cultural Communities and Indigenous Peoples;
3. House Resolution No. 1753, on the current policies of the Department of Education in relation to the private loans of teachers and personnel, including the status of its automatic payroll deduction system and the accreditation process for private lending institutions and the implementation of the net take-home pay provision of the General Appropriations Act – to the Committee on Basic Education and Culture;
4. House Resolution No. 1754, on the lack of government intervention on the worsening crop infestation in several parts of Eastern Visayas, and to recommend measures that will address the situation of the affected peasant families – to the Committee on Agriculture and Food;
5. House Resolution No. 1756, on the present state of Bangon Marawi Comprehensive Rehabilitation and Recovery Program as mandated by Administrative Order No. 3, as amended – to the Committee on Public Works and Highways;
6. House Resolution No. 1759, on the non-implementation of the provisions of R.A. No. 4670 or the Magna Carta for Public School Teachers on free compulsory medical examination and treatment and compensation for injuries – to the Committees on Basic Education and Culture, and Higher and Technical Education;
7. House Resolution No. 1760, on the lack of intelligence by the Philippine National Police which led to the siege of Marawi City

– to the Committee on Public Order and Safety; and

8. House Resolution No. 1761, on the possible irregularities in the use of funds by the Department of Social Welfare and Development, particularly in Region X such as but not limited to the Second District of Misamis Occidental, in the implementation of social services programs – to the Committee on Good Government and Public Accountability.

**UNFINISHED BUSINESS:  
COMMITTEE REPORT NO. 621  
ON HOUSE BILL NO. 7233**

On motion of Representative de Venecia, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7233 as contained in Committee Report No. 621 and reported out by the Committee on Information and Communications Technology.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT REQUIRING THE REGISTRATION OF ALL USERS OF SUBSCRIBER IDENTITY MODULE CARDS.”

On motion of Representative de Venecia, the Chair recognized Rep. Victor A. Yap, Chairperson of the sponsoring Committee, to sponsor the measure, and Rep. Sarah Jane I. Elago for her interpellation.

**INTERPELLATION OF  
REPRESENTATIVE ELAGO**

Representative Elago discussed with Representative Yap (V.) the mechanics and guidelines of the proposed registration of subscriber identity module (SIM) cards and its primary purpose to deter crime. The former expressed apprehension that it could give access to sensitive and personal information, be used for surveillance purposes, and result in more nefarious and fraudulent activities. The latter stressed that the Department of Information and Communications Technology (DICT) would provide mechanisms to ensure the safety and integrity of registered SIM cards and that the right to privacy is enshrined in the Constitution.

Thereupon, Representative Elago asked the proponents of the Bill to ensure that the citizen's right to privacy is preserved and protected.

On motion of Representative de Venecia, the Chair next recognized Rep. Carlos Isagani T. Zarate for his interpellation.

#### **INTERPELLATION OF REPRESENTATIVE ZARATE**

To Representative Zarate's questions on the objectives of the Bill, Representative Yap (V.) stated that it would help the State reduce crime. He clarified that the public should first file a complaint about the fraudulent or criminal use of SIM cards before the State can enforce the law; and that the instant Bill had nothing to do with the proposed national identification system.

After exchanging views with the Sponsor about the Bill's safeguards and limitations as regards commercial and roaming subscriptions as well as SIM cards purchased abroad, Representative Zarate expressed his apprehension about the possible breach of information and commission of other crimes upon the implementation of the Bill. He added that with the advent of information technology, Congress should craft measures to protect the right to privacy.

On motion of Representative de Venecia, the Chair subsequently recognized Rep. Ariel "Ka Ayik" B. Casilao for his interpellation.

#### **INTERPELLATION OF REPRESENTATIVE CASILAO**

After saying that he did not see the logic of the Bill because one can buy multiple SIM cards and provide multiple identities and information, Representative Casilao asked if card registration will entail additional costs to consumers. Even as he replied in the negative and pointed out that this safeguard can be included in the implementing rules and regulations of the Bill, Representative Yap (V.) said that he could not promise that the cost of SIM cards themselves will not increase.

Representative Casilao then expressed concern about the right to privacy; protection of information; abandonment by some countries of the card registration system and the use thereof for surveillance activities; and the continuous upgrading of communication devices which will render SIM cards obsolete.

The Sponsor stressed that the DICT and National Telecommunications Commission have the capacity to maintain and protect personal information; and that the former had existing data centers.

#### **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no other Member who wished to interpellate on the Bill, on successive motions of Representative de Venecia, there being no objection, the Body terminated the period of sponsorship and debate; and thereafter proceeded to the period of amendments.

#### **TERMINATION OF THE PERIOD OF AMENDMENTS**

There being no Committee and individual amendments, on motion of Representative de Venecia, there being no objection, the Body terminated the period of amendments.

#### **APPROVAL ON SECOND READING OF HOUSE BILL NO. 7233**

On motion of Representative de Venecia, there being no objection, the Body approved on Second Reading House Bill No. 7233 through *viva voce* voting.

#### **ADDITIONAL REFERENCE OF BUSINESS**

On further motion of Representative de Venecia, there being no objection, the Body proceeded to the Additional Reference of Business.

Upon direction of the Chair, the Secretary General read the following Committee Report which was referred to the Committee on Rules:
