### **PRIVILEGE HOUR**

With leave of the House, on further motion of Rep. Defensor, there being no objection, the Chair declared a Privilege Hour and thereafter recognized Rep. Henry S. Oaminal for his privilege speech.

### **PRIVILEGE SPEECH OF REP. OAMINAL**

After citing the successful holding of the recent Association of Southeast Asian Nations (ASEAN) Inter-Parliamentary Assembly (AIPA) in Manila the previous week, Rep. Oaminal adverted to the holding of the Annual Communication (ANCOM) gathering of Freemasons in Tagaytay City during the same period. He explained that the event brought together Masonic brethren representing more than 400 lodges nationwide in order to listen to various issues and reports and elect their officers for 2017-2018. He lauded and congratulated the three Members of the Seventeenth Congress who stood out in the AIPA and the ANCOM, thus: Speaker Pantaleon D. Alvarez, AIPA President, for his legislative acumen and diplomatic knowledge; Majority Floor Leader Rodolfo C. Fariñas, AIPA Rapporteur, for his extraordinary wit and parliamentary expertise; and Rep. Abraham "Bambol" N. Tolentino, for his election to the position of the Most Worshipful Grand Master of the Grand Lodge of Free and Accepted Masons of the Philippines and for his support for the public school system.

Rep. Oaminal concluded his speech by stressing that Masons, such as himself, will continue promoting understanding, peace, and harmony as evidenced by their significant contributions in securing liberty and freedom in the country.

### **PRIVILEGE SPEECH OF REP. TEVES**

Speaking in Filipino, Rep. Teves said that the Philippine National Police (PNP) was the most important factor in the success of the war against drugs and illegal gambling. He pointed out that illegal numbers games were widespread because they had the backing of some PNP officials and asked why there were corrupt members of the PNP while many of them were serious and sincere. He expressed support for the new small-time lottery (STL) program of the Duterte Administration because it provided jobs and helped fund public health services, but admonished illegal numbers games from which corrupt policemen obtained money. He said that he will file a resolution for an investigation of police and government officials who protected drug syndicates and were involved in illegal gambling so that the social and economic gains of the new STL program will not be put to waste.
