Representative Eriguel initially related the personal life, political career, and public service record of her family which included her husband, former Congressman Eufanio “Franny” C. Eriguel, M.D. and daughter, Agoo Mayor Stephanie Anne Y.

Eriguel. She lamented the fact that despite their overwhelming win during the elections, their political opponents did not stop looking for ways to clip their wings such as filing election protests and quo warranto and civil cases.

Saying that the first attempt to kill her husband in 2016 remained unsolved, she then recounted his murder by unidentified men during a political meeting on May 12, 2018. She lamented the fact that during that time, the city, provincial, and regional officers of the Philippine National Police (PNP) pulled out their security detail despite death threats that her family received. She denounced the senseless, brutal, and cowardly murder of a public servant who had dedicated his life to the people of La Union, and three of his companions.

Stressing that the killing was politically motivated and denying their detractors' allegation that her husband was involved in illegal drugs, Representative Eriguel subsequently asked the House to look into the aforementioned actuations of the PNP. She pointed out that the killing was also an attack on her family and constituents, the Chamber itself, and fellow public servants. She also called on the PNP and the National Bureau of Investigation to fast-track its investigation thereon.

In closing, Representative Eriguel thanked supporters, allies, relatives, friends, and colleagues who supported them and stayed with them during their difficult time, most especially Speaker Pantaleon D. Alvarez and Majority Leader Rodolfo C. Fariñas.

**EXPLANATION OF VOTES**

The following Members explained their votes:

1. Representative Brosas cast a negative vote. She pointed out that with the climate of impunity in committing human rights violations in the country and the lack of proper implementation of other special laws on children, the government should instead pursue the peace negotiations and focus on resolving the root causes of conflict such as poverty, inequality, injustice, and lack of basic services. She maintained that the instant Bill was unnecessary and repressive, and will not assure the protection of children; and then enjoined her colleagues to block its passage.

2. Speaking in Filipino, Representative Zarate said that he opposes the approval of the instant Bill because it a) disregards the realism and root causes of armed conflict in the country; and b) lacks solid evidence on the real condition of children, including human rights violations being committed against them, especially in remote areas of the country. He urged his colleagues to continuously fight for children's rights and remain steadfast in saving them from the ills of malnutrition, lack of education, and poverty.

COMMITTEE REPORT NO. 722  
ON HOUSE BILL NO. 7512**

On successive motions of Representative Gullas, there being no objection, the Body considered on Second Reading House Bill No. 7512, as contained in Committee Report No. 722 and submitted by the Committees on Rural Development, and Appropriations, establishing the Barangay Integrated Development Approach for Nutrition Improvement (BIDANI) of the rural poor as a linkage program for all state universities and colleges (SUCs) and community colleges; dispensed with the reading of the text thereof without prejudice to its insertion into the Record of the House; adopted the Explanatory Notes of House Bills No. 234 and 667 as the sponsorship remarks on the measure, on motion of Rep. Deogracias B. Ramos Jr., Chairperson of the Committee on Rural Development; terminated the period of sponsorship and debate; terminated the period of amendments in the absence of Committee and individual amendments; and approved the same on Second Reading through *viva voce* voting.

**MANIFESTATION OF  
REPRESENTATIVE RAMOS**

Thereupon, Representative Ramos manifested that Reps. Gabriel H. Bordado Jr., Anthony M. Bravo, Ph.D., and Cesar V. Sarmiento be included as coauthors of House Bill No. 7512.

The Chair took note of the same.

**ADDITIONAL COAUTHORS**

On motion of Representative Gullas, there being no objection, the Body approved to include as additional coauthors of House Bills No. 7173, 7449,

7503, 7512, 7548, and 7742 and House Resolution No. 1818 the names of Members contained in the lists to be submitted by the Committee on Rules.

**BUSINESS FOR THE DAY:  
COMMITTEE REPORT NO. 753  
ON HOUSE BILL NO. 7449**

On motion of Representative Gullas, there being no objection, the Body considered on Second Reading House Bill No. 7449 as contained in Committee Report No. 753 and reported out by the Committee on Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT APPROPRIATING THE SUM OF ONE BILLION ONE HUNDRED SIXTY ONE MILLION SEVEN HUNDRED TEN THOUSAND PESOS (P1,161,710,000) AS SUPPLEMENTAL APPROPRIATIONS FOR FY 2018 AND FOR OTHER PURPOSES.”

As copies of the Bill had been distributed to the Members, on motion of Representative Gullas, there being no objection, the Body dispensed with the reading of the text of the measure without prejudice to its insertion into the Record of the House.

Thereafter, on motion of Representative Gullas, the Chair recognized Rep. Karlo Alexei B. Nograles, Chairperson of the sponsoring Committee, to sponsor the measure.

**SPONSORSHIP REMARKS OF  
REPRESENTATIVE NOGRALES (K.A.)**

Stating that House Bill No. 7449 was in consolidation with House Joint Resolutions No. 20 and 21 and House Resolution No. 1724, Representative Nograles moved the Body consider the Explanatory Note of the Bill as the sponsorship speech on the measure. There being no objection, the Body approved the same.

**MANIFESTATION OF  
REPRESENTATIVE LAGMAN**

Upon recognition by the Chair, Rep. Edcel C. Lagman manifested his intent to interpellate on the measure. After Representative Gullas stated that there was a list of interpellators to follow, the former said that he will defer his interpellation as long as he will be included in said list.



On motion of Representative Gullas, the Chair then recognized Rep. Emmi A. De Jesus for her interpellation.

### **INTERPELLATION OF REPRESENTATIVE DE JESUS**

At the outset, Representative De Jesus informed the Body that Gabriela Women's Party-List had created a task force to look into the welfare of Dengvaxia vaccinees and then discussed with Representative Nograles (K.A.) the number and identity of Dengvaxia patients as well as the areas where Dengvaxia vaccinees are prevalent. She subsequently sought more information about the use of the proposed supplemental budget.

Representative Nograles thus discussed the process and mechanism involved in public health management, deployment of nurses, and implementation of the Department of Health's (DOH's) medical assistance program which will cover the costs of Dengvaxia vaccinees' laboratory tests, medicines, and medical supplies. However, Representative De Jesus stressed that more funds should instead be allocated for the prevention of dengue, the dissemination of information among Dengvaxia vaccinees and their families about the government's medical assistance program, and an increase in the number of public hospitals that will cater to the affected vaccinees.

On motion of Representative Gullas, the Chair then recognized Representative Tinio for his interpellation.

### **INTERPELLATION OF REPRESENTATIVE TINIO**

Initially citing the important provisions of Section 2 of the Bill and its funding allocation, Representative Tinio asked whether the funds for the medical assistance program which constitutes the bulk of the supplemental budget will be additional pork barrel or Priority Development Assistance Fund (PDAF) for the Members.

*At this juncture, Deputy Speaker Abu relinquished the Chair to Representative Gullas.*

Representative Nograles replied in the negative and assured Representative Tinio that said funds will be used exclusively to fund the needs of Dengvaxia vaccinees and the DOH program for them, and can be accessed even without the intervention of any Member.

*At this point, Representative Gullas relinquished the Chair to Deputy Speaker Abu.*

The two Members thereafter discussed the mechanics or process for the distribution of the medical assistance program funds to the DOH regional offices and private and public hospitals all over the country, and for the availment of the same by Dengvaxia patients.

On motion of Representative Gullas, the Chair recognized Representative Lagman for his interpellation.

### **INTERPELLATION OF REPRESENTATIVE LAGMAN**

To Representative Lagman's query on the funding source of the supplemental budget, Representative Nograles (K.A.) cited the refund completely paid to the government by Zuellig Pharma, the local distributor of Dengvaxia manufacturer Sanofi Pasteur, covering unused vials of the Dengvaxia vaccine.

Representative Lagman opined that before they could proceed with the deliberation of the instant Bill, the Committee on Appropriations should secure a written certification of availability of funds from the National Treasury and not a testimonial certification as had been given in the hearing of the Committee on Appropriations. He then asked whether such certification from the National Treasury can be obtained the following day.

### **SUSPENSION OF SESSION**

On motion of Representative Gullas, the Chair suspended the session at 7:57 p.m.

### **RESUMPTION OF SESSION**

The session resumed at 8:01 p.m.

### **SUSPENSION OF CONSIDERATION ON SECOND READING OF HOUSE BILL NO. 7449**

On motion of Representative Gullas, there being no objection, the Body suspended consideration on Second Reading of House Bill No. 7449.

### **UNFINISHED BUSINESS: COMMITTEE REPORT NO. 741 ON HOUSE BILL NO. 7742**

On further motion of Representative Gullas, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7742,

as contained in Committee Report No. 741 and reported out by the Committee on Banks and Financial Intermediaries, Ways and Means, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT REINFORCING THE CORPORATE VIABILITY OF THE BANGKO SENTRAL NG PILIPINAS, STRENGTHENING ITS MONETARY AND FINANCIAL STABILITY FUNCTIONS AND ENHANCING ITS REGULATORY POWERS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7653, OTHERWISE KNOWN AS 'THE NEW CENTRAL BANK ACT'.”

Representative Gullas stated that the parliamentary status was that the Bill was in the period of sponsorship and debate and upon his motion, the Chair recognized the Chairperson of the sponsoring Committee, Rep. Ben P. Evardone, and Representative Lagman for sponsorship and interpellation, respectively.

#### **MANIFESTATION OF REPRESENTATIVE LAGMAN**

Representative Lagman stated that in a communication sent to him the previous week, the General Counsel of the Bangko Sentral ng Pilipinas (BSP) had fully addressed his concerns about the bank including the nature of its losses; the amendment to the computation of profits and losses; the exemption from attachments by other creditors of properties collateralized for BSP loans; the non-coverage of injunctive relief against the BSP in the exercise of its quasi-judicial functions from the Regional Trial Courts except the Court of Appeals and the Supreme Court; and the status of the sinking fund under Section 1326 of the BSP Charter.

He concluded that in view thereof, he will not continue with his interpellation.

#### **TERMINATION OF THE PERIOD OF SPONSORSHIP AND DEBATE**

There being no further interpellations, on motion of Representative Gullas, there being no objection, the Body terminated the period of sponsorship and debate on House Bill No. 7742 and thereafter, proceeded to the period of amendments.

#### **TERMINATION OF THE PERIOD OF AMENDMENTS**

There being no Committee and individual amendments, on motion of Representative Gullas, there being no objection, the Body terminated the period of amendments.

#### **APPROVAL ON SECOND READING OF HOUSE BILL NO. 7742**

Thereupon, on motion of Representative Gullas, there being no objection, the Body approved on Second Reading House Bill No. 7742 through *viva voce* voting.

#### **SUSPENSION OF SESSION**

On motion of Representative Gullas, the Chair suspended the session at 8:06 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 8:07 p.m.

#### **SENATE TRANSMITTAL OF HOUSE BILLS**

Upon resumption of session, on motion of Representative Gullas, there being no objection, the Body directed the Secretariat to immediately transmit to the Senate copies of the House Bills that had just been approved on Third Reading.

#### **ADJOURNMENT OF SESSION**

Thereupon, on motion of Representative Gullas, there being no objection, the Chair declared the session adjourned until four o'clock in the afternoon of Tuesday, May 29, 2018.
