On motion of Representative Marcoleta, the Chair recognized Majority Leader Rolando G. Andaya Jr. on a question of privilege.

#### QUESTION OF PRIVILEGE OF MAJORITY LEADER ANDAYA

Explaining why the Majority had voted to recognize Rep. Danilo E. Suarez as Minority Leader the previous session day, so as not to leave an impression they were merely bullying the Members or relying on their sheer number, Majority Leader Andaya stressed that Section 8, Rule II of the House Rules and the accompanying decision of the Supreme Court in *Baguilat vs. Fariñas* did not apply on the issue at hand.

He first said that the aforesaid case contemplated a situation of an initial organizational change in the House, and not a situation of a change in leadership that did not involve the organization of the Chamber.

He next said that what will apply in the current situation are previous practices and traditions of the House which also become part of its Rules. He recalled the replacement of Speaker Manuel B. Villar Jr. by Speaker Arnulfo P. Fuentesbella in 1999 and of Speaker Jose C. de Venecia Jr. by Speaker Prospero C. Nograles in 2008, during which members in the Minority remained therein or the Minority Leader retained his position after the change in leadership.

Thereafter, Majority Leader Andaya said that he just wanted to make his question of privilege as part of the records and would not entertain interpellations to save time.

#### MANIFESTATION OF REPRESENTATIVE TINIO

At this point, Rep. Antonio L. Tinio manifested his desire to rise on a question of privilege.

#### ACKNOWLEDGMENT OF GUESTS

With the permission of the Chair, Representative Marcoleta acknowledged the guests of Reps. Strike B. Revilla and Jose Christopher Y. Belmonte.

#### QUERY OF REPRESENTATIVE MARCOLETA

Recognized by the Chair, Representative Marcoleta then asked on the nature of the question of privilege of Representative Tinio. When the latter said that he wanted to make a statement on the proper interpretation of the House Rules on membership in the Majority and Minority, the former

said that such was not a proper subject of a question of privilege and advised his colleague to instead raise a point of order.

#### **REMARKS OF REPRESENTATIVE TINIO**

Representative Tinio remarked that his topic concerns a matter of personal and collective privilege and the Rules of the House do not make such limitation on the rights of the Members to speak. He said he did not wish to raise a point of order.

#### **RULING OF THE CHAIR**

The Chair sustained the position of Representative Marcoleta.

#### **SUSPENSION OF SESSION**

On motion of Representative Marcoleta, the Chair declared a recess at 3:54 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 3:57 p.m.

#### **REMARKS OF REPRESENTATIVE MARCOLETA**

Upon recognition by the Chair, Representative Marcoleta explained that the interpretation of the Rules was not in order because the House had already voted thereon and it had been rendered moot and academic.

#### **RULING OF THE CHAIR**

The Chair sustained Representative Marcoleta's position anew.

#### **MOTION OF REPRESENTATIVE MARCOLETA**

Recognized by the Chair, Representative Marcoleta moved that the Body resume the consideration of House Bill No. 7773 contained in Committee Report No. 752.

#### **MANIFESTATION OF REPRESENTATIVE TINIO**

Stressing that the Members' right to speak should not be curtailed, Representative Tinio asked to be allowed to deliver his question of privilege or else he will be constrained to move for the adjournment of session.

#### **SUSPENSION OF SESSION**

On motion of Representative Marcoleta, the Chair suspended the session at 3:58 p.m.

#### **RESUMPTION OF SESSION**

The session resumed at 4:00 p.m.

#### **MANIFESTATION OF REPRESENTATIVE TINIO**

Upon recognition by the Chair, Representative Tinio said for the record that he had risen on the basis of the privilege given to him under Section 102 of the amended Provisional Rules of the House which allows any Member to speak on any urgent matter directly and principally affecting the duties, conduct, rights, privileges, dignity, integrity, or reputation of the House or of its Members, individually or collectively.

He noted that the Chair had allowed Majority Leader Andaya to speak on the interpretation of Rule II on the membership, speakership, and the composition of the Majority and the Minority and that according to his interpretation, which the Body voted and approved the previous day, said Rule II applies on the initial organization of Congress.

He however disagreed thereto, pointing out that nowhere in the Rule states that this only applies solely to the initial organization of the House; therefore, the proper interpretation of the said Rule is that it applies to all cases when choosing the Speaker and determining the composition of the Majority and the Minority.

He then said that Majority Leader Andaya and the other Members have been inventing and amending the Rules when they spoke of the limit of the Rules on initially choosing the Speaker.

He pointed out that the said Rule applies in all cases of choosing the Speaker and determining the composition of the new Majority and the new Minority. He explained that there will be a reconstitution of the Majority if there is an election of a new Speaker or the Majority who voted for former Speaker Pantaleon D. Alvarez would be different from the Majority that voted for Speaker Gloria Macapagal-Arroyo. He said that the difference in the number of Members who voted for Speaker Macapagal-Arroyo and former Speaker Alvarez would obviously show that there is therefore a new Majority and a new Minority.

He emphasized that among the 184 Members who supported Speaker Macapagal-Arroyo was Rep. Danilo E. Suarez and so he could no longer be a part of the new Minority and it cannot be said that his decision to vote for Speaker Macapagal-Arroyo will not affect his standing as Minority Leader under former Speaker Alvarez. This as he said that the former Majority and Minority blocs had been dissolved as well as the membership status of former Members including that of Rep. Eugene Michael B.



De Vera who now claims to be the legitimate Minority Leader when the new Speaker was elected.

He expressed belief that it is only in the Philippines that a Minority Leader has been chosen by the Majority because of the crooked, wrong, and unreasonable interpretation of the Rules of the House.

#### **REFERRAL OF THE MANIFESTATION OF REPRESENTATIVE TINIO**

On motion of Representative Marcoleta, there being no objection, the Body referred Representative Tinio's manifestation to the Committee on Rules.

#### **ACKNOWLEDGMENT OF GUESTS**

At this point, Representative Marcoleta acknowledged the presence in the Session Hall of the spouses of Reps. Maximo B. Rodriguez Jr., Benhur L. Salimbangon, Seth Frederick P. Jalosjos, and Raul A. Daza, as well as the mother of Deputy Speaker Mercedes K. Alvarez.

#### **MANIFESTATION OF REPRESENTATIVE ATIENZA**

Upon recognition by the Chair, Rep. Jose L. Atienza Jr. informed the Body that he had been monitoring the meeting among the Metro Manila mayors as presided by the Metro Manila Development Authority (MMDA) and he learned that they were considering passing a measure prohibiting the use of EDSA by motor vehicles with only one occupant. He pointed out that this is limiting the rights of vehicle owners and motorists. He said that he was aware of the traffic problem that hampers the economy because the government had failed to address them effectively and asked whether this was the only solution that the MMDA can think of; and that they should also consider car owners who have no drivers.

After expressing his apprehension that the Metro Manila Council might approve the said measure, he appealed to MMDA General Manager Jojo Garcia and Chairman Danny Lim to conduct an extensive study thereon and come up with a solution that would not jeopardize the rights of ordinary people. He suggested that before they advise motorists to pass through alternative routes, they should clear the side streets of illegal bus terminals and curb corruption on the streets.

He said that he would file a resolution to counter this kind of measure which deprives the use of

motor vehicles by private individuals and then appealed to the Members to support his resolution.

#### **REFERRAL OF THE MANIFESTATION OF REPRESENTATIVE ATIENZA**

On motion of Representative Roa-Puno, there being no objection, the Body referred Representative Atienza's manifestation to the Committee on Rules.

#### **UNFINISHED BUSINESS: COMMITTEE REPORT NO. 752 ON HOUSE BILL NO. 7773**

On motion of Representative Roa-Puno, there being no objection, the Body resumed consideration on Second Reading of House Bill No. 7773 contained in Committee Report No. 752 as reported out by the Committees on Poverty Alleviation, and Appropriations.

Upon direction of the Chair, the Secretary General read the title of the Bill, to wit:

“AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) TO REDUCE POVERTY AND PROMOTE HUMAN CAPITAL DEVELOPMENT AND PROVIDING FUNDS THEREFOR.”

Representative Roa-Puno stated that the parliamentary status was that the Body was in the period of sponsorship and debate; and on her motion, the Chair recognized Rep. Raymond Democrito C. Mendoza, Chairperson of the Committee on Poverty Alleviation, to sponsor the measure and Rep. Arlene D. Brosas for her interpellation.

#### **INTERPELLATION OF REPRESENTATIVE BROSAS**

On Representative Brosas' initial query, Representative Villarín gave the following summary of assessments with regard to the 4Ps since its implementation in 2008: 1) during the first wave of assessment, many beneficiaries were given aid, specifically funds released for education and health; 2) on the second wave of assessment, many mothers availed of prenatal care by having regular checkups in health facilities; 3) children's access to healthcare services improved; and 4) many households invested for the education of their children by sending them to school. He also said labor employment for the agriculture sector decreased because parents of children who took on agricultural jobs opted to enroll them in schools.

As regards the 2015 assessment prepared by the World Bank, Representative Villarín underscored that the report stated that the poor and vulnerable in the Philippines benefit from what is today one of the largest and best targeted social safety net programs in the world. Furthermore, he said that in terms of specifics, the state of social safety nets report pointed out that at present, conditional cash transfer (CCT) programs account globally for 50 percent of beneficiaries in social safety net programs and that the Philippines has been cited as one of the leading implementors of said social safety net program.

On the third wave of assessment, as this is still ongoing, Representative Villarín maintained that there is an increase in data regarding households that have transitioned from extremely poor to near poor. With the inflation rate at present, Representative Villarín said that while the government has given a one-time unconditional cash transfer (UCT) to 4Ps and non-4Ps beneficiaries, this is all the more reason that the 4Ps measure should be institutionalized.

Thereupon, Representative Brosas asked what course of action had been taken as regards the Commission on Audit (COA) reports on its findings that there were unclaimed cash grants, unreleased cash, issues about the Land Bank of the Philippines, and on ghost beneficiaries that became a big issue in the past and hounded the implementation of the 4Ps system, and on the unliquidated amount of ₱7.689 billion as of December 2016 for the period covering 2012 to 2016.

Speaking in Filipino, Representative Villarín opined that the observation made by the COA last December 31, 2017 revealed that there were 1,889,994 accounts unwithdrawn or non-moving. He said that based on COA's new assessment which was validated by the DSWD, it showed that there were 83,196 unwithdrawn or non-moving accounts with balances above ₱500.00 and beyond 181 days. While the remaining 1,806,798 accounts have maintaining balances of less than ₱500.00, he added that in general, an amount is needed to keep the maintaining balance in the accounts of the 4Ps beneficiaries. He explained further that the program uses cash cards distributed by the DSWD and over-the-counter (OTC) withdrawals, and in those areas that are not served by financial institutions or banks, they tapped the services of other financial institutions such as the Philippine Veterans Bank, cooperative banks, and remittance centers to help in the distribution.

Thereupon, both Members discussed who would be the lead agency tasked with the imple-

mentation and monitoring of, and the role of Congress in the proposed 4Ps under the Bill. Representative Brosas raised her concern on the capacity of the DSWD as lead agency because it is not yet finished on its assessment of the third wave of the 4Ps implementation and on other matters that needed immediate action such as the unreleased cash and bank issues; on the security of tenure of about 90 percent of its personnel; and the status of House Resolution No. 464, recommending to the Committee on Poverty Alleviation to defer further consideration of the 4Ps measure and other related bills and to undertake the proposed round table discussions with 4Ps stakeholders. Representative Villarín stated that those personnel presently covered by job orders or MOA arrangements will be regularized if the law will be passed by January 2019; and that the Committee tackled the Resolution but decided not to conduct on-site hearings anymore.

At this point, Representative Brosas suggested that the Sponsor re-examine the expertise of the DSWD in delivering poverty alleviation services. Representative Villarín stated that those who will be contracted-out will help in the Family Development Sessions (FDS) in the regions in accordance with existing COA guidelines on contracting-out or consultancy services.

Representative Brosas thereafter expressed concern on the exact amount funded by the WB and ADB for the 4Ps, as well as the possibility that the fund may be used for political patronage. She stressed that there should be transparency and accountability in the disbursement of the fund. She also noted the government's failure to pursue on-site hearings, and recommended the provision of decent and regular job opportunities instead of cash grants to address the problem of poverty.

Representative Villarín explained that from 2010 to 2019, the program was only partially funded by the WB and ADB, as the bulk of the amount are part of programs included in the national budget, unless specifically covered by the Special Purpose Fund. He also underscored that any release of the money which is part of the General Fund undergoes existing accounting process.

On motion of Representative Roa-Puno, the Chair recognized Rep. Jose L. Atienza Jr. for his interpellation.

#### **INTERPELLATION OF REPRESENTATIVE ATIENZA**

To the queries of Representative Atienza, Representative Villarín explained that the 4Ps' budget for 2018 is ₱89 billion while the 2019 proposed

budget is ₱88 billion. He stressed the need to institutionalize the program to allow regular fund allocation, and program monitoring and phasing; clear parameters in targeting specific class of households; and enable Congress to exercise its oversight power in the implementation thereof.

Representative Atienza however opined that the program should only be temporary to encourage people to aspire for a better life.

Representative Villarín however stressed that the program is an investment that seeks to help those who are really in need of government assistance at some time, as he emphasized the continuous cycle of poverty in some sectors of society.

As he inquired on the intent of the measure to help the poor achieve a better life, Representative Atienza maintained that institutionalizing the program would not benefit them as what they need is temporary assistance. He also asked whether the program has resulted in lower poverty rate; who the targeted beneficiaries under the measure are; the definition of the phrase “poorest of the poor”; and why despite the program, homeless people still abound in Manila. He suggested that the fund intended for the 4Ps should instead be used to provide food, shelter, and medicine to the poor.

In reaction, Representative Villarín pointed to lower poverty incidence rate from 2009 to 2015; defined “extremely poor” as belonging to households who do not meet their daily food and non-food requirements; and explained that the homeless can avail of the Modified CCT Program of the 4Ps.

As he observed the dwindling number of Members in the plenary despite the importance of the measure being discussed, Representative Atienza then moved for the suspension of its deliberation but reserved the right to be given more time to ask questions next time.

#### **MOTION TO APPROVE JOURNAL NO. 8**

At this point, Representative Marcoleta moved for the approval of Journal No. 8 dated August 7, 2018.

The Chair *motu proprio* suspended the session at 5:41 p.m.

At 5:41 p.m., the session resumed.

On motion of Rep. Ron P. Salo, there being no objection, the Body suspended the consideration on Second Reading of House Bill No. 7773.

Whereupon, on Representative Roa-Puno’s motion, the Chair recognized Rep. Ariel “Ka Ayik” B. Casilao for a brief manifestation.

#### **MANIFESTATION OF REPRESENTATIVE CASILAO**

Addressing his manifestation to the Plenary Affairs Bureau or the Committee on Rules, Representative Casilao clarified that his name should no longer be included in the list of coauthors of House Bill No. 7735 because he had already filed his withdrawal of coauthorship on May 17, 2018, and even before his interpellation during the Second Reading deliberation of the measure. He thereby requested that the Chair instruct the appropriate Committee to delete his name, and to reproduce or resubmit another copy of the measure, which the Chair took note of.
