RESOLUTION NO. 21

RESOLUTION CONGRATULATING THE GOLD MEDAL  
AWARDEES OF THE 30<sup>TH</sup> SOUTHEAST ASIAN GAMES  
AND GRANTING ADDITIONAL INCENTIVES FROM  
THE LEADERS AND MEMBERS OF THE HOUSE OF  
REPRESENTATIVES IN THE EIGHTEENTH CONGRESS

WHEREAS, the Philippines is hosting the 30<sup>th</sup> Southeast Asian Games, also known as the SEA Games from November 30 to December 11, 2019;

WHEREAS, the leaders and Members of the House of Representatives in the Eighteenth Congress stand in solidarity with the Team Philippines throughout the competition in their quest to capture the gold medals in their respective sports, and to bring honor and pride to the Filipino people;

WHEREAS, aside from the incentives granted by law, the Philippine Olympic Committee (POC), headed by our colleague, Representative Abraham "Bambol" N. Tolentino, had given additional incentives to Filipino gold medal winners in the 30<sup>th</sup> SEA Games;

WHEREAS, as a concrete manifestation of the commonality of the goal to bring honor and pride to the country, the leaders and Members of the House of Representatives deem it proper to deduct individual pledges from their salaries for January 2020 as additional incentives to Filipino gold medal winners in the 30<sup>th</sup> SEA Games;

WHEREAS, by winning gold medals in their respective sports in the 30<sup>th</sup> SEA Games and for bringing great honor and pride to the Filipino people, it is but fitting to grant these athletes the additional incentives from the POC and the House of Representatives: Now, therefore, be it

*Resolved by the House of Representatives, To congratulate the gold medal awardees during the 30<sup>th</sup> Southeast Asian Games and to grant them additional incentives from the leaders and Members of the House of Representatives in the Eighteenth Congress.*

*Resolved, further, To collect and deduct the individual pledges of the leaders and Members of the House of Representatives in the Eighteenth Congress from their January 2020 salary for the purpose of granting additional incentives to the gold medal awardees.*
