AN ACT CONVERTING THE DULAG SATELLITE CAMPUS OF THE
EASTERN VISAYAS STATE UNIVERSITY (EVSU) LOCATED IN
THE MUNICIPALITY OF DULAG, PROVINCE OF LEYTE, INTO
A REGULAR CAMPUS, AMENDING FOR THE PURPOSE
REPUBLIC ACT NO. 9311, AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. This Act shall be known as the "Eastern Visayas
2 State University-Dulag Campus Act".

3 SEC. 2. The Dulag Satellite Campus of the Eastern Visayas
4 State University (EVSU) located in the Municipality of Dulag,
5 Province of Leyte, is hereby converted into a regular campus to be
6 known as the EVSU-Dulag Campus.

7 SEC. 3. The EVSU-Dulag Campus shall offer short-term
8 technical-vocational education and training (TVET) courses,
9 undergraduate and graduate degree programs, and other related
10 and relevant fields of study within its competency and areas of
11 specialization, as the Board of Regents may deem necessary to carry
12 out its objectives, and respond to meet the human resource
13 development needs of the Province of Leyte and Region VIII.

1 The EVSU-Dulag Campus shall also undertake research,
2 extension services, and production activities in support of the
3 socio-economic development of the province and the region, and
4 provide progressive leadership in these areas.

5 SEC. 4. The governance of the EVSU-Dulag Campus shall be
6 vested exclusively in the Board of Regents of the EVSU, hereinafter
7 referred to as the Board.

8 SEC. 5. The EVSU-Dulag Campus shall be headed by a
9 Campus Administrator who shall render full-time service and who
10 shall be appointed or designated by the Board upon the
11 recommendation of the search committee and the President, subject
12 to the guidelines, qualifications and standards set by the Board.

13 SEC. 6. All assets, real and personal, personnel and records
14 of the EVSU-Dulag Satellite Campus located in the Municipality of
15 Dulag, Province of Leyte, as well as its liabilities or obligations, are
16 hereby transferred to the EVSU. The positions, rights and security
17 of tenure of faculty members and personnel therein employed under
18 existing laws prior to the conversion into a regular campus shall be
19 respected.

20 All parcels of land belonging to the government occupied by
21 the EVSU-Dulag Satellite Campus are hereby transferred to the
22 EVSU, and shall be titled under its name: *Provided*, That should
23 the campus or the University cease to exist or be abolished or
24 should such aforementioned parcels of land be no longer needed by
25 the University, the same shall revert to the local government units
26 concerned.

27 SEC. 7. The amount necessary to carry out the initial
28 implementation of this Act shall be charged against the current

1 year's funding of the EVSU-Dulag Satellite Campus provided by the
2 Municipality of Dulag, Province of Leyte.

3 The Municipality of Dulag shall provide the same assistance
4 until such time that the amount necessary for the continued
5 operation and maintenance of the EVSU-Dulag Satellite Campus
6 shall be included in the annual General Appropriations Act.

7 SEC. 8. If, for any reason, any part or provision of this Act is
8 declared invalid or unconstitutional, the remaining parts or
9 provisions not affected thereby shall remain in full force and effect.

10 SEC. 9. Republic Act No. 9311, which establishes the Eastern
11 Visayas State University, is hereby amended. All other laws,
12 presidential decrees, executive orders, rules and regulations
13 contrary to or inconsistent with the provisions of this Act are hereby
14 repealed or modified accordingly.

15 SEC. 10. This Act shall take effect fifteen (15) days after its
16 publication in the *Official Gazette* or in a newspaper of general
17 circulation.
