
#### EXPLANATORY NOTE

The Department of Education (DepEd) recently included in its strategic goals the “expansion of access and inclusion in basic education.” In line with this thrust, the DepEd institutionalized the Special Education (SPED) Program – a curriculum that caters specifically to learners who are visually or hearing impaired, orthopedically handicapped, have learning disabilities, suffer speech impediments, or are afflicted with autism, ADHD and other similar medical conditions. Students in the SPED program are placed in an educational environment with facilities suited to their abilities and guided by sufficient faculty and staff members trained to educate special learners.

At present, there are only three (3) SPED Centers in the Schools Division of the City of Mati, Davao Oriental. Due to the distance and financial constraints brought about by high transportation costs, personal and safety expenses, and other necessary logistical costs, these centers are inaccessible to special learners residing in the farther areas of the district including barangays Dahican, Dawan, Macangao, La Union, Tibanban and Luzon.

This bill is being filed in response to the petition filed by the residents of Barangay Macangao, Municipality of Lupon for the establishment of a SPED Center within their barangay proper to be called the Macangao Central Elementary School SPED Center.

Support for this bill is earnestly sought.

**AN ACT**  
**ESTABLISHING A SPECIAL EDUCATION SCHOOL IN BARANGAY MACANGAO,**  
**MUNICIPALITY OF LUPON, PROVINCE OF DAVAO ORIENTAL TO BE KNOWN AS**  
**MACANGAO CENTRAL ELEMENTARY SCHOOL SPECIAL EDUCATION CENTER**  
**AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in the Congress assembled:*

1           **SECTION 1.** There is hereby established, under the supervision of the Department of  
2 Education, a special education school in Barangay Macangao, Municipality of Lupon,  
3 Province of Davao Oriental to be known as Macangao Central Elementary School Special  
4 Education (SPED) Center.

5  
6           **SECTION 2.** The Secretary of Education shall immediately include in the  
7 Department's program the operationalization of the Macangao Central Elementary School  
8 SPED Center, the funding of which shall be included in the annual General Appropriations  
9 Act.

10  
11           **SECTION 3.** The Secretary of Education shall formulate the rules and regulations  
12 implementing the provisions of this Act.

13  
14           **SECTION 4.** This Act shall take effect (15) days after its publication in the Official  
15 Gazette or in a newspaper of general circulation.
