RESOLUTION

Primicias-Agabas of the 6th District of Pangasinan, wife of Representative Tyrone D. Agabas;

WHEREAS, he lived his life with simplicity, humility, and genuine concern for other people, and inculcated upon his children the true meaning of public service and utmost love for God and country, which served as his lasting legacy;

WHEREAS, Alex conducted his business with integrity, and was the embodiment of a competent leader who possessed exceptional determination and the fervent desire to improve the lives and promote the progress of his fellow Filipinos;

WHEREAS, he was a compassionate friend, a man of wisdom, and a leading light in his community, and his memory will forever be in the hearts of his family, relatives, friends, and the people whose lives he had touched: Now, therefore, be it
