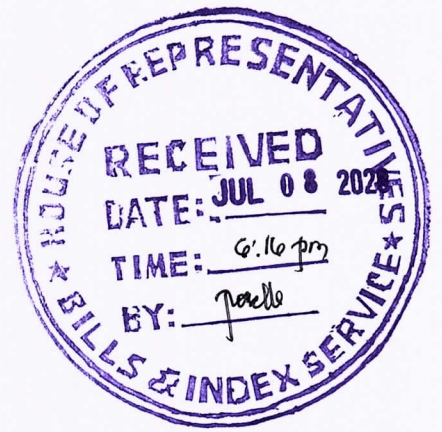

**RESOLUTION**

**FOR THE HOUSE OF REPRESENTATIVES TO CONDEMN THE MURDER OF 15-YEAR OLD ILOCOS SUR NATIVE FABILA PINEDA, TO CALL FOR SWIFT JUSTICE FOR THE VICTIMS AND TO CALL FOR THE IMMEDIATE AND APPROPRIATE FILING OF CHARGES AGAINST THE SUSPECTS.**

**WHEREAS**, 15-year old Ilocos Sur native Fabila Pineda and her 18-year old cousin were arrested for curfew violations by Police Staff Sergeants Randy Ramos and Marawi Torda of the San Juan Police Station in Ilocos Sur;

**WHEREAS**, the said police officers, on the pretext of escorting the girls back to their respective homes, instead allegedly took advantage of the 2 teenagers, to wit: PO3 Marawi Torda committed Acts of Lasciviousness against Pineda and PO3 Randy Ramos raped Pineda's cousin;

**WHEREAS**, Fabila Pineda filed a criminal complaint against Torda for Acts of Lasciviousness and Pineda's cousin accused Ramos of Rape;


**WHEREAS**, after filing the complaint at the Cabugao Police Station, Pineda proceeded home on a motorcycle with relatives but was gunned down by motorcycle-riding gunmen on the night of July 2, 2020;

**WHEREAS**, Ilocos Sur Police Chief Colonel Ronald Tago said they still do not know whether the said two policemen shot the girl dead, but they believe that the two were involved in on the murder in some way;

**WHEREAS**, the suspects are now under restrictive custody at the Ilocos Sur Provincial Office in Bantay town while undergoing investigation.

**NOW THEREFORE, BE IT RESOLVED FOR THE HOUSE OF REPRESENTATIVES, TO CONDEMN THE MURDER OF 15-YEAR OLD ILOCOS SUR NATIVE FABILA PINEDA, TO CALL FOR SWIFT JUSTICE FOR THE VICTIMS AND TO CALL FOR THE IMMEDIATE AND APPROPRIATE FILING OF CHARGES AGAINST THE SUSPECTS.**
