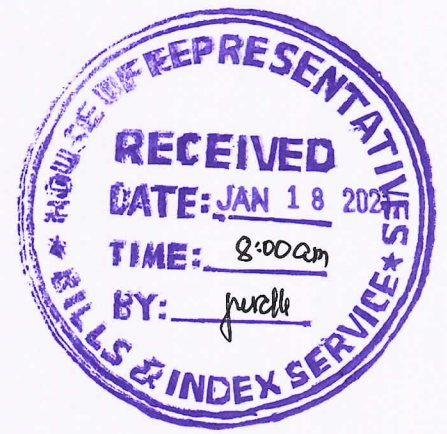

House Resolution No. 1478

**A RESOLUTION EXPRESSING THE PROFOUND SYMPATHIES AND SINCEREST
CONDOLENCES OF THE HOUSE OF REPRESENTATIVES TO THE BEREAVED
FAMILY OF HONORABLE REYNALDO UMALI, FORMER REPRESENTATIVE OF THE
SECOND DISTRICT OF ORIENTAL MINDORO IN THE 15TH, 16TH AND 17TH
CONGRESSES**

WHEREAS, Honorable Reynaldo "Rey" V. Umali passed away on the 7th of January 2021 after having been diagnosed with both COVID-19 and liver cancer a month earlier;

WHEREAS, Hon. Rey Umali was survived by his wife Ma. Linda Tantoco-Umali and six children;

WHEREAS, Atty. Reynaldo V. Umali was an economist, lawyer and a public servant who devoted years in the service of the people;

WHEREAS, Hon. Umali served as the representative of the Second District of Oriental Mindoro served in the 15th, 16th and 17th Congresses and was succeeded by his brother Representative Alfonso Umali Jr. in the 18th Congress;

WHEREAS, prior to his stint as a district representative, he was a seasoned bureaucrat who served as an economist and division chief at the National Economic Development Authority, Director at the Presidential Agrarian Reform from 1990 to 1992, and the Legal Office Chief and later on the Deputy Commissioner at the Bureau of Customs from 2005 to 2010;

WHEREAS, in his tenure as the Customs Deputy Commissioner, he authored the Customs Modernization and Tariff Act which pushed for the full automation of operations of the Bureau of Customs in an effort to eradicate corruption and technical smuggling within the agency;


