AN ACT
ESTABLISHING A NATIONAL JUNIOR HIGH SCHOOL IN BARANGAY
MAGANHAN, BAYBAY CITY, PROVINCE OF LEYTE TO BE KNOWN AS
MAGANHAN JUNIOR HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There is hereby established, under the supervision of the Department of
2 Education, a national junior high school in Barangay Maganhan, Baybay City, Province of
3 Leyte to be known as Maganhan Junior High School.

4
5 SEC. 2. The Secretary of Education shall immediately include in the Department's
6 program the operationalization of the Maganhan Junior High School, the funding of which
7 shall be included in the annual General Appropriations Act.

8
9 SEC. 3. Within one hundred twenty days (120) from the approval of this Act, the
10 Secretary of Education shall formulate the rules and regulations implementing the provisions
11 of this Act.

12
13 SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official
14 Gazette or in a newspaper of general circulation.
