HOUSE BILL NO. **5870**
(In Substitution of House Bill No. 5191)

Introduced by Representative Neptali M. Gonzales II

AN ACT

ESTABLISHING A THREE HUNDRED (300) BED CAPACITY TERTIARY TRAINING AND GENERAL HOSPITAL IN BARANGAY MAUWAY, CITY OF MANDALUYONG TO BE KNOWN AS THE SENATE PRESIDENT NEPTALI A. GONZALES GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established a three hundred (300) bed capacity tertiary
2 training and general hospital to be located in Nueve De Febrero St., Barangay Mauway, City
3 of Mandaluyong, to be known as the Senate President Neptali A. Gonzales General Hospital
4 (SPNGGH) under the direct supervision and control of the Department of Health (DOH).

6 SEC. 2. The DOH shall develop a hospital development plan to reflect the
7 developmental goals of the hospital. Any future increase in bed capacity, and upgrading of
8 healthcare services and facilities shall be based on the hospital development plan.

10 SEC. 3. The Secretary of Health shall immediately include in the Department's
11 program the implementation of this Act, the funding of which shall be included in the annual
12 General Appropriations Act.

14 SEC. 4. Within sixty (60) days from the effectivity of this Act, the DOH shall issue the
15 necessary rules and regulations for its effective implementation.

17 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
18 *Gazette* or in a newspaper of general circulation.
