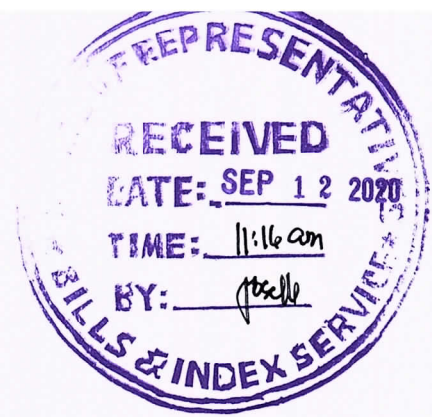

AN ACT
DECLARING NOVEMBER 7 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY IN THE MUNICIPALITY OF CUENCA, PROVINCE OF BATANGAS TO BE KNOWN AS “CUENCA FOUNDATION DAY”, IN COMMEMORATION OF ITS FOUNDATION ANNIVERSARY

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** November 7 of every year is hereby declared a special non-working
2 holiday in the Municipality of Cuenca, Province of Batangas to be known as “*Cuenca*
3 *Foundation Day*”, in commemoration of its foundation anniversary.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
5 *Gazette* or in a newspaper of general circulation.

6 *Approved,*
