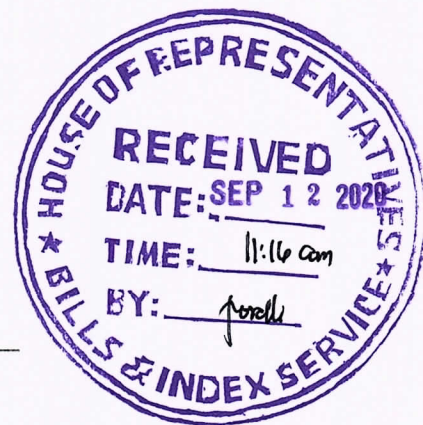

**AN ACT**  
**DECLARING AUGUST 11 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY**  
**IN THE PROVINCE OF SAMAR TO BE KNOWN AS “SAMAR DAY”, IN**  
**COMMEMORATION OF ITS FOUNDATION ANNIVERSARY**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1.** August 11 of every year is hereby declared a special non-working holiday in  
2 the Province of Samar to be known as “*Samar Day*”, in commemoration of its foundation  
3 anniversary.

4           **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
5 *Gazette* or in a newspaper of general circulation.
